- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1702.002, Occupations Code, is amended
- 6 by amending Subdivision (5-c) and adding Subdivision (5-d) to read
- 7 as follows:
- 8 (5-c) "Company representative" means an individual
- 9 who is responsible for a company license holder's compliance with
- 10 this chapter.
- 11 (5-d) "Department" means the Department of Public
- 12 Safety of the State of Texas.
- SECTION 2. Subchapter F, Chapter 1702, Occupations Code, is
- 14 amended by adding Sections 1702.1155 and 1702.126 to read as
- 15 follows:
- Sec. 1702.1155. COMPANY REPRESENTATIVE LICENSE. (a) An
- 17 individual may not act as a company representative for a company
- 18 license holder unless the individual is licensed under this section
- 19 <u>as a company representative.</u>
- 20 (b) An application for a company representative license
- 21 under this section must be in the form prescribed by the department
- 22 and include:
- 23 (1) the full name and business address of the
- 24 applicant; and

1	(2) a statement as to whether the applicant:
2	(A) is additionally applying for or holds a
3	<pre>company license; or</pre>
4	(B) is applying for the company representative
5	license to serve as the company representative for a company
6	license holder that is not the applicant.
7	(c) An applicant is eligible for a company representative
8	license if the applicant has passed the licensing examination under
9	Section 1702.117. The applicant is not required to meet any
10	experience requirement for a company license under this subchapter.
11	Sec. 1702.126. DESIGNATION OF COMPANY REPRESENTATIVE. (a)
12	A company license holder shall:
13	(1) if the company license holder is an individual who
14	also holds a company representative license, designate that
15	individual as the company representative; or
16	(2) if the company license holder does not hold a
17	company representative license, designate a company representative
18	license holder as the company representative.
19	(b) A company representative designated under Subsection
20	(a)(2) is not required to be:
21	(1) an officer who oversees the security-related
22	aspects of the company license holder's business;
23	(2) a partner or shareholder of the company license
24	holder; or
25	(3) an owner of a specified percentage of the company
26	license holder's business.
27	(c) A company representative designated under this section

- 1 is the individual to whom the department may direct all
- 2 correspondence regarding the company license holder.
- 3 SECTION 3. (a) The Public Safety Commission shall adopt
- 4 rules necessary to implement the changes in law made by this Act not
- 5 later than December 1, 2023. A person is not required to obtain a
- 6 license under Section 1702.1155, Occupations Code, as added by this
- 7 Act, to act as a company representative before January 1, 2024.
- 8 (b) Not later than January 1, 2024, a company license holder
- 9 shall designate a company representative in accordance with Section
- 10 1702.126, Occupations Code, as added by this Act.
- 11 SECTION 4. This Act takes effect September 1, 2023.
