- 10 this Act, applies to a member of the State Soil and Water
- 11 Conservation Board appointed before, on, or after the effective
- 12 date of this Act.
- 13 (b) A member of the State Soil and Water Conservation Board
- 14 who, before the effective date of this Act, completed the training
- 15 program required by Section 201.0142, Agriculture Code, as that law
- 16 existed before the effective date of this Act, is only required to
- 17 complete additional training on the subjects added by this Act to
