- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 614.021(b), Government Code, is amended
- 6 to read as follows:
- 7 (b) Except as provided by Section 614.024, this [This]
- 8 subchapter does not apply to a peace officer or fire fighter
- 9 appointed or employed by a political subdivision that is covered by
- 10 a meet and confer or collective bargaining agreement under Chapter
- 11 143 or 174, Local Government Code, if that agreement includes
- 12 provisions relating to the investigation of, and disciplinary
- 13 action resulting from, a complaint against a peace officer or fire
- 14 fighter, as applicable.
- SECTION 2. Section 614.023(a), Government Code, is amended
- 16 to read as follows:
- 17 (a) A copy of a signed complaint against a law enforcement
- 18 officer of this state or a fire fighter, detention officer, county
- 19 jailer, or peace officer appointed or employed by a political
- 20 subdivision of this state shall be given to the officer or employee:
- 21 <u>(1)</u> within a reasonable time after the complaint is
- 22 filed; or
- 23 (2) for a municipal fire fighter, in accordance with
- 24 procedures applicable under Section 614.024.

- 1 SECTION 3. Subchapter B, Chapter 614, Government Code, is
- 2 amended by adding Section 614.024 to read as follows:
- 3 Sec. 614.024. INVESTIGATION OF MUNICIPAL FIRE FIGHTERS
- 4 REQUIRED IN CERTAIN MUNICIPALITIES. (a) In this section:
- 5 (1) "Fire fighter" means a paid employee of a
- 6 municipal fire department.
- 7 (2) "Investigation" means an administrative
- 8 <u>investigation conducted by a municipality of alleged misconduct by</u>
- 9 a fire fighter that could result in punitive action against the fire
- 10 fighter.
- 11 (3) "Punitive action" means a disciplinary
- 12 suspension, indefinite suspension, demotion in rank, reprimand, or
- 13 any combination of those actions.
- (b) This section applies only to a municipality with a
- 15 population of 10,000 or more.
- 16 (c) Notwithstanding Section 614.021(b), this section
- 17 applies to a fire fighter employed by a municipality regardless of
- 18 whether the municipality is covered by a meet and confer or
- 19 collective bargaining agreement under Chapter 143 or 174, Local
- 20 Government Code.
- 21 (d) This section supersedes a conflicting provision in a
- 22 meet and confer or collective bargaining agreement.
- (e) A meet and confer or collective bargaining agreement
- 24 under Chapter 143 or 174, Local Government Code, may impose
- 25 requirements for investigations in addition to those provided in
- 26 Section 143.123 or Sections 143.312(a)-(k), Local Government Code,
- 27 that do not conflict with the requirements of those sections.

- 1 (f) In addition to the requirements of Section 614.023, a
- 2 municipality may not take punitive action against a fire fighter
- 3 unless an investigation has been conducted in accordance with:
- 4 (1) Section 143.123 or Sections 143.312(a)-(k), Local
- 5 Government Code, or other applicable law, including the
- 6 requirements adopted under Subsection (g), if applicable; and
- 7 (2) any additional requirements imposed by a meet and
- 8 confer or collective bargaining agreement under Chapter 143 or 174,
- 9 Local Government Code.
- 10 (g) A municipality to which Section 143.123 or 143.312,
- 11 Local Government Code, or another substantially similar
- 12 investigation requirement does not apply shall adopt and comply
- 13 with:
- 14 (1) procedures substantially identical to those
- 15 required by Sections 143.312(a)-(k), Local Government Code; and
- 16 (2) any additional procedures or requirements imposed
- 17 by a meet and confer or collective bargaining agreement under
- 18 Chapter 143 or 174, Local Government Code.
- 19 SECTION 4. (a) Section 614.024, Government Code, as added
- 20 by this Act, applies only to an investigation, as that term is
- 21 defined by that section, initiated by a municipality on or after the
- 22 effective date of this Act.
- 23 (b) Section 614.024(d), Government Code, as added by this
- 24 Act, applies only to an agreement entered into on or after the
- 25 effective date of this Act.
- 26 SECTION 5. This Act takes effect September 1, 2023.
