## A BILL TO BE ENTITLED

AN ACT

2 relating to powers and duties of navigation districts and the 3 boards of trustees of municipal port facilities.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 60.403(a), Water Code, is amended to 6 read as follows:

7 (a) A port commission, an authorized designated officer of the port commission, the executive director of the district or the 8 9 port authority, or an authorized representative of the executive 10 director may make routine purchases or contracts in an amount not to 11 exceed \$50,000. A port commission may delegate authority to an 12 authorized designated officer of the port commission, the executive director of the district or the port authority, or an authorized 13 14 representative of the executive director to make routine purchases or contracts in an amount not to exceed \$100,000. 15

16 SECTION 2. Section 60.4035(a), Water Code, is amended to 17 read as follows:

(a) Notwithstanding the competitive bidding requirements and proposal procedures of this subchapter and Subchapter O and the requirements of Sections 60.408(a), (b), (c), (d), and (e), the executive director of a district or an officer of a district authorized in writing by the port commission may make emergency purchases or contracts or emergency amendments to existing purchase orders or contracts in an amount that exceeds the amount authorized

Section 60.412(a), Water Code, is amended to read as follows: 23 24 (a) A contract for a purchase is exempt from the competitive 25 bidding requirements and proposal procedures of this subchapter and 26 Subchapter O if a contract is for the purchase of: 27 (1) an item that must be purchased in a case of public

Section 62.106(e), Water Code, is amended to read as follows: 16 17 (e) A district created under this chapter may elect to take advantage of the condemnation procedure provided in Chapter 21, 18 Property Code [Subchapter F of Chapter 51 of this code]. 19 20 SECTION 5. Section 62.120(a), Water Code, is amended to read as follows: 21 A district may enter into operating contracts and leases 22 (a) with cities and other governmental subdivisions for the operation 23 24 of the portions of the district's water system which are designated by the board or the commission. 25 SECTION 6. Section 62.122, Water Code, is amended to read as 26 follows: 27

Sec. 62.122. DISPOSITION OF SALVAGE OR SURPLUS PERSONAL PROPERTY. (a) Except as provided by Subsection (b), the commission <u>or board of trustees under Chapter 54, Transportation Code,</u> may periodically dispose of surplus or salvage personal property in the same manner as the commissioners court of a county under Subchapter D, Chapter 263, Local Government Code.

7 (b) The commission <u>or board of trustees under Chapter 54</u>,
8 <u>Transportation Code</u>, may authorize:

9 (1) the destruction or disposition of salvage or 10 surplus property as worthless if the property is so worn, damaged, or obsolete that it has no value for the purpose for which it was 11 12 originally intended, and the expense to the district to attempt to sell the property would be more than the proceeds from the sale; and 13 14 (2) following any required action by the United States 15 Army Corps of Engineers, the sale of dredge material from a dredge material placement area to any person on such terms and conditions 16 17 as the commission or board of trustees considers appropriate or advantageous to the district. 18

19 SECTION 7. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2023.
