3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 65.013(b), Election Code, is amended to
5	read as follows:
6	(b) The register must state:
7	(1) the total number of ballots received for
8	conducting voting at the polling place;

- 9 (2) the number of defectively printed ballots 10 received;
- 11 (3) the number of ballots provided to voters as
- 13 (4) the number of spoiled ballots returned by voters;

indicated by the number of voters on the poll list;

- 14 [and]
- 15 (5) the number of unused ballots that are not 16 accounted for as defectively printed ballots;
- 17 <u>(6) the range of serial numbers of the ballots</u>
 18 <u>received for conducting voting at the polling place;</u>
- 19 <u>(7) the range of serial numbers of the ballots</u> 20 provided to voters; and
- 21 (8) the serial numbers of the spoiled ballots.
- 22 SECTION 2. Section 65.055(b), Election Code, is amended to 23 read as follows:
- (b) The board shall place the ballot in a separate envelope

- 1 for provisional ballots in the [a] ballot box containing all the
- 2 provisional ballots accepted for voting in the same precinct [the
- 3 election].
- 4 SECTION 3. Sections 65.056(b) and (d), Election Code, are
- 5 amended to read as follows:
- 6 (b) The early voting ballot board shall place the envelopes
- 7 containing rejected provisional ballots in <u>envelopes segregated</u>
- 8 <u>and marked by precinct</u> [an envelope] and shall seal <u>each</u> [the]
- 9 envelope. More than one envelope for each precinct may be used if
- 10 necessary.
- 11 (d) A board member shall deliver the <u>envelopes</u> [<u>envelope</u>]
- 12 containing the rejected provisional ballots to the general
- 13 custodian of election records to be preserved for the period for
- 14 preserving the precinct election records. The <u>envelopes</u> [envelope]
- 15 may not be placed in the box containing the accepted provisional
- 16 ballots or any other election records.
- 17 SECTION 4. Section 66.002, Election Code, is amended to
- 18 read as follows:
- 19 Sec. 66.002. PRECINCT ELECTION RECORDS. In this chapter,
- 20 "precinct election records" means the precinct election returns,
- 21 voted ballots, and other records of an election that are assembled
- 22 and distributed under this chapter, and includes election data, as
- 23 defined by <u>Section 279.001</u>, associated with the precinct.
- SECTION 5. Section 66.0021(b), Election Code, is amended to
- 25 read as follows:
- 26 (b) The general custodian of election records for a primary
- 27 election or the general election for state and county officers

- 1 shall maintain a list that states the total number of votes cast in
- 2 each precinct by personal appearance <u>during the</u> [on] election
- 3 period [day] that is available for public inspection not later than
- 4 the day after election day.
- 5 SECTION 6. Section 66.058, Election Code, is amended by
- 6 amending Subsections (a), (b), (b-1), (c), and (g), and adding
- 7 Subsections (b-2) and (g-1) to read as follows:
- 8 (a) Except as otherwise provided by this code, the precinct
- 9 election records shall be preserved by the authority to whom they
- 10 are distributed for at least 36 [22] months after election day.
- 11 (b) For a period of at least 60 days after the date of the
- 12 election, the voted ballots shall be preserved securely in a locked
- 13 room in the locked ballot box in which they are delivered to the
- 14 general custodian of election records. On the 61st day after
- 15 election day, the general custodian of election records shall
- 16 [may]:
- 17 (1) require a person who has possession of a key that
- 18 operates the lock on a ballot box containing voted ballots to return
- 19 the key to the custodian; [and]
- 20 (2) unlock the ballot box and transfer the voted
- 21 ballots to another secure container, segregated and marked by
- 22 precinct, for the remainder of the preservation period; and
- 23 (3) create and maintain an index of voted ballots and
- 24 ballot numbers assigned to each precinct, categorized by precinct
- 25 <u>location and polling place location, and make the index available</u>
- 26 to the public on the county election Internet website, if the county
- 27 maintains a website.

- 1 (b-1) Except as permitted by this code, a ballot box or
- 2 other secure container containing voted ballots may not be opened
- 3 during the first 60 days of the preservation period.
- 4 (b-2) A secure container that ballots or other precinct
- 5 election records are transferred to under this section must be
- 6 sealed with a uniquely numbered seal, and the number shall be logged
- 7 to ensure chain of custody during the preservation period.
- 8 (c) If during the preservation period an authorized entry is
- 9 made into a ballot box or other secure container containing voted
- 10 ballots, when the purpose for the entry is fulfilled, the box or
- 11 container shall be relocked or resecured and resealed with a
- 12 uniquely numbered, logged seal, and the box and key or secure
- 13 container returned to the custodian.
- 14 (g) Electronic records created under any other provision of
- 15 this code [Chapter 129] shall be preserved in a secure container,
- 16 segregated and marked by precinct.
- 17 (g-1) If ballots are imaged during the election process, the
- 18 general custodian of election records shall post the ballot images,
- 19 including the serial number assigned to the ballot and indexed by
- 20 precinct, on the county's Internet website or the secretary of
- 21 state's Internet website not later than five days after the
- 22 <u>election</u>.
- SECTION 7. Section 66.059(c), Election Code, is amended to
- 24 read as follows:
- 25 (c) Any interested person may observe the opening of the
- 26 box, and the opening of the box must be witnessed by two witnesses
- 27 who shall sign a sworn statement that confirms that the erroneously

- 1 placed election record was removed and where it was placed. The
- 2 sworn statement shall be preserved with the other precinct election
- 3 <u>records</u>.
- 4 SECTION 8. Section 66.060(c), Election Code, is amended to
- 5 read as follows:
- 6 (c) The custodian of the key to ballot box no. 3 shall keep
- 7 the key <u>in a secure</u>, <u>locked place</u> for the period for preserving the
- 8 precinct election records except for the time the key is
- 9 temporarily out of the custodian's custody in accordance with this
- 10 code.
- 11 SECTION 9. Section 66.025(b), Election Code, is repealed.
- 12 SECTION 10. This Act takes effect September 1, 2023.
