4	SECTION 1. Section 701.002, Occupations Code, is amended by
5	amending Subdivision (1-a) and adding Subdivisions (1-b), (1-c),
6	(10), and (11) to read as follows:
7	(1-a) <u>"Certifying entity" means:</u>
8	(A) the Commission on Dietetic Registration; or
9	(B) another entity that has standards equivalent
10	to the standards of the entity described by Paragraph (A), is
11	accredited by the National Commission for Certifying Agencies to
12	issue credentials for the professional practice of dietetics, and
13	is approved by the department.
14	(1-b) "Commission" means the Texas Commission of
15	Licensing and Regulation.
16	(1-c) "Commission on Dietetic Registration" means the
17	commission that is accredited by the National Commission for
18	Certifying Agencies to issue credentials for the professional
19	practice of dietetics.
20	(10) "Registered dietitian" means a person who is
21	credentialed by a certifying entity as a registered dietitian.
22	(11) "Registered dietitian nutritionist" means a
23	person who is credentialed by a certifying entity as a registered
24	dietitian nutritionist.

SECTION 2. Sections 701.251(b) and (c), Occupations Code, are amended to read as follows:

3 (b) Unless the person holds an appropriate license issued4 under this chapter, a person may not:

5 (1) use the title or represent or imply that the person 6 has the title "licensed dietitian" [or "provisional licensed 7 dietitian"] or use the letters "LD" [or "PLD"]; or

8 (2) use a facsimile of <u>that title</u> [those titles] to 9 indicate or imply that the person is a licensed dietitian [or 10 provisional licensed dietitian].

11 (c) Unless the person is a [dietitian] registered dietitian
12 or registered dietitian nutritionist [by the Commission on Dietetic
13 Registration], a person may not, as applicable:

14 (1) use the title or represent or imply that the person 15 has the title "registered dietitian" <u>or "registered dietitian</u> 16 <u>nutritionist"</u> or use the letters "RD" <u>or "RDN"</u>; or

17 (2) use a facsimile of <u>those titles</u> [that title] to 18 indicate or imply that the person is a [dietitian] registered 19 <u>dietitian or registered dietitian nutritionist</u> [by the Commission 20 on Dietetic Registration].

21 SECTION 3. Subchapter F, Chapter 701, Occupations Code, is 22 amended by adding Section 701.2525 to read as follows:

23 <u>Sec. 701.2525. LICENSE QUALIFICATIONS. An applicant for a</u> 24 <u>dietitian license must provide evidence satisfactory to the</u> 25 <u>department that the applicant:</u>

26 <u>(1) is a registered dietitian or registered dietitian</u>

3	(A) possesses at least a master's degree,

21	SECTION 4. Sections 701.2575(a) and (b), Occupations Code,
22	are amended to read as follows:
23	(a) The department shall develop and administer [at least
24	twice each calendar year] a jurisprudence examination to determine
25	an applicant's knowledge of this chapter, commission rules under
26	this chapter, and any other applicable laws of this state affecting
27	the applicant's dietetics practice.

(b) In addition to the [license] examination required by
 Section 701.2525 [701.253], an applicant must pass a jurisprudence
 examination to qualify for a license under this chapter.

4 SECTION 5. Section 701.304, Occupations Code, is amended to 5 read as follows:

6 Sec. 701.304. GROUNDS FOR REFUSING RENEWAL. The commission 7 or department may refuse to renew the license of a person who fails 8 to pay an administrative penalty imposed <u>against the person</u> under 9 Subchapter <u>F, Chapter 51</u> [K], unless enforcement of the penalty is 10 stayed or a court has ordered that the administrative penalty is not 11 owed.

SECTION 6. The following provisions of the Occupations Code are repealed:

SECTION 7. (a) The changes in law made by this Act to Subchapter F, Chapter 701, Occupations Code, apply only to an application for a dietitian license submitted on or after January 1, 2024. An application for a dietitian license submitted before January 1, 2024, is governed by the law in effect immediately before the effective date of this Act, and the former law is continued in effect for that purpose.

1 (b) A person who holds a dietitian license under Chapter 2 701, Occupations Code, on the effective date of this Act may 3 continue to renew that license without complying with Section 4 701.2525, Occupations Code, as added by this Act.

5 Notwithstanding Section 701.2525, Occupations Code, as (c) added by this Act, a person who was credentialed as a registered 6 7 dietitian or registered dietitian nutritionist as defined by Section 701.002, Occupations Code, as amended by this Act, before 8 9 January 1, 2024, and who continues to hold that credential may apply for a dietitian license without complying with Subchapter F, 10 11 Chapter 701, Occupations Code, as amended by this Act. An application for a dietitian license submitted by a person described 12 by this subsection is governed by the law in effect immediately 13 before the effective date of this Act, and the former law is 14 15 continued in effect for that purpose.
