- 22 aids, regardless of whether the transaction occurs in person,

- SECTION 4. Section 401.403(b), Occupations Code, is amended

- 23 (1) comply with rules adopted under this chapter
- 24 related to fitting and dispensing hearing instruments;

- 1 (3) when providing services in this state, use a
- 2 written contract that contains the information prescribed by
- 3 commission rule [the department's name, mailing address, telephone
- 4 number, and Internet website address]; and
- 5 (4) follow the guidelines adopted by commission rule
- 6 for a 30-day trial period on every hearing instrument purchased.
- 7 SECTION 5. Section 402.001, Occupations Code, is amended by
- 8 amending Subdivisions (4), (5), and (7) and adding Subdivisions
- 9 (4-a) and (6-a) to read as follows:
- 10 (4) "Fitting and dispensing hearing instruments"
- 11 means the measurement of human hearing by the use of an audiometer
- 12 or other means to make selections, adaptations, or sales of hearing
- 13 instruments. The term includes prescribing, ordering, or
- 14 <u>authorizing the use of hearing instruments</u>, the making of
- 15 impressions for earmolds to be used as a part of the hearing

- 18 (4-a) "Hearing aid" means any wearable device designed
- 19 for, offered for the purpose of, or represented as aiding persons
- 20 with or compensating for impaired hearing. The term includes
- 21 hearing instruments and over-the-counter hearing aids.
- 22 (5) "Hearing instrument" means <u>a prescription hearing</u>
- 23 aid as that term is defined by 21 C.F.R. Section 800.30 [any
- 24 wearable instrument or device designed for, or represented as,
- 25 aiding, improving, or correcting defective human hearing. The term
- 26 includes the instrument's parts and any attachment, including an
- 27 earmold, or accessory to the instrument. The term does not include

- 1 a battery or cord].
- 2 (6-a) "Over-the-counter hearing aid" has the meaning
- 3 assigned by 21 C.F.R. Section 800.30.
- 4 (7) "Sale" includes a <u>lease</u>, rental, or any other
- 5 purchase or exchange for value [transfer of title or of the right to
- 6 use by lease, bailment, or other contract]. The term does not
- 7 include a sale at wholesale by a manufacturer to a person licensed
- 8 under this chapter or to a distributor for distribution and sale to
- 9 a person licensed under this chapter.
- 10 SECTION 6. Subchapter A, Chapter 402, Occupations Code, is
- 11 amended by adding Section 402.004 to read as follows:
- 12 Sec. 402.004. OVER-THE-COUNTER HEARING AIDS. (a) Except
- 13 as provided by this section, this chapter does not apply to
- 14 servicing, marketing, selling, dispensing, providing customer
- 15 support for, acquiring, or distributing over-the-counter hearing
- 16 aids, regardless of whether the transaction occurs in person,
- online, or through other means.

- Sec. 402.403. WRITTEN CONTRACT. The owner of a hearing

- 2 client receives a written contract at the time of purchase of a
- 3 hearing instrument that contains the information prescribed by
- 4 commission rule[+
- 5 [(1) the signature of the license holder who dispensed
- 6 the hearing instrument;
- 7 [(2) the printed name of the license holder who
- 8 dispensed the hearing instrument;
- 9 [(3) the address of the principal office of the
- 10 license holder who dispensed the hearing instrument;
- 11 [(4) the license number of the license holder who
- 12 dispensed the hearing instrument;
- [(5) a description of the make and model of the hearing
- 14 instrument;
- 15 [(6) the amount charged for the hearing instrument;
- 16 [(7) a statement of whether the hearing instrument is
- 17 new, used, or rebuilt;
- 18 [(8) notice of the 30-day trial period under Section
- 19 402.401; and
- [(9) the name, mailing address, e-mail address, and
- 21 telephone number of the department].
- 22 SECTION 9. Section 401.058(b), Occupations Code, is
- 23 repealed.
- SECTION 10. Not later than December 1, 2023, the Texas
- 25 Commission of Licensing and Regulation shall adopt rules
- 26 prescribing the information required to be included:
- 27 (1) in a contract, as required by Sections 401.403(b),
