5	SECTION 1. Section 1431.002, Government Code, is amended by
6	adding Subsection (d) to read as follows:
7	(d) Except as provided by this subsection, the governing
8	body of an issuer may not authorize an anticipation note to pay a
9	contractual obligation to be incurred if a bond proposition to
10	authorize the issuance of bonds for the same purpose was submitted
11	to the voters during the preceding five years and failed to be
12	approved. The governing body of an issuer may authorize an
13	anticipation note that the governing body is otherwise prohibited
14	from authorizing under this subsection:
15	(1) in a case described by Section 271.056(1), (2), or
16	(3), Local Government Code; and
17	(2) to comply with a state or federal law, rule, or
18	regulation if the issuer has been officially notified of
19	noncompliance with the law, rule, or regulation.
20	SECTION 2. Section 1431.003(b), Government Code, is amended
21	to read as follows:
22	(b) Notwithstanding anything in this chapter to the
23	contrary and except as provided by Section 1431.002(d), the

1 body of an issuer with regard to issuance of obligations under 2 Chapter 1371, except that the prohibition in that chapter on the 3 repayment of an obligation with ad valorem taxes does not apply to 4 an issuer exercising the authority granted by this section.

5 SECTION 3. Section 271.047(d), Local Government Code, is 6 amended to read as follows:

Except as provided by this subsection, the governing 7 (d) 8 body of an issuer may not authorize a certificate to pay a contractual obligation to be incurred if a bond proposition to 9 10 authorize the issuance of bonds for the same purpose was submitted to the voters during the preceding <u>five</u> [three] years and failed to 11 12 be approved. A governing body may authorize a certificate that the governing body is otherwise prohibited from authorizing under this 13 14 subsection:

(1) in a case described by <u>Section 271.056(1), (2), or</u>
(3) [Sections 271.056(1)-(3)]; and

17 (2) to comply with a state or federal law, rule, or 18 regulation if the political subdivision has been officially 19 notified of noncompliance with the law, rule, or regulation.

SECTION 4. The changes in law made by this Act apply only to an anticipation note or certificate of obligation authorized to be issued on or after the effective date of this Act. An anticipation note or certificate of obligation authorized to be issued before the effective date of this Act is governed by the law in effect immediately before the effective date of this Act, and the former law is continued in effect for that purpose.

27 SECTION 5. This Act takes effect September 1, 2023.
