2	relating to the continuation and transfer of the regulation of
3	willed body programs to the Texas Funeral Service Commission, the
4	regulation of willed body programs, non-transplant anatomical
5	donation organizations, and anatomical facilities, and the
6	creation of the State Anatomical Advisory Committee; requiring
7	registration; authorizing fees; authorizing an administrative
8	penalty.
9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
10	ARTICLE 1. STATE ANATOMICAL ADVISORY COMMITTEE; TEXAS FUNERAL
11	SERVICE COMMISSION
12	SECTION 1.01. The heading to Chapter 691, Health and Safety
13	Code, is amended to read as follows:
14	CHAPTER 691. DONATION OF BODIES AND ANATOMICAL SPECIMENS
15	[ANATOMICAL BOARD OF THE STATE OF TEXAS]
16	SECTION 1.02. The heading to Subchapter A, Chapter 691,
17	Health and Safety Code, is amended to read as follows:
18	SUBCHAPTER A. GENERAL PROVISIONS; STATE [ORGANIZATION OF]
19	ANATOMICAL ADVISORY COMMITTEE [BOARD OF THE STATE OF TEXAS]
20	SECTION 1.03. Section 691.001, Health and Safety Code, is
21	amended by amending Subdivision (1) and adding Subdivisions (1-a),
22	(4), (5), and (6) to read as follows:
23	(1) " <u>Advisory committee</u> [Board]" means the <u>State</u>

Anatomical Advisory Committee [Board of the State of Texas].

- 1 (1-a) "Anatomical facility" means a facility in this
- 2 state inspected and approved by the commission under Section
- 3 691.034 that does not operate as a willed body program or a
- 4 non-transplant anatomical donation organization.
- 5 (4) "Commission" means the Texas Funeral Service
- 6 Commission.
- 7 (5) "Non-transplant anatomical donation organization"
- 8 means a person accredited to engage in the recovery, receipt,
- 9 screening, testing, processing, storage, or distribution of tissue
- 10 or human remains for any purpose other than transplantation into a
- 11 <u>living individual in this state.</u>
- 12 (6) "Willed body program" means a program operated at
- 13 an institution of higher education in this state that allows a
- 14 living individual to donate the individual's body or anatomical
- 15 specimen for educational or research purposes.
- SECTION 1.04. Section 691.002, Health and Safety Code, is
- 17 amended to read as follows:
- 18 Sec. 691.002. ADVISORY COMMITTEE [COMPOSITION OF BOARD].
- 19 (a) The State Anatomical Advisory Committee is established to
- 20 advise and provide expertise to the commission on matters related
- 21 to the regulation and operation of willed body programs,
- 22 <u>non-transplant anatomical donation organizations</u>, and anatomical
- 23 facilities in this state.
- 24 (b) The advisory committee is composed of seven members
- 25 appointed by the commission as follows:
- 26 (1) two members who represent institutions of higher
- 27 education that operate willed body programs;

- 1 (2) two members who represent non-transplant
- 2 anatomical donation organizations;
- 3 (3) two members who represent anatomical facilities;
- 4 and
- 5 (4) one public member [The Anatomical Board of the
- 6 State of Texas is composed of one representative from each school or
- 7 college of chiropractic, osteopathy, medicine, or dentistry
- 8 incorporated in this state].
- 9 (c) Members of the advisory committee serve two-year terms
- 10 [(b) On March 1 of each odd-numbered year, the chief executive
- 11 officer of each institution described by Subsection (a) shall
- 12 appoint as the institution's representative on the board one
- 13 professor of surgery or of basic anatomical sciences who is
- 14 associated with the institution].
- 15 (d) An advisory committee member may be reappointed.
- (e) (c) Appointments to the <u>advisory committee</u> [board]
- 17 shall be made without regard to the race, creed, sex, religion, or
- 18 national origin of the appointees.
- (f) Sections 2110.002 and 2110.008, Government Code, do not
- 20 apply to the advisory committee.
- SECTION 1.05. Section 691.007(c), Health and Safety Code,
- 22 is redesignated as Section 691.011, Health and Safety Code, and
- 23 amended to read as follows:
- Sec. 691.011. RECORDS. [(c)] The <u>commission</u> [board] shall
- 25 keep identification records of each body donated to the commission
- 26 [board] and of each body or anatomical specimen distributed by the
- 27 commission [board].

- 1 SECTION 1.06. Section 691.008(a), Health and Safety Code,
- 2 is redesignated as Section 691.012, Health and Safety Code, and
- 3 amended to read as follows:
- 4 Sec. 691.012. FEES. (a) The commission [board] may set and
- 5 collect reasonable and necessary fees for the cost of administering
- 6 this chapter, including:
- 7 <u>(1)</u> receiving and distributing bodies and anatomical
- 8 specimens; and
- 9 (2) conducting inspections of willed body programs and
- 10 anatomical facilities.
- 11 (b) The commission by rule may establish fees for the
- 12 registration of willed body programs and non-transplant anatomical
- 13 donation organizations in amounts reasonable and necessary to cover
- 14 the cost of administering this chapter.
- 15 (c) A non-transplant anatomical donation organization is
- 16 exempt from a fee described by Subsection (a)(1).
- 17 SECTION 1.07. Section 691.010, Health and Safety Code, is
- 18 amended to read as follows:
- 19 Sec. 691.010. PUBLIC INFORMATION AND PARTICIPATION;
- 20 COMPLAINTS. (a) The commission [board] shall prepare information
- 21 of public interest describing the functions of the commission under
- 22 <u>this chapter</u> [board] and the <u>commission's</u> [board's] procedures by
- 23 which complaints are filed with and resolved by the commission
- 24 [board]. The commission [board] shall make the information
- 25 available to the public and appropriate state agencies.
- 26 (b) The commission [board] by rule shall establish methods
- 27 by which service recipients can be notified of the name, mailing

- 1 address, and telephone number of the commission [board] for the
- 2 purpose of directing complaints to the commission [board]. The
- 3 commission [board] may provide for that notification by including
- 4 the information on each written contract relating to bodies willed
- 5 or donated to an entity regulated by the commission [board] or
- 6 authorized by the commission [board] to receive bodies.
- 7 (c) The $\underline{\text{commission}}$ [board] shall keep an information file
- 8 about each complaint filed with the commission [board] relating to
- 9 its functions <u>under this chapter</u>. If a written complaint is filed
- 10 with the commission [board] relating to a person or an entity
- 11 regulated by the $\underline{\text{commission under this chapter}}$ [board], the
- 12 <u>commission</u> [board, at least as frequently as quarterly and until
- 13 final disposition of the complaint, shall periodically notify the
- 14 parties to the complaint of the status of the complaint $\underline{\text{until final}}$
- 15 <u>disposition</u> unless notice would jeopardize an undercover
- 16 investigation.
- 17 (d) The commission [board] shall develop and implement
- 18 policies that provide the public with a reasonable opportunity to
- 19 appear before the commission [board] and to speak on any issue under
- 20 the jurisdiction of the commission [board].
- 21 SECTION 1.08. Section 691.022, Health and Safety Code, is
- 22 amended to read as follows:
- Sec. 691.022. GENERAL DUTIES. (a) The commission [board]
- 24 shall distribute bodies and anatomical specimens to [institutions
- 25 and other] persons authorized to receive a body or specimen under
- 26 this chapter [them]. This subsection does not apply to a body or
- 27 specimen donated to a registered non-transplant anatomical

- 1 donation organization.
- 2 (b) The <u>commission</u> [board] shall adopt rules to ensure that
- 3 each body and anatomical specimen is treated with respect while in
- 4 the custody of the commission [board] or person authorized to
- 5 receive the body or specimen [an institution represented on the
- 6 board is treated with respect].
- 7 (c) The commission shall adopt rules, establish procedures,
- 8 and prescribe forms necessary to administer and enforce this
- 9 chapter, including rules establishing registration and inspection
- 10 requirements and procedures. The commission may issue a reprimand,
- 11 assess an administrative penalty, impose other penalties, or
- 12 revoke, suspend, or probate a registration or other authorization
- 13 for a violation of this chapter or a commission rule adopted under
- 14 this chapter, including a violation related to an inspection
- 15 conducted under Section 691.034, in the manner provided by Chapter
- 16 651, Occupations Code.
- SECTION 1.09. Section 691.0225, Health and Safety Code, is
- 18 amended to read as follows:
- 19 Sec. 691.0225. INFORMATIONAL DOCUMENT. The commission
- 20 [board] shall develop a document to inform a person making a gift of
- 21 a decedent's body or anatomical specimen about the options for
- 22 <u>donation authorized under this chapter</u> [for purposes of education,
- 23 including forensic science education, or research of the risks and
- 24 benefits associated with donation]. The commission [board] shall
- 25 make the document available on the commission's [board's] Internet
- 26 website.
- SECTION 1.10. Section 691.023, Health and Safety Code, is

- 1 amended to read as follows:
- 2 Sec. 691.023. DUTY TO DELIVER CERTAIN BODIES TO COMMISSION
- 3 [BOARD]. (a) An officer, employee, or representative of the state,
- 4 of a political subdivision, or of an institution having charge or
- 5 control of a body not claimed for burial or a body required to be
- 6 buried at public expense shall:
- 7 (1) notify the <u>commission</u> [board] or the <u>commission's</u>
- 8 [board's] representative of the body's existence when the body
- 9 comes into the person's possession, charge, or control if notified
- 10 in writing to do so by the commission [board] or the commission's
- 11 [board's] representative;
- 12 (2) deliver the body in accordance with the direction
- 13 of the commission [board]; and
- 14 (3) allow the commission [board], the commission's
- 15 [board's] representative, or a physician designated by the
- 16 commission [board] who complies with this chapter to remove the
- 17 body to be used for the advancement of medical or forensic science.
- 18 (b) If the commission [board] does not require a political
- 19 subdivision or agency of the political subdivision to deliver a
- 20 body under this section, the political subdivision shall pay all
- 21 costs of preparation for burial, including costs of embalming.
- SECTION 1.11. Section 691.025(c), Health and Safety Code,
- 23 is amended to read as follows:
- 24 (c) A body that is not claimed for burial within 48 hours
- 25 after a relative receives notification shall be delivered as soon
- 26 as possible to the commission [board] or the commission's [board's]
- 27 representative.

- 1 SECTION 1.12. Section 691.026, Health and Safety Code, is
- 2 amended to read as follows:
- 3 Sec. 691.026. BODY OF TRAVELER. If an unclaimed body is the
- 4 body of a traveler who died suddenly, the commission [board] shall
- 5 direct the institution or other person receiving the body to retain
- 6 the body for six months for purposes of identification.
- 7 SECTION 1.13. Section 691.027, Health and Safety Code, is
- 8 amended to read as follows:
- 9 Sec. 691.027. AUTOPSY. Only the commission [board] may
- 10 grant permission to perform an autopsy on an unclaimed body. The
- 11 <u>commission</u> [board] may grant permission after receiving a specific
- 12 request for an autopsy that shows sufficient evidence of medical
- 13 urgency.
- 14 SECTION 1.14. Section 691.028, Health and Safety Code, is
- 15 amended by amending Subsections (a) and (b) and adding Subsection
- 16 (b-1) to read as follows:
- 17 (a) An adult living in this state who is of sound mind may
- 18 donate the adult's body by will or other written instrument to the
- 19 commission [board], a willed body program of a medical or dental
- 20 school, a non-transplant anatomical donation organization, or
- 21 another donee authorized by the commission [board,] to be used for
- 22 the advancement of medical or forensic science.
- 23 (b) To be effective, the donor must provide informed consent
- 24 by signing [sign] the will or other written instrument and it must
- 25 be witnessed by two adults. The donor is not required to use a
- 26 particular form or particular words in making the donation, but the
- 27 will or other instrument must clearly convey:

- 1 (1) the donor's intent; and
- 2 (2) the donor's acknowledgment that the donor was
- 3 informed about:
- 4 (A) the consequences of the donation before
- 5 providing consent;
- 6 (B) the use the donee plans for the donated body
- 7 parts; and
- 8 (C) if applicable, any body part and the
- 9 condition in which the body part will be returned to the person
- 10 designated by the donor.
- 11 (b-1) For purposes of Subsection (b), the donor must be
- 12 informed in writing about the information described by Subsection
- 13 (b)(2) in a clear manner on a single piece of paper that is 8-1/2 by
- 14 11 inches with 14-point type. The commission by rule shall design
- 15 and adopt a form that complies with this subsection that willed body
- 16 programs and non-transplant anatomical donation organizations must
- 17 <u>use.</u>
- 18 SECTION 1.15. Section 691.029, Health and Safety Code, is
- 19 amended to read as follows:
- Sec. 691.029. AUTHORITY TO RECEIVE, DISTRIBUTE, AND
- 21 TRANSFER [ACCEPT] BODIES OR ANATOMICAL SPECIMENS [FROM OUTSIDE THE
- 22 STATE]. The commission [board] may receive, distribute, and
- 23 transfer a body or anatomical specimen from inside or [a body
- 24 transported to the board from outside this state.
- 25 SECTION 1.16. Section 691.030, Health and Safety Code, is
- 26 amended to read as follows:
- Sec. 691.030. COMMISSION'S [BOARD'S] AUTHORITY TO

- 1 DISTRIBUTE BODIES AND ANATOMICAL SPECIMENS. (a) The commission
- 2 [board] or the <u>commission's</u> [board's] representative shall
- 3 distribute bodies donated to it and may redistribute bodies donated
- 4 to medical or dental schools or other donees authorized by the
- 5 commission [board] to:
- 6 (1) willed body programs of schools and colleges of
- 7 chiropractic, osteopathy, medicine, or dentistry incorporated in
- 8 this state;
- 9 (2) forensic science programs;
- 10 (3) search and rescue organizations or recovery teams
- 11 that are recognized by the commission [board], are exempt from
- 12 federal taxation under Section 501(c)(3), Internal Revenue Code of
- 13 1986, and use human remains detection canines with the
- 14 authorization of a local or county law enforcement agency;
- 15 (4) physicians; [and]
- 16 (5) <u>anatomical facilities; and</u>
- 17 (6) other persons as provided by this section.
- 18 (b) In making the distribution, the commission [board]
- 19 shall give priority to the schools and colleges that need bodies for
- 20 lectures and demonstrations.
- 21 (c) If the <u>commission</u> [board] has remaining bodies, the
- 22 $\underline{\text{commission}}$ [board] or the $\underline{\text{commission's}}$ [board's] representative
- 23 shall distribute or redistribute those bodies to the schools and
- 24 colleges proportionately and equitably according to the number of
- 25 students in each school or college receiving instruction or
- 26 demonstration in normal or morbid anatomy and operative surgery.
- 27 The dean of each school or college shall certify that number to the

- 1 commission [board] when required by the commission [board].
- 2 (d) The <u>commission</u> [board] may transport a body or
- 3 anatomical specimen to an authorized recipient in another state if
- 4 the commission [board] determines that the supply of bodies or
- 5 anatomical specimens in this state exceeds the need for bodies or
- 6 anatomical specimens in this state and if:
- 7 (1) the deceased donated the deceased's [his] body in
- 8 compliance with Section 691.028 and at the time of the donation
- 9 authorized the commission [board] to transport the body outside
- 10 this state; or
- 11 (2) the body was donated in compliance with Chapter
- 12 692A and the person authorized to make the donation under Section
- 13 692A.009 authorized the commission [board] to transport the body
- 14 outside this state.
- 15 (e) This section does not apply to a body or anatomical
- 16 specimen donated to a registered non-transplant anatomical
- 17 <u>donation organization</u>.
- 18 SECTION 1.17. Sections 691.031(a), (b), and (f), Health and
- 19 Safety Code, are amended to read as follows:
- 20 (a) The commission [board] shall adopt rules to ensure that:
- 21 (1) each body or anatomical specimen received or
- 22 distributed <u>under this chapter</u> [by the board] is properly
- 23 transported;
- 24 (2) a label with a [the] statement that the container's
- 25 contents are derived from human tissue ["CONTENTS DERIVED FROM
- 26 DONATED HUMAN TISSUE"] is affixed to the container in which the body
- 27 or anatomical specimen is transported; and

- 1 (3) each person who has control or possession of a body
- 2 or anatomical specimen:
- 3 (A) satisfactorily completes the information
- 4 required on a chain-of-custody form prescribed by the commission
- 5 [board];
- 6 (B) maintains a copy of the form for the person's
- 7 records; and
- 8 (C) transfers the form to any other person to
- 9 whom control or possession of the body or anatomical specimen is
- 10 transferred.
- 11 (b) The <u>commission</u> [board] may employ a public carrier to
- 12 transport bodies or anatomical specimens received or distributed by
- 13 the commission [board].
- 14 (f) The sender and receiver of each body or anatomical
- 15 specimen shall file the records required under this section in
- 16 accordance with commission [board] rules so that the commission
- 17 [board] or a district or county attorney may inspect the records at
- 18 any time.
- 19 SECTION 1.18. Section 691.032, Health and Safety Code, is
- 20 amended to read as follows:
- Sec. 691.032. COSTS OF DISTRIBUTION. A person or
- 22 institution receiving a body or anatomical specimen under this
- 23 chapter shall pay in a manner specified by the commission [board],
- 24 or as otherwise agreed on, all costs incurred in distributing the
- 25 body or anatomical specimen so that the state, a county, a
- 26 municipality, or an officer, employee, or representative of the
- 27 state, a county, or a municipality does not incur any expense.

- 1 SECTION 1.19. Sections 691.033(a), (b), and (d), Health and
- 2 Safety Code, are amended to read as follows:
- 3 (a) To further medical or forensic science, a willed body
- 4 program, non-transplant anatomical donation organization,
- 5 anatomical facility, [school, college,] or other person designated
- 6 by the commission [board] may use, dissect, operate on, examine,
- 7 and experiment on a body or anatomical specimen distributed under
- 8 this chapter.
- 9 (b) A <u>willed body program</u>, non-transplant anatomical
- 10 donation organization, [school, college,] or other person shall
- 11 keep a permanent record of each body or anatomical specimen
- 12 received from the commission [board's]
- 13 representative. The record:
- 14 (1) must be sufficient to identify the body or
- 15 anatomical specimen;
- 16 (2) must track the body or anatomical specimen from
- 17 <u>intake to final disposition;</u> and
- 18 (3) may be inspected by the commission [board] or the
- 19 commission's [board's] representative.
- 20 (d) To aid prosecutions under Section 42.08, Penal Code, the
- 21 commission [board] shall adopt rules that clearly state the
- 22 activities that are authorized by the $\underline{\text{commission}}$ [board] in
- 23 relation to the use or dissection of a body.
- SECTION 1.20. Section 691.034, Health and Safety Code, is
- 25 amended to read as follows:
- Sec. 691.034. REGULATION AND REGISTRATION OF PERSONS AND
- 27 INSTITUTIONS USING BODIES AND ANATOMICAL SPECIMENS. (a) A willed

- 1 body program or non-transplant anatomical donation organization
- 2 may not operate in this state unless the program or organization
- 3 registers with the commission in the form and manner prescribed by
- 4 the commission.
- 5 (a-1) To be eligible for registration under this section, a
- 6 non-transplant anatomical donation organization must be accredited
- 7 by the American Association of Tissue Banks under the association's
- 8 Standards for Non-Transplant Anatomical Donation. The commission
- 9 may issue conditional registration to a non-transplant anatomical
- 10 donation organization that is not yet accredited.
- 11 <u>(a-2)</u> The <u>commission</u> [board] shall inspect and may approve
- 12 willed body programs, anatomical facilities, [institutions] and
- 13 other persons for the receipt and use of bodies and anatomical
- 14 specimens under this chapter.
- 15 (a-3) A registered non-transplant anatomical donation
- 16 organization is exempt from an inspection described by Subsection
- 17 (a-2).
- 18 (b) The commission [board] may investigate a willed body
- 19 program, non-transplant anatomical donation organization,
- 20 anatomical facility, or other person [or institution] if the
- 21 commission [board] has reason to believe that the program,
- 22 <u>organization, facility, or</u> person [or institution] has improperly
- 23 used a body or anatomical specimen.
- 24 (b-1) Notwithstanding Subsection (a-3), the commission may
- 25 inspect a non-transplant anatomical donation organization as part
- 26 of an investigation described by Subsection (b).
- 27 (c) The commission [board] may suspend or revoke a willed

- 1 body program's, non-transplant anatomical donation organization's,
- 2 <u>anatomical facility's</u>, or other person's registration or other [or
- 3 institution's authorization to receive and use or dissect bodies
- 4 or anatomical specimens if the commission [board] determines that
- 5 the program, organization, facility, or person [or institution] has
- 6 improperly used a body or anatomical specimen.
- 7 (d) A willed body program, non-transplant anatomical
- 8 donation organization, anatomical facility, or other person [or
- 9 <u>institution</u>] is entitled to a hearing before the commission [board]
- 10 or a hearing examiner appointed by the commission [board] before
- 11 the commission [board] may revoke the program's, organization's,
- 12 <u>facility's, or</u> person's <u>registration or other</u> [or institution's]
- 13 authorization to receive and use or dissect bodies or anatomical
- 14 specimens. The commission [board] shall make all final decisions
- 15 to suspend or revoke an authorization.
- 16 <u>(e) A registered non-transplant anatomical donation</u>
- 17 organization must inform the commission within the time prescribed
- 18 by commission rule if the organization loses its accreditation with
- 19 the American Association of Tissue Banks.
- 20 (f) A commission member or holder of any license issued by
- 21 the commission may not hold an ownership interest in a registered
- 22 non-transplant anatomical donation organization.
- 23 (g) The commission shall adopt rules and procedures
- 24 necessary to administer this section.
- SECTION 1.21. Subchapter A, Chapter 651, Occupations Code,
- 26 is amended by adding Section 651.005 to read as follows:
- Sec. 651.005. REGULATION OF WILLED BODY PROGRAMS,

SECTION 2.02. Section 404.093(b), Government

- 25 (2) funds held in trust or escrow for the benefit of a 26 person or entity other than a state agency;
- 27 (3) funds set apart out of earnings derived from

- 1 investment of funds held in trust for others, as administrative
- 2 expenses of the trustee agency; or
- 3 (4) funds, grants, donations, and proceeds from funds,
- 4 grants, and donations, given in trust to the Texas State Library and
- 5 Archives Commission for the establishment and maintenance of
- 6 regional historical resource depositories and libraries in
- 7 accordance with Section 441.154[+ or
- 8 [(5) funds under the management of the
- 9 secretary-treasurer of the Anatomical Board of the State of Texas,
- 10 as provided by Section 691.008, Health and Safety Code].
- 11 SECTION 2.03. Sections 692A.011(a), (b), and (c), Health
- 12 and Safety Code, are amended to read as follows:
- 13 (a) An anatomical gift may be made to the following persons
- 14 named in the document of gift:
- 15 (1) an organ procurement organization to be used for
- 16 transplantation, therapy, research, or education;
- 17 (2) a hospital to be used for research;
- 18 (3) subject to Subsection (d), an individual
- 19 designated by the person making the anatomical gift if the
- 20 individual is the recipient of the part;
- 21 (4) an eye bank or tissue bank, except that use of a
- 22 gift of a whole body must be coordinated through the Texas Funeral
- 23 Service Commission [Anatomical Board of the State of Texas];
- 24 (5) a forensic science program at:
- 25 (A) a general academic teaching institution as
- 26 defined by Section 61.003, Education Code; or
- 27 (B) a private or independent institution of

- 1 higher education as defined by Section 61.003, Education Code;
- 2 (6) a search and rescue organization or recovery team
- 3 that is recognized by the Texas Funeral Service Commission
- 4 [Anatomical Board of the State of Texas], is exempt from federal
- 5 taxation under Section 501(c)(3), Internal Revenue Code of 1986,
- 6 and uses human remains detection canines with the authorization of
- 7 a local or county law enforcement agency; [or]
- 8 (7) the <u>Texas Funeral Service Commission</u>; or
- 9 (8) a non-transplant anatomical donation organization
 10 [Anatomical Board of the State of Texas].
- 11 (b) Except for donations described by Subsections (a)(1)
- 12 through (6), the <u>Texas Funeral Service Commission or a</u>
- 13 non-transplant anatomical donation organization [Anatomical Board
- 14 of the State of Texas] shall be the donee of gifts of bodies or parts
- 15 of bodies made for the purpose of education or research that are

- 18 (c) A forensic science program that receives a donation
- 19 under Subsection (a)(5) must submit a report to the Texas Funeral

- 26 ARTICLE 3. TRANSITIONS AND EFFECTIVE DATE
- 27 SECTION 3.01. (a) The Anatomical Board of the State of

- 1 Texas is abolished but continues in existence until September 1,
- 2 2024, for the sole purpose of transferring obligations, property,
- 3 rights, powers, and duties to the Texas Funeral Service Commission.
- 4 The Texas Funeral Service Commission assumes all of the
- 5 obligations, property, rights, powers, and duties of the Anatomical
- 6 Board of the State of Texas as they exist immediately before the
- 7 effective date of this Act. All unexpended and unobligated funds
- 8 under the management of the secretary-treasurer of the Anatomical
- 9 Board of the State of Texas, as provided by Section 691.008, Health
- 10 and Safety Code, as that section existed immediately before the
- 11 effective date of this Act, are transferred to the general revenue
- 12 fund for the purpose of the Texas Funeral Service Commission
- 13 administering duties under Chapter 691, Health and Safety Code, as
- 14 amended by this Act.
- 15 (b) The Anatomical Board of the State of Texas and the Texas
- 16 Funeral Service Commission shall, in consultation with appropriate
- 17 state entities, ensure that the transfer of the obligations,
- 18 property, rights, powers, and duties of the Anatomical Board of the
- 19 State of Texas to the Texas Funeral Service Commission is completed
- 20 not later than September 1, 2024.
- 21 (c) All rules of the Anatomical Board of the State of Texas
- 22 are continued in effect as rules of the Texas Funeral Service

- 24 Commission. An authorization issued by the Anatomical Board of the
- 25 State of Texas is continued in effect as provided by the law in

- 2 Act. A complaint, investigation, or other proceeding pending on

- 5 (d) Unless the context indicates otherwise, a reference to
- 6 the Anatomical Board of the State of Texas in a law or
- 7 administrative rule means the Texas Funeral Service Commission.
- 8 (e) The terms of the members of the Anatomical Board of the
- 9 State of Texas expire on September 1, 2024.
- 10 (f) For the state fiscal year ending August 31, 2024, the
- 11 Texas Funeral Service Commission shall quarterly prepare and submit
- 12 to the lieutenant governor, the speaker of the house of
- 13 representatives, the Sunset Advisory Commission, and each standing
- 14 committee of the legislature with primary jurisdiction over the
- 15 Texas Funeral Service Commission a report on the progress of the
- 16 transfer described by Subsection (a) of this section.
- 17 (g) Not later than December 1, 2024, the Texas Funeral
- 18 Service Commission shall submit to the Sunset Advisory Commission

- 21 legislative recommendation necessary to improve the Texas Funeral
- 22 Service Commission's administration of Chapter 691, Health and

- SECTION 3.02. (a) Not later than the 60th day after the
- 25 effective date of this Act, the Texas Funeral Service Commission
- 26 shall appoint members to the State Anatomical Advisory Committee in
- 27 accordance with Section 691.002, Health and Safety Code, as amended

- 2 (b) The members of the Anatomical Board of the State of
- 3 Texas whose terms expire under Section 3.01 of this Act shall
- 4 continue to provide advice to the Texas Funeral Service Commission

- 7 qualified. A member of the Anatomical Board of the State of Texas
- 8 described by this subsection may be appointed to the State
