9	Sec. 786.001. DEFINITIONS. In this chapter:
10	(1) "First responder" means a public safety
11	employee of a state agency or political subdivision of this state
12	whose duties include responding rapidly to an emergency.
13	(2) "Post-traumatic stress disorder" has the
14	meaning assigned by Texas Labor Code, 504.019(2).
15	Sec. 786.002. APPLICABILITY. This chapter applies only to
16	a first responder who is:
17	(1) a peace officer licensed under Chapter 1701,
18	Occupations Code;
19	(2) fire protection personnel as defined by Section
20	419.021, Government Code; or
21	(3) emergency medical services personnel licensed
22	under Chapter 773.

24	provided by Subsection (b), an employer of a first responder may not

suspend, terminate, or take any other adverse employment action, 1 including a demotion in rank or reduction of pay or benefits, 2 against a first responder solely because the employer knows or 3 believes that the first responder has Post-traumatic stress 4 5 disorder. 6 (b) Notwithstanding Subsection (a), an employer of a first 7 responder who knows or believes that the first responder has Post-traumatic stress disorder may take an appropriate adverse 8 9 employment action that is necessary to ensure public safety. 10 Sec. 786.004. CLAIM OR DEFENSE BASED ON ADVERSE EMPLOYMENT 11 ACTION; DAMAGES. (a) A person may assert a violation of this chapter as a claim against an employer, including a governmental entity, in 12 13 a judicial or administrative proceeding or as a defense in a judicial or administrative proceeding. 14 15 (b) An aggrieved person may seek: 16 (1) compensatory damages; 17 (2) reasonable attorney's fees and court costs; and 18 (3) any other appropriate relief. Sec. 786.005. SOVEREIGN IMMUNITY WAIVED. Sovereign immunity 19 20 to suit is waived and abolished to the extent of liability created by this chapter. 21 22 SECTION 2. This applies Act only to a suspension, termination, or other adverse employment action taken by an 23 24 employer against a first responder on or after the effective date of 25 this Act. A suspension, termination, or other adverse employment action that is taken by an employer against a first responder before 26 27 the effective date of this Act is governed by the law in effect on

1 the date the employment action is taken, and the former law is 2 continued in effect for that purpose.

3 SECTION 3. This Act takes effect September 1, 2023.
