- 2 Sec. 130.454. APPROVAL OF ALTERNATIVE HIGH SCHOOL DIPLOMA
- 3 PROGRAM. (a) A public junior college may submit to the
- 4 coordinating board an application to participate in the program.
- 5 The application must propose an alternative competency-based high
- 6 school diploma program to be offered for concurrent enrollment to
- 7 adult students without a high school diploma who are enrolled in a

- 23 financial aid, or subsidies, available to public junior colleges
- 24 and students to encourage and facilitate participation in the
- 25 program.
- 26 (b) A public junior college participating in the program is
- 27 entitled to receive funding under Section 130.003 for the program

- 1 in the manner provided by coordinating board rule.
- Sec. 130.457. REPORT. Not later than December 1, 2026, the
- 3 coordinating board shall submit to the legislature a progress
- 4 report on the effectiveness of the program and any recommendations
- 5 for legislative or other action. This section expires
- 6 <u>September 1, 2027.</u>
- 7 Sec. 130.458. RULES. The coordinating board may adopt
- 8 rules as necessary to implement this subchapter.
- 9 SECTION 2. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2023.
