- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 143.023(c), Local Government Code, is
- 6 repealed.
- 7 SECTION 2. The heading to Section 143.083, Local Government
- 8 Code, is amended to read as follows:
- 9 Sec. 143.083. EMERGENCY APPOINTMENT OF TEMPORARY FIRE
- 10 FIGHTERS [AND POLICE OFFICERS].
- 11 SECTION 3. Section 143.083(a), Local Government Code, is
- 12 amended to read as follows:
- 13 (a) If a municipality is unable to recruit qualified fire
- 14 fighters [or police officers] because of the maximum age limit
- 15 prescribed by Section 143.023 and the municipality's governing body
- 16 finds that this inability creates an emergency, the commission
- 17 shall recommend to the governing body additional rules governing
- 18 the temporary employment of persons who are 36 years of age or
- 19 older.
- 20 SECTION 4. Section 143.084, Local Government Code, is
- 21 amended to read as follows:
- Sec. 143.084. CIVIL SERVICE STATUS AND PENSION BENEFITS FOR
- 23 CERTAIN FIRE FIGHTERS [AND POLICE OFFICERS]. (a) Each fire fighter
- 24 [or police officer] who, since December 31, 1969, has been

- 1 continuously employed as a temporary employee under the provision
- 2 codified as Section 143.083 has the full status of a civil service
- 3 employee with all the rights and privileges granted by Section
- 4 143.005.
- 5 (b) A fire fighter [or police officer] covered by Subsection
- 6 (a) is eligible to participate in earned pension benefits. The
- 7 person may buy back service credits in the pension fund in which the
- 8 permanent fire fighters [or police officers] in the department have
- 9 participated since that person's employment. The credits may be
- 10 bought at a rate determined by the actuary of the affected pension
- 11 fund.
- 12 SECTION 5. Section 143.084, Local Government Code, as
- 13 amended by this Act, does not affect the civil service status or
- 14 eligibility for pension benefits of a police officer to whom that
- 15 section applied immediately before the effective date of this Act.
- 16 The civil service status and eligibility for pension benefits of a
- 17 police officer to whom that section applied is governed by the law
- 18 in effect immediately before the effective date of this Act, and the
- 19 former law is continued in effect for that purpose.
- 20 SECTION 6. This Act takes effect September 1, 2023.
