A BILL TO BE ENTITLED

1	AN ACT
2	relating to a pilot program for the safe disposal of prescription
3	drugs, including controlled substance prescription drugs.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle A, Title 6, Health and Safety Code, is
6	amended by adding Chapter 442A to read as follows:
7	CHAPTER 442A. PRESCRIPTION DRUG SAFE DISPOSAL PILOT PROGRAM
8	SUBCHAPTER A. GENERAL PROVISIONS
9	Sec. 442A.001. DEFINITIONS. In this chapter:
10	(1) "Board" means the Texas State Board of Pharmacy.
11	(2) "Controlled substance" has the meaning assigned by
12	Section 481.002.
13	(3) "Pharmacy" means a facility licensed under Chapter
14	560, Occupations Code.
15	(4) "Pilot program" means the prescription drug safe
16	disposal pilot program established under this chapter.
17	(5) "Prescription drug" has the meaning assigned by
18	Section 551.003, Occupations Code.
19	(6) "Ultimate user" has the meaning assigned by 21
20	U.S.C. Section 802.
21	Sec. 442A.002. PRESCRIPTION DRUG SAFE DISPOSAL PILOT
22	PROGRAM. The board by rule shall develop and implement a
23	prescription drug safe disposal pilot program to increase the
24	number of locations in this state where unused, unwanted, or

- 1 expired prescription drugs are collected from the public for safe
- 2 disposal.
- 3 SUBCHAPTER B. PHARMACY PARTICIPATION
- 4 Sec. 442A.051. PHARMACY ELIGIBILITY. A pharmacy operating
- 5 <u>in this state may apply to the board to participate in the pilot</u>
- 6 program if the pharmacy:
- 7 (1) is registered as an authorized drug collection
- 8 site with the <u>United States Drug Enforcement Administration</u>;
- 9 (2) is not the subject of state or federal opioid
- 10 litigation; and
- 11 (3) meets the eligibility requirements established by
- 12 21 C.F.R. Section 1317.40 and board rules.
- 13 Sec. 442A.052. APPLICATION AND SELECTION PROCESSES. (a)
- 14 The board shall adopt rules prescribing:
- 15 (1) the form and manner for a pharmacy to apply for
- 16 participation in the pilot program; and
- 17 (2) evaluation and selection criteria and processes.
- 18 (b) The board shall give priority to a pharmacy applicant
- 19 that:
- 20 (1) does not collect unused ultimate user prescription
- 21 drugs under 21 C.F.R. Part 1317 at the time the applicant submits
- 22 the application; or
- 23 (2) is located in a rural or underserved area the board
- 24 designates.
- 25 (c) A pharmacy that operates multiple locations must submit
- 26 an application for each location.
- Sec. 442A.053. COLLECTION RECEPTACLE REQUIREMENTS. (a) A

- 1 participating pharmacy that provides a collection receptacle for
- 2 the safe disposal of prescription drugs shall ensure the
- 3 receptacle:
- 4 (1) meets the requirements of 21 C.F.R. Section
- 5 1317.75;
- 6 (2) is accessible during the pharmacy's regular hours
- 7 of operation;
- 8 (3) allows for the anonymous deposit of unused
- 9 controlled substance prescription drugs listed in Schedules II,
- 10 III, IV, and V; and
- 11 (4) provides disposal of unused prescription drugs at
- 12 no cost to the ultimate user.
- 13 (b) Controlled substance prescription drugs and
- 14 noncontrolled substance prescription drugs may be collected
- 15 together and comingled.
- 16 Sec. 442A.054. MAIL-BACK PROGRAM REQUIREMENTS. (a) A
- 17 participating pharmacy that provides a collection receptacle for
- 18 the safe disposal of prescription drugs may, under limited
- 19 circumstances as the pharmacy determines necessary, provide at the
- 20 time the pharmacy dispenses a controlled substance prescription
- 21 drug to the ultimate user a vendor's mail-back envelope, at no cost
- 22 to the ultimate user. The mail-back envelope must:
- 23 (1) be pre-addressed and return postage paid; and
- 24 (2) meet the requirements of 21 C.F.R. Section
- 25 1317.70.
- 26 (b) A participating pharmacy may provide not more than 250
- 27 mail-back envelopes during the duration of the pilot program to

- encourage use of the pharmacy's collection receptacle. 1 2 Sec. 442A.055. PHARMACY MANAGEMENT; RECORDS. 3 participating pharmacy is responsible for the daily management and recordkeeping of the pharmacy's prescription drug safe disposal 4 program in accordance with the pharmacy's United States Drug 5 Enforcement Administration registration and board rules. 6 7 Sec. 442A.056. TEXAS PREMIER PHARMACY DESIGNATION. The board shall designate each pharmacy participating in the pilot 8 9 program as a Texas premier pharmacy provider committed to safe prescription drug disposal. 10 11 (b) A participating pharmacy may use the designation for 12 marketing purposes. 13 SUBCHAPTER C. BOARD DUTIES Sec. 442A.101. PILOT PROGRAM INCENTIVES. (a) The board 14 shall assist each pharmacy participating in the pilot program, 15 including by paying the costs of: 16 17 (1) maintaining one collection receptacle at each participating pharmacy location and destroying through 18 incineration of the receptacle's full inner liner the prescription 19 20 drugs deposited in the receptacle; (2) ordering and distributing pre-addressed, return 21 postage paid mail-back envelopes from a third-party mail-back 22

program and destroying through incineration the returned mail-back

(3) other operational needs the board determines

envelopes containing the collected prescription drugs; and

- 1 (1) shall directly reimburse a participating pharmacy
- 2 for costs the pharmacy incurs under Subsection (a); and
- 3 (2) may not reimburse a participating pharmacy for the
- 4 cost of using a third-party incineration facility unless the
- 5 facility is appropriately registered with the United States Drug
- 6 Enforcement Administration.
- 7 (c) Subject to money available for purposes of this chapter,
- 8 the board may provide financial incentives to a pharmacy to
- 9 continue providing prescription drug collection services or expand
- 10 those services to accommodate controlled substance prescriptions.
- 11 The board may provide financial incentives to a chain retail
- 12 pharmacy for not more than 15 locations.
- Sec. 442A.102. COMMUNITY OUTREACH. (a) The board shall:
- 14 (1) develop and distribute educational outreach
- 15 materials for the public about the availability of safe
- 16 prescription drug disposal in this state;
- 17 (2) post the materials on the board's Internet
- 18 website; and
- 19 (3) provide the materials to other state agencies for
- 20 those agencies to conduct the community outreach.
- 21 (b) The educational outreach materials must be in English,
- 22 Spanish, and for specific areas of this state as the board
- 23 determines appropriate, another language spoken by a substantial
- 24 portion of the area's residents.
- Sec. 442A.103. REPORT. Not later than December 1 of each
- 26 <u>even-numbered year</u>, the board shall submit to the governor and the
- 27 legislature a report that:

1	(1) summarizes the results of the pilot program,
2	including:
3	(A) the number and geographic distribution of
4	collection receptacles at participating pharmacies;
5	(B) the estimated amount of prescription drugs
6	collected by participating pharmacies under the program, measured
7	by:
8	(i) the number of inner liners fully filled
9	with collected prescription drugs and sent for incineration by the
10	pharmacies;
11	(ii) the number of mail-back envelopes
12	distributed by the pharmacies; and
13	(iii) the weight, measured in pounds, of:
14	(a) inner liners described by
15	Subparagraph (i); and
16	(b) returned mail-back envelopes
17	filled with collected prescription drugs;
18	(C) the amount of money distributed under the
19	pilot program and the identity of each participating pharmacy to
20	which money is distributed; and
21	(D) a description of the board's educational
22	efforts and outcomes; and
23	(2) recommends whether the pilot program should
24	continue, be expanded, or terminate or whether the board should
25	permanently implement a prescription drug safe disposal program.
26	SUBCHAPTER D. FUNDING
27	Sec. 442A.151. FUNDING. (a) Money contained in the opioid

- 1 abatement account established under Section 403.505, Government
- 2 Code, as added by Chapter 781 (S.B. 1827), Acts of the 87th
- 3 Legislature, Regular Session, 2021, may be appropriated to the
- 4 board to fund the pilot program established under this chapter.
- 5 (b) The board may collect gifts, grants, and donations to
- 6 fund the program.

SUBCHAPTER E. EXPIRATION

- 8 Sec. 442A.201. EXPIRATION. This chapter expires on the
- 9 second anniversary of the date that all money appropriated for the
- 10 pilot program has been expended.
- 11 SECTION 2. As soon as practicable after the effective date
- 12 of this Act, the Texas State Board of Pharmacy shall implement the
- 13 prescription drug safe disposal pilot program developed under
- 14 Chapter 442A, Health and Safety Code, as added by this Act.
- 15 SECTION 3. This Act takes effect September 1, 2023.
