- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1023.002(c), Estates Code, is amended to
- 6 read as follows:
- 7 (c) If it appears to the court at any time before the
- 8 guardianship is closed that the proceeding was commenced in a court
- 9 that did not have venue over the proceeding, the court shall, on the
- 10 application of any interested person, transfer the proceeding to
- 11 the proper county in the manner prescribed by Section 1023.006.
- SECTION 2. Sections 1023.004(a) and (c), Estates Code, are
- 13 amended to read as follows:
- 14 (a) On filing an application or on motion of a court to
- 15 transfer a guardianship to another county under Section 1023.002 or
- 16 1023.003, the sureties on the bond of the guardian shall be cited by
- 17 <u>certified mail, return receipt requested, [personal service</u>] to
- 18 appear and show cause why the guardianship should not be
- 19 transferred.
- (c) If a court made a motion to transfer a guardianship, the
- 21 guardian shall be given notice by certified mail, return receipt
- 22 <u>requested,</u> to appear and show cause why the guardianship should not
- 23 be transferred.
- SECTION 3. Section 1023.005(c), Estates Code, is amended to

- 1 read as follows:
- 2 (c) On receipt of an order described by Subsection (a), the
- 3 clerk of the court to which the quardianship is transferred
- 4 [county] shall accept the transfer of the quardianship.
- 5 SECTION 4. Section 1023.006, Estates Code, is amended to
- 6 read as follows:
- 7 Sec. 1023.006. TRANSFER OF RECORD. (a) When an order of
- 8 transfer is made under Section 1023.002 or 1023.005, the clerk of
- 9 the court transferring a proceeding shall, using the electronic
- 10 filing system established under Section 72.031, Government Code,
- 11 send to the proper court in the county to which the transfer is
- 12 made:
- 13 (1) a transfer certificate and certified index of
- 14 transferred documents;
- 15 (2) a copy of each order, including a copy of the order
- of transfer signed by the transferring court;
- 17 (3) a copy of the original papers filed in the
- 18 transferring court, including any papers previously received on
- 19 transfer from a court in another county;
- 20 (4) a copy of the transfer certificate and certified
- 21 index of transferred documents from each previous transfer, if
- 22 applicable; and
- 23 <u>(5) a bill of any costs that have accrued in the</u>
- 24 transferring court.
- 25 (b) The clerk of the transferring court shall use the
- 26 standardized transfer certificate and index of transferred
- 27 documents form created by the Office of Court Administration of the

- 1 Texas Judicial System under Section 72.037, Government Code, when
- 2 transferring a proceeding under this section.
- 3 (c) The clerk of the transferring court shall keep a copy of
- 4 transferred pleadings, orders, and all other papers filed into the
- 5 case record.
- 6 (d) The clerk of the transferee court shall, subject to
- 7 <u>Section 1023.005</u>, accept the documents transferred under
- 8 Subsection (a) and docket the case.
- 9 (e) The clerk of the transferee court shall physically or
- 10 <u>electronically mark or stamp the transfer certificate and index of</u>
- 11 transferred documents to evidence the date and time of acceptance
- 12 under Subsection (c) but may not physically or electronically mark
- 13 or stamp any other document transferred under Subsection (a).
- 14 (f) Sections 80.001 and 80.002, Government Code, do not
- 15 apply to the transfer of documents under this section [shall record
- 16 any unrecorded papers of the guardianship required to be
- 17 recorded. On payment of the clerk's fee, the clerk shall transmit
- 18 in electronic or paper form to the county clerk of the county to
- 19 which the quardianship was ordered transferred:
- 20 [(1) the case file of the guardianship proceedings;
- 21 and
- 22 [(2) a certified copy of the index of the quardianship
- 23 records].
- SECTION 5. Section 1023.007, Estates Code, is amended to

- Sec. 1023.007. TRANSFER EFFECTIVE. The order transferring
- 27 a quardianship does not take effect until:

- 1 (1) the case file and a certified copy of the index
- 2 required by Section 1023.006 are filed in electronic or paper form
- 3 in the office of the county clerk of the county to which the
- 4 quardianship was ordered transferred; and
- 5 (2) a certificate under the court's [clerk's] official
- 6 seal and reporting the filing of the case file and a certified copy
- 7 of the index is filed using the electronic filing system
- 8 <u>established under Section 72.031, Government Code,</u> [in electronic
- 9 or paper form] in the court ordering the transfer by the county
- 10 clerk of the county to which the guardianship was ordered
- 11 transferred.
- 12 SECTION 6. Chapter 1023, Estates Code, is amended by adding
- 13 Section 1023.0071 to read as follows:
- 14 Sec. 1023.0071. TRANSFER FEE. (a) The fee for filing a
- 15 guardianship case transferred from another county under this
- 16 chapter in which the guardian has previously been appointed and
- 17 qualified in accordance with this title is \$45 payable to the clerk
- 18 of the court to which the case is transferred. No portion of this
- 19 fee may be sent to the state.
- 20 (b) A party may not be assessed any other filing fee by the
- 21 <u>clerk of the court to which the guardianship is transferred in</u>
- 22 connection with the filing and docketing of the transferred case.
- 23 <u>(c) To the extent that this section conflicts with another</u>
- 24 state statute, the Texas Rules of Civil Procedure, or other rules,
- 25 this section prevails.
- SECTION 7. Subchapter I, Chapter 1104, Estates Code, is
- 27 amended by adding Section 1104.4015 to read as follows:

- 13 Sec. 1104.405. INFORMATION FOR EXCLUSIVE USE OF
- 14 COURT. (a) Criminal history record information [obtained or]
- 15 provided to the court as specified under Section 1104.4015
- 16 [1104.402, 1104.403, or 1104.404] is privileged and confidential
- 17 and is for the exclusive use of the court. The criminal history
- 18 record information may not be released or otherwise disclosed to
- 19 any person or agency except on court order or consent of the person
- 20 being investigated.
- 21 (b) The county clerk shall [may] destroy the criminal
- 22 history record information after the information is used for the
- 23 purposes authorized by this subchapter.
- SECTION 9. Section 1104.408(a), Estates Code, is amended to
- 25 read as follows:
- 26 (a) Criminal history record information obtained under
- 27 Section 1104.407 is privileged and confidential and is for the

- 10 (d) Copies of the notices mailed under Subsection (c) must
- 11 be filed with the court with a copy of the certified mail return
- 12 receipt for each notice mailed.

- 3 SECTION 20. Section 1204.152, Estates Code, is amended to
- 4 read as follows:
- 5 Sec. 1204.152. DISCHARGE OF GUARDIAN WHEN ESTATE FULLY
- 6 ADMINISTERED. The court shall enter an order discharging a
- 7 guardian of the estate from the guardian's trust, canceling the
- 8 letters issued to the guardian of the estate, and declaring the
- 9 estate closed when:
- 10 (1) the guardian has fully administered the estate in
- 11 accordance with this title and the court's orders;
- 12 (2) the guardian's account for final settlement has
- 13 been approved; and
- 14 (3) the quardian has delivered all of the estate
- 15 remaining in the guardian's possession to any person entitled to
- 16 receive the estate.
- SECTION 21. Section 1251.005(a), Estates Code, is amended
- 18 to read as follows:
- 19 (a) On the filing of an application for temporary

(a) Except as otherwise provided by this 11 12 section, the changes in law made by this Act apply to a guardianship created before, on, or after the effective date of this Act. 13
- 14 Sections 1023.002(c), 1023.004(a) and (c), 1023.005(c), 15 1023.006, and 1023.007, Estates Code, as amended by this Act, and Section 1023.0071, Estates Code, as added by this Act, apply only to 16 17 an application filed or motion made to transfer a guardianship on or after the effective date of this Act. 18
- Sections 1023.006, 1156.052, and 1251.005(a), Estates 19 Code, as amended by this Act, apply only to an application filed on 20 or after the effective date of this Act. An application filed 21 before the effective date of this Act is governed by the law in 22 effect on the date the application was filed, and the former law is 23 24 continued in effect for that purpose.
- 25 SECTION 26. This Act takes effect September 1, 2023.
