- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 112.002, Occupations Code, is
- 7 transferred to Subchapter B, Chapter 112, Occupations Code,
- 8 redesignated as Section 112.0501, Occupations Code, and amended to
- 9 read as follows:

- Sec. 112.0501 [112.002]. APPLICABILITY. This subchapter
- 11 [chapter] applies only to licensing entities and health care
- 12 practitioners under Chapters 401, 453, and 454 and Subtitles B, C,
- 13 D, E, F, and K.
- 14 SECTION 2. Chapter 112, Occupations Code, is amended by
- 15 adding Subchapter C to read as follows:

16 SUBCHAPTER C. CONTINUING EDUCATION REQUIREMENTS

- Sec. 112.101. DEFINITIONS. In this subchapter:
- 18 <u>(1) "Continuing education course" means a course,</u>
- 19 clinic, forum, lecture, program, or seminar that an individual must
- 20 <u>complete in order to maintain or renew a license.</u>
- 21 (2) "Continuing education provider" means a person
- 22 authorized or approved by a licensing entity to offer continuing
- 23 education courses.
- 24 (3) "Continuing education tracking system" means an

- 1 electronic system established by a licensing entity as required by
- 2 <u>Section 112.104.</u>
- 3 (4) "License" means a license, certificate,
- 4 registration, permit, or other form of authorization that:
- 5 (A) is issued by a licensing entity; and
- 6 (B) an individual must obtain to engage in a
- 7 particular business, occupation, or profession.
- 8 Sec. 112.102. APPLICABILITY. (a) Except as provided by
- 9 Subsection (b), this subchapter applies only to a licensing entity
- 10 that issues a license to a health care practitioner under this
- 11 <u>title</u>.
- 12 (b) This subchapter does not apply to Subtitle L.
- 13 Sec. 112.103. CONTINUING EDUCATION COMPLIANCE REQUIRED FOR
- 14 LICENSE RENEWAL. (a) Notwithstanding any other law, a licensing
- 15 entity may not renew a health care practitioner's license unless
- 16 the licensing entity verifies that the health care practitioner has
- 17 complied with any continuing education requirements of the
- 18 <u>licensing entity.</u>
- 19 (b) Verification of a health care practitioner's compliance
- 20 with continuing education requirements that is generated by the
- 21 continuing education tracking system:
- 22 (1) satisfies the requirement of Subsection (a); and
- 23 (2) must be used in the conduct of any audit of health
- 24 care practitioners conducted by the licensing entity.
- 25 (c) This section does not prohibit a licensing entity from
- 26 imposing penalties under applicable statutes or rules for a health
- 27 care practitioner's failure to comply with continuing education

1 requirements. Sec. 112.104. CONTINUING EDUCATION TRACKING SYSTEM. (a) 2 Each licensing entity by rule shall establish a continuing 3 education tracking system for use by and accessible to health care 4 practitioners, licensing entity staff, and continuing education 5 6 providers. 7 (b) A continuing education tracking system established under this subchapter may not require any expenditure by the 8 9 licensing entity. 10 Sec. 112.105. DATA AND SYSTEMS REQUIREMENTS. (a) A 11 continuing education tracking system may collect and use only: (1) information that directly relates to a health care 12 13 practitioner's compliance with continuing education requirements, 14 including: 15 (A) the name in which the health care 16 practitioner's license is issued; 17 (B) the health care practitioner's license 18 number; 19 (C) the license issue date; 20 (D) the license expiration date; and 21 (E) any other information disclosed to the public 22 in response to a license verification request; and (2) other information designated by licensing entity 23 rule as necessary for the system's performance of a function 24

required by this subchapter.

under Section 112.104 must:

- 1 (1) if the continuing education tracking system is a
- 2 $\underline{\text{cloud-based}}$ system, be certified under the state risk and
- 3 authorization management program established under Section
- 4 2054.0593, Government Code; and
- 5 (2) comply with the Americans with Disabilities Act of
- 6 1990 (42 U.S.C. Section 12101 et seq.).
- 7 Sec. 112.106. RULEMAKING. A licensing entity shall adopt
- 8 rules necessary to implement this subchapter.
- 9 SECTION 3. Not later than September 1, 2024, each licensing
- 10 entity shall establish a continuing education tracking system as
- 11 required by Section 112.104, Occupations Code, as added by this
- 12 Act.
- SECTION 4. Notwithstanding Section 112.104(b), Occupations
- 14 Code, as added by this Act, a licensing entity subject to that
- 15 section that on the effective date of this Act has an agreement in
- 16 place with a continuing education tracking system provider that is
- 17 able to implement the requirements of Subchapter C, Chapter 112,
- 18 Occupations Code, as added by this Act, may maintain that agreement
- 19 and any costs associated with implementation of the agreement.
- 20 SECTION 5. This Act takes effect September 1, 2023.
