4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 161, Health and Safety Code, is amended
6	by adding Subchapter X to read as follows:
7	SUBCHAPTER X. PREGNANCY-RELATED RESOURCES AND INFORMATION
8	Sec. 161.701. PREGNANCY-RELATED RESOURCES AND INFORMATION
9	WEBPAGE. (a) The commission, with assistance from the Department
10	of Information Resources, shall develop and maintain on the
11	Texas.gov Internet website a publicly accessible, mobile-friendly
12	webpage of pregnancy-related resources and information, including
13	any available:
14	(1) resources for:
15	(A) mental health counseling, pregnancy
16	counseling, and other prenatal and postpartum services;
17	(B) mentorship opportunities, including
18	pregnancy assistance and case management;
19	(C) health care and well-being services,
20	including services for obstetrical and gynecological support,
21	abortion pill reversal, breast-feeding assistance, health care,
22	and dental care;
23	(D) financial assistance, employment
24	opportunities, nutrition assistance, child care options, and

1	educational opportunities;
2	(E) legal services, including legal services for
3	child support, custody issues, family leave, and breast-feeding
4	<pre>protections;</pre>
5	(F) professional support, including tax
6	preparation;
7	(G) financial and housing assistance, including
8	assistance with food, nutrition, clothing, household goods, baby
9	supplies, housing options, shelter options, maternity home
10	options, and crisis pregnancy center options;
11	(H) recovery and mental health services,
12	including services for addiction or suicide intervention,
13	counseling services for victims of intimate partner violence,
14	sexual assault, or sex trafficking, and counseling services for the
15	unexpected loss of a child;
16	(I) prenatal diagnostic services and postnatal
17	pediatric hospice services, including newborn medical
18	interventions and supportive palliative care, and disability
19	support organizations;
20	(J) healing and support services for abortion
21	survivors and the survivors' families; and
22	(K) services related to providing care for
23	children, including services for public and private adoption,
24	kinship care, foster care, and short-term child care;
25	(2) information about:
26	(A) alternatives to abortion;
27	(B) abortion risks, including complications and

1	failures;
2	(C) child development beginning at conception;
3	(D) pregnancy wellness;
4	(E) family planning;
5	(F) the Healthy Texas Women program defined by
6	<u>Section 32.151;</u>
7	(G) the Alternatives to Abortion program
8	administered by the commission;
9	(H) safe haven laws, including safe haven baby
10	boxes, and emergency infant care providers; and
11	(I) any pregnancy-related services provided by a
12	county in this state; and
13	(3) any other resources or information considered
14	helpful to pregnant women.
15	(b) The webpage described by Subsection (a) must:
16	(1) through a series of questions, provide the person
17	accessing the webpage information tailored to the person's answers,
18	including information regarding risks related to abortion at all
19	stages of gestation;
20	(2) allow for webpage users to submit feedback
21	regarding whether the webpage is user-friendly and helpful in
22	providing tailored answers described by Subdivision (1); and
23	(3) include a tool to search for resources described
24	by Subsection (a) by zip code and county.
