A BILL TO BE ENTITLED

- 2 relating to instructional material and technology, the adoption of
- 3 essential knowledge and skills for certain public school foundation
- 4 curriculum subjects, and creating allotments for the procurement of
- 5 certain instructional materials under the Foundation School
- 6 Program; authorizing a fee.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 11.164, Education Code, is amended by
- 9 amending Subsection (a) and adding Subsection (a-1) to read as
- 10 follows:
- 11 (a) The board of trustees of each school district shall
- 12 limit redundant requests for information and the number and length
- 13 of written reports that a classroom teacher is required to prepare.
- 14 A classroom teacher may not be required to prepare any written
- 15 information other than:
- 16 (1) any report concerning the health, safety, or
- 17 welfare of a student;
- 18 (2) a report of a student's grade on an assignment or
- 19 examination;
- 20 (3) a report of a student's academic progress in a
- 21 class or course;
- 22 (4) a report of a student's grades at the end of each
- 23 grade reporting period;
- 24 (5) a report on instructional materials;

- 1 (6) subject to Subsection (a-1), a unit or weekly
- 2 lesson plan that outlines, in a brief and general manner, the
- 3 information to be presented during each period at the secondary
- 4 level or in each subject or topic at the elementary level;
- 5 (7) an attendance report;
- 6 (8) any report required for accreditation review;
- 7 (9) any information required by a school district that
- 8 relates to a complaint, grievance, or actual or potential
- 9 litigation and that requires the classroom teacher's involvement;
- 10 or
- 11 (10) any information specifically required by law,
- 12 rule, or regulation.
- 13 (a-1) A unit or weekly lesson plan that is included in
- 14 instructional material, as defined by Section 31.002, and adopted
- 15 by the board of trustees of the school district at which a teacher
- 16 is employed is sufficient to satisfy a requirement to prepare
- 17 written information described by Subsection (a)(6).
- SECTION 2. Section 21.044, Education Code, is amended by
- 19 amending Subsection (a-1) and adding Subsection (h) to read as
- 20 follows:
- 21 (a-1) Any training requirements for a certificate specified
- 22 under Subsection (a) must require that the person demonstrate:
- 23 (1) basic knowledge of:
- 24 (A) each disability category under the
- 25 Individuals with Disabilities Education Act (20 U.S.C. Section 1400
- 26 et seq.) and how each category can affect student learning and
- 27 development; and

- 14 SECTION 3. Subchapter I, Chapter 21, Education Code, is
- 15 amended by adding Section 21.4045 to read as follows:
- 16 Sec. 21.4045. PLANNING AND NONINSTRUCTIONAL DUTIES OF
- 17 TEACHERS. (a) A school district may permit, but may not require, a
- 18 classroom teacher for a foundation curriculum course to spend
- 19 planning and preparation time to which the teacher is entitled
- 20 under Section 21.404 creating or selecting instructional materials
- 21 to initially cover the applicable essential knowledge and skills
- 22 for the course unless the contract under which the teacher is
- 23 employed explicitly states that the teacher is responsible for
- 24 duties relating to initial lesson plan design or instructional
- 25 material selection.
- 26 (b) A contract between a school district and a classroom
- 27 teacher under which a teacher is assigned responsibility for duties

- 1 unrelated to providing instruction and that requires the teacher to
- 2 work a greater number of hours than the number of hours worked by
- 3 other full-time teachers of the same grade level in the district
- 4 must explicitly state each of the teacher's duties unrelated to
- 5 providing instruction.
- 6 SECTION 4. Subchapter B, Chapter 22, Education Code, is
- 7 amended by adding Section 22.05125 to read as follows:
- 8 Sec. 22.05125. IMMUNITY FROM DISCIPLINARY PROCEEDINGS FOR
- 9 CLASSROOM TEACHERS. (a) In this section, "disciplinary
- 10 proceeding" has the meaning assigned by Section 22.0512.
- 11 (b) A classroom teacher employed by a school district may
- 12 not be subject to disciplinary proceedings for an allegation that
- 13 the teacher violated Section 28.0022, the Establishment Clause of
- 14 the First Amendment of the United States Constitution, or a related
- 15 state or federal law if:
- 16 (1) the teacher used only instructional material
- 17 included on the list of approved instructional material maintained
- 18 by the State Board of Education under Section 31.022 and adopted by
- 19 the district; and
- 20 (2) the allegation does not dispute that the teacher
- 21 delivered instruction from instructional material described by
- 22 <u>Subdivision (1) with fidelity.</u>
- (c) The immunity provided by Subsection (b) is in addition
- 24 to any other immunity provided by law. This section may not be
- 25 construed to interfere with any other immunity provided by law.
- SECTION 5. Section 26.006, Education Code, is amended by
- 27 amending Subsection (b) and adding Subsections (b-1) and (f) to

- 1 read as follows:
- 2 (b) A school district shall make teaching materials and
- 3 tests readily available for review by parents both in person and, if
- 4 applicable and subject to denial under Section 31.154(e), through
- 5 an instructional materials parent portal established under Section
- 6 31.154. In providing access to instructional materials to a
- 7 student's parent under this section, the district shall:
- 8 <u>(1) allow access beginning not later than 30 days</u>
- 9 before the school year begins and concluding not earlier than 30
- 10 days after the school year ends; and
- 11 (2) include, for the entire period specified in
- 12 Subdivision (1), access to all instructional materials that pertain
- 13 to each subject area in the grade level in which the student is
- 14 enrolled, except for:
- 15 (A) tests or exams that have not yet been
- 16 administered to the student; and
- 17 <u>(B) the student's graded assignments.</u>
- 18 (b-1) The district may specify reasonable hours for
- 19 in-person review.
- 20 (f) A school district that denies a parent access to an
- 21 instructional materials parent portal under Section 31.154(e) must
- 22 permit the parent to appeal the denial to the board of trustees of
- 23 the school district.
- SECTION 6. Chapter 26, Education Code, is amended by adding
- 25 Section 26.0061 to read as follows:
- Sec. 26.0061. RIGHT TO REQUEST INSTRUCTIONAL MATERIAL
- 27 REVIEW. (a) The board of trustees of each school district shall

- 1 establish a process by which a parent of a student, as indicated on
- 2 the student registration form at the student's campus, may request
- 3 an instructional material review under Section 31.0252 for a
- 4 subject area in the grade level in which the student is enrolled.
- 5 (b) A process established under Subsection (a):
- 6 (1) may not require more than one parent of a student
 7 to make the request;
- 8 (2) must provide for the board of trustees of the
- 9 school district to determine if the request will be granted, either
- 10 originally or through an appeal process; and
- 11 (3) may permit the requesting parent to review the
- 12 instructional material directly before the district conducts an
- 13 instructional material review under Section 31.0252.
- 14 (c) If the parents of at least 25 percent of the students
- 15 enrolled at a campus present to the board of trustees of the school
- 16 <u>district in which the campus is located a petition for the board to</u>
- 17 conduct an instructional material review under Section 31.0252, the
- 18 board shall, subject to Subsection (d), conduct the review, unless
- 19 the petition is presented by the parents of less than 50 percent of
- 20 the students enrolled at the campus and, by a majority vote, the
- 21 <u>board denies the request.</u> A review conducted under this subsection
- 22 shall include a review of instructional materials for each subject
- 23 area or grade level specified in the petition.
- 24 <u>(d) The board of trustees of a school district is not</u>
- 25 required to conduct a review under this section for a specific
- 26 <u>subject area or grade level at a specific district campus more than</u>
- 27 once per school year.

- 1 (e) Parental access to instructional material provided by
- 2 an instructional material review conducted under this section is in
- 3 addition to any other right to access instructional material
- 4 granted by this title or school district policy.
- 5 (f) The State Board of Education may adopt rules to
- 6 implement this section.
- 7 SECTION 7. Section 28.002, Education Code, is amended by
- 8 adding Subsections (c-4) and (c-5) to read as follows:
- 9 <u>(c-4)</u> In adopting essential knowledge and skills for
- 10 English language arts under Subsection (a)(1)(A), the State Board
- 11 of Education shall specify a list of required vocabulary and at
- 12 least one literary work to be taught in each grade level. The
- 13 vocabulary specified by the board must support the essential
- 14 knowledge and skills adopted for other courses offered under the
- 15 foundation curriculum under Subsection (a)(1).
- 16 <u>(c-5)</u> The State Board of Education shall initiate the
- 17 process of specifying an initial list of vocabulary and literary
- 18 works as required by Subsection (c-4) not later than February 1,
- 19 2024. The State Board of Education shall request from the agency
- 20 recommendations regarding the list, and that request for
- 21 recommendations may be considered an initiation of the process.
- 22 This subsection expires September 1, 2025.
- SECTION 8. The heading to Section 28.0027, Education Code,
- 24 is amended to read as follows:
- Sec. 28.0027. DISTRICT CURRICULUM SCOPE, [AND] SEQUENCE,
- 26 AND INSTRUCTIONAL MATERIAL.
- SECTION 9. Sections 28.0027(a) and (b), Education Code, are

- 1 amended to read as follows:
- 2 (a) In adopting a recommended or designated scope and sequence or instructional materials for a subject in the required 4 curriculum under Section 28.002(a) in a particular grade level, a school district shall ensure sufficient time is provided for
- 6 teachers to teach and students to learn the essential knowledge and
- 7 skills for that subject and grade level.
- (b) Except as provided by Subsection (c), a school district
 may not penalize a teacher who does not follow the pacing of
 recommended or designated instructional materials or the pacing of
 the recommended or designated scope and sequence for a subject in
 the required curriculum under Section 28.002(a) in a particular
 grade level based on the teacher's determination that the teacher's
 students need more or less time in a specific area to demonstrate
- 16 and grade level.

17 SECTION 10. Section 28.0062, Education Code, is amended by adding Subsection (a-1) to read as follows:

proficiency in the essential knowledge and skills for that subject

- 19 <u>(a-1)</u> In this subsection, "three-cueing" means a method of
- 20 reading instruction for identification of words by which a student
- 21 <u>is encouraged to draw on context and sentence structure to read</u>
- 22 words without sounding the words out or using a phonics-based
- 23 approach. A school district or open-enrollment charter school may
- 24 not include any instruction that incorporates three-cueing in the
- 25 phonics curriculum required under Subsection (a)(1).
- 26 SECTION 11. The heading to Chapter 31, Education Code, is
- 27 amended to read as follows:

1 CHAPTER 31. INSTRUCTIONAL MATERIALS AND TECHNOLOGY 2 SECTION 12. Section 31.002, Education Code, is amended by amending Subdivisions (1) and (1-a) and adding Subdivisions (1-b), 3 4 (1-c), and (3) to read as follows: 5 (1)"Full subject tier one instructional material" means instructional material designed to, if implemented as 6 7 designed, provide a student with mastery of the essential knowledge and skills adopted by the board for a certain subject and grade 8 level in the required curriculum under Section 28.002 or for 9 prekindergarten without the need for supplementation. 10 11 (1-a) "Instructional material" means content that conveys the essential knowledge and skills of a subject in the 12 13 public school curriculum through a medium or a combination of media for conveying information to a student. The term includes: 14 15 (A) material used by a teacher, including a 16 lesson plan, answer key, grading rubric, or unit plan; 17 (B) material used by a principal or campus 18 instructional leader to support instruction; and 19 (C) material used by a student, including a book, 20 supplementary materials, a combination of a book, workbook, and supplementary materials, computer software, magnetic media, DVD, 21 22 CD-ROM, computer courseware, on-line services, or an electronic medium, or other means of conveying information to the student or 23 24 otherwise contributing to the learning process through electronic 25 means, including open education resource instructional material.

- SECTION 13. Section 31.003, Education Code, is amended to

- Sec. 31.003. RULES. (a) The State Board of Education may
- 25 adopt rules, consistent with this chapter, for the adoption,
- 26 requisition, distribution, care, use, and disposal of
- 27 instructional materials.

- 1 (b) The commissioner may adopt rules, consistent with this
- 2 chapter, as necessary to implement any provision of this chapter.
- 3 SECTION 14. Subchapter A, Chapter 31, Education Code, is
- 4 amended by adding Section 31.006 to read as follows:
- 5 Sec. 31.006. ADVISORY COMMITTEE. The State Board of
- 6 Education or the agency may form an advisory committee to comply
- 7 with the provisions of this chapter. Chapter 2110, Government
- 8 Code, does not apply to an advisory committee formed under this
- 9 section.
- 10 SECTION 15. Chapter 31, Education Code, is amended by

- 2 [(8) pay the expenses associated with the
- 3 instructional materials web portal developed under Section
- 4 31.081].
- 5 (d) Money transferred to the state instructional materials
- 6 and technology fund remains in the fund until spent and does not
- 7 lapse to the state at the end of the fiscal year.
- 8 Sec. 31.0212. INSTRUCTIONAL MATERIALS AND TECHNOLOGY
- 9 ACCOUNT. (a) The commissioner shall maintain an instructional
- 10 materials and technology account for each school district. In the
- 11 first year of each biennium, the commissioner shall deposit in the
- 12 account for each district the amount of the district's
- 13 instructional materials and technology allotment under Section
- 14 31.0211.
- 15 (b) The commissioner shall pay the cost of instructional
- 16 materials requisitioned by a school district under Section 31.103
- 17 using funds from the district's instructional materials and
- 18 technology account.
- 19 (c) [A school district may also use funds in the district's
- 20 account to purchase electronic instructional materials or
- 21 technological equipment. The district shall submit to the
- 22 commissioner a request for funds for this purpose from the
- 23 district's account. The commissioner shall adopt rules regarding
- 24 the documentation a school district must submit to receive funds
- 25 under this subsection.
- 26 [(d)] Money deposited in a school district's instructional
- 27 materials and technology account during each state fiscal biennium

- 1 remains in the account and available for use by the district for the
- 2 entire biennium. At the end of each biennium, a district with
- 3 unused money in the district's account may carry forward any
- 4 remaining balance to the next biennium.
- 5 (d) A [(e) The commissioner shall adopt rules as necessary
- 6 to implement this section. The rules must include a requirement
- 7 that a] school district shall provide to the agency the title and
- 8 publication information for any instructional materials
- 9 requisitioned or purchased by the district with the district's
- 10 instructional materials and technology allotment.
- 11 (e) The agency shall provide for the development and
- 12 maintenance of an online requisition and disbursement system for
- 13 each school district's instructional materials and technology
- 14 account.
- 15 Sec. 31.0214. ADJUSTMENT FOR HIGH ENROLLMENT GROWTH
- 16 DISTRICTS. [(a)] Each year the commissioner shall adjust the
- 17 instructional materials and technology allotment of school
- 18 districts experiencing high enrollment growth. The commissioner
- 19 shall establish a procedure for determining high enrollment growth
- 20 districts eligible to receive an adjustment under this section and
- 21 the amount of the instructional materials and technology allotment
- 22 those districts will receive.
- [(b) The commissioner may adopt rules as necessary to
- 24 implement this section.
- 25 Sec. 31.0215. INSTRUCTIONAL MATERIALS AND TECHNOLOGY
- 26 ALLOTMENT PURCHASES. (a) The commissioner shall, as early as
- 27 practicable during each biennium, notify each school district and

- 1 open-enrollment charter school of the estimated amount to which the
- 2 district or charter school will be entitled under Section 31.0211
- 3 during the next fiscal biennium.
- 4 (b) The commissioner shall [may] allow a school district or
- 5 open-enrollment charter school to place an order for instructional
- 6 materials before the beginning of a fiscal biennium and to receive
- 7 instructional materials before payment. The commissioner shall
- 8 limit the cost of an order placed under this section to 80 percent
- 9 of the estimated amount to which a school district or
- 10 open-enrollment charter school is estimated to be entitled as
- 11 provided by Subsection (a) and shall first credit any balance in a
- 12 district or charter school instructional materials and technology
- 13 account to pay for an order placed under this section.
- 14 (c) The commissioner shall make payments for orders placed
- 15 under this section as funds become available to the instructional
- 16 materials and technology fund and shall prioritize payment of
- 17 orders placed under this section over reimbursement of purchases
- 18 made directly by a school district or open-enrollment charter
- 19 school.
- 20 (d) The commissioner shall ensure that publishers of
- 21 instructional materials are informed of any potential delay in
- 22 payment and that payment is subject to the availability of
- 23 appropriated funds. A publisher may decline to accept an order
- 24 placed under this section.
- 25 (e) Chapter 2251, Government Code, does not apply to
- 26 purchases of instructional materials under this section.
- 27 [(f) The commissioner may adopt rules to implement this

- 2 SECTION 18. Section 31.0211, Education Code, as amended by
- 3 Chapters 806 (H.B. 1525) and 1003 (H.B. 3261), Acts of the 87th
- 4 Legislature, Regular Session, 2021, is transferred to Subchapter
- 5 A-1, Chapter 31, Education Code, as added by this Act, reenacted,
- 6 and amended to read as follows:
- 7 Sec. 31.0211. INSTRUCTIONAL MATERIALS AND TECHNOLOGY
- 8 ALLOTMENT. (a) A school district is entitled to an allotment each
- 9 biennium from the state instructional materials and technology fund
- 10 for each student enrolled in the district on a date during the last
- 11 year of the preceding biennium specified by the commissioner. The
- 12 commissioner shall determine the amount of the allotment per
- 13 student each biennium on the basis of the amount of money available
- 14 in the state instructional materials and technology fund to fund
- 15 the allotment. An allotment under this section shall be
- 16 transferred from the state instructional materials and technology
- 17 fund to the credit of the district's instructional materials and
- 18 technology account as provided by Section 31.0212.
- 19 (b) A juvenile justice alternative education program under
- 20 Section 37.011 is entitled to an allotment from the state
- 21 instructional materials and technology fund in an amount determined
- 22 by the commissioner. The program shall use the allotment to
- 23 purchase items listed in Subsection (c) for students enrolled in
- 24 the program. The commissioner's determination under this
- 25 subsection is final and may not be appealed.
