2 WHEREAS, Texas game wardens devote themselves to protection of the state's natural resources, and since 1895, 20 of 3 4 these dedicated public servants have tragically lost their lives while fulfilling their important duties; and 5

WHEREAS, Game wardens, as certified peace officers, responsible for preserving the peace and enforcing the game, fish, and water safety laws of Texas, which include, but are not limited to, apprehending poachers and other individuals who ignore wildlife 9 10 law; many of the criminals that game wardens encounter have also ventured into other illegal activities, such as theft or the drug 11 trade, and because game wardens are often patrolling areas with hunters, loaded guns are a constant in their work; the myriad challenges of the job may put them in harm's way at any time; and

14 15 WHEREAS, To honor those who died in the line of duty, the Game Warden Peace Officers Association has commissioned a Game Warden 16 17 Memorial to be designed and sculpted to the Association's specifications, and be dedicated to the memory of Joe Williams, 18 Harry Raymond, Dawson Richard Murchison, R. M. Wynne, Gus Engeling, 19 Claude Keller, J. D. - 10 the historic Capitol grounds; and, be it further
- 11 RESOLVED, That the board consider a site south of the Sam
- 12 Houston Building for the location of the memorial; and, be it

- 14 RESOLVED, That the Texas secretary of state forward an
- 15 official copy of this resolution to the executive director of the
- 16 State Preservation Board and to the chair and president of the Game
- 17 Warden Peace Officers Association.
