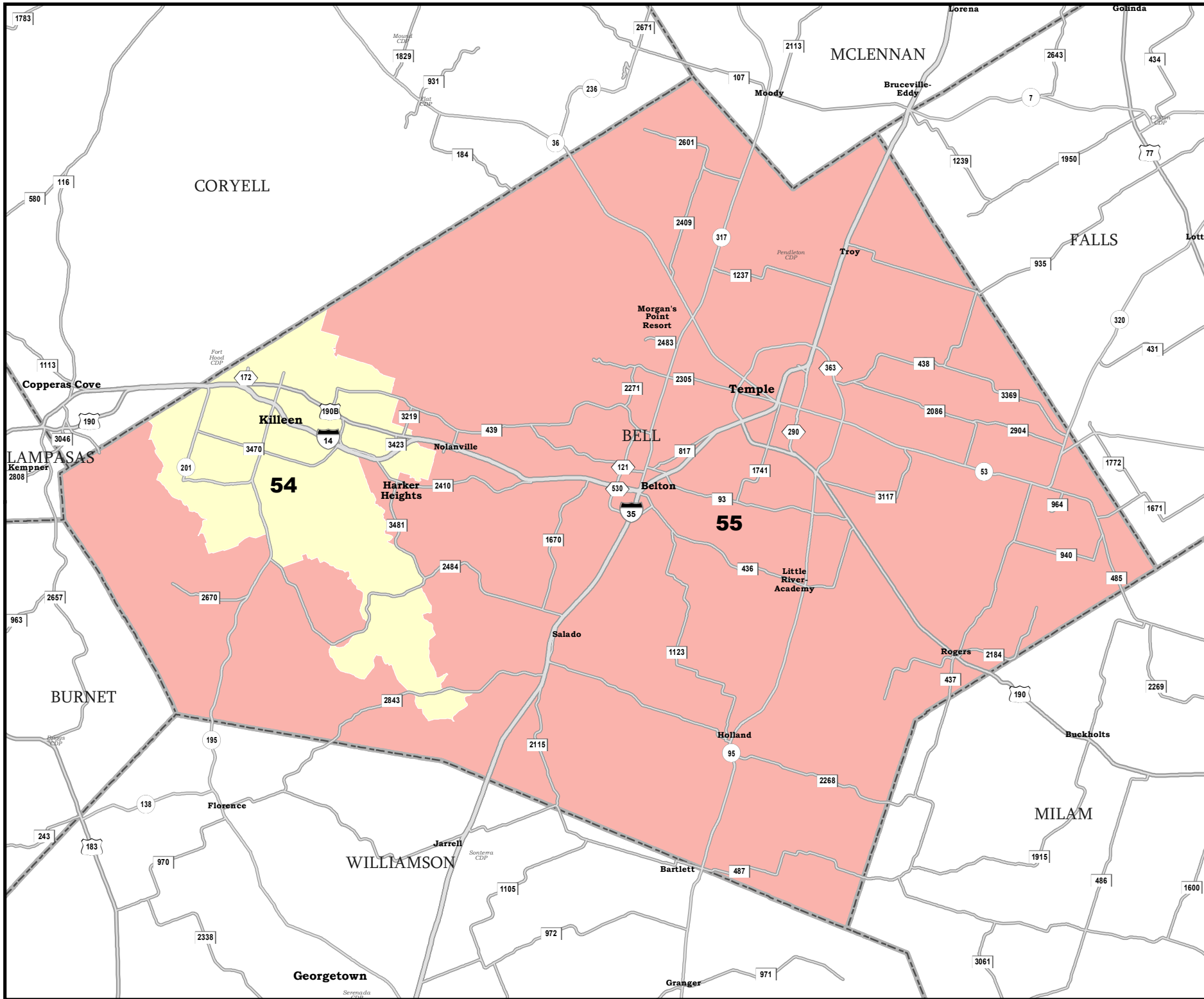
# State House Districts Proposed Plan PLANH2216

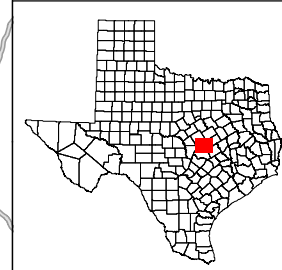
