## **NOTICE OF INTENTION TO INTRODUCE A BILL IN THE LEGISLATURE OF TEXAS**

Notice is hereby given of the  
intention to introduce in the  
Regular Session of the 88th  
Legislature of Texas a bill  
creating and establishing a  
special district in the corpo-  
rate limits of the City of  
Mustang Ridge, Travis  
County, under the provisions  
of Article XVI, Section 59 of  
the Constitution of Texas,  
with powers including those  
given to municipal utility  
districts operating pursuant  
to Chapters 49 and 54, Texas  
Water Code. The bill will  
provide for the district's  
administration, powers,  
name, duties, operation, and  
financing. The district is  
proposed to include approxi-  
mately 57 acres +/- gener-  
ally located north of Tom  
Sassman Road, south of FM  
1327, and west of US HWY
