COMMENTS FOR HB 92 by Landgraf

I am thankful that this bill has been authored and is being heard. As Texans face inflation and an increase at the grocery store, I feel that this bill is imperative for the self sufficiency of all Texans.

I would like to see this bill add that municipalities cannot regulate distance of fowl or rabbits from other structures. Many properties are on small lots. Most municipalities will simply bypass this law by increasing the distance needed to do so. I think that it makes more sense to allow Texans to keep their birds and rabbits on their property. If the birds or rabbits escape, that then becomes a nuisance and only then should property owners be penalized. Texans invested in their own property. Please, consider allowing them to use it as they see fit.

I also believe that cockerals and roosters should be allowed. They are much quieter than dogs, horns, construction, and some stereo systems. They help Texans create more chicks and that could be dinner for some families. It is important that as times change, we are able to feed our families. Families may need to depend on a rooster to create more food to provide a better life for their children.

Quail are very small birds. I think that the limit for quail should be much higher than only six. Ideally, it would be nice to see families keep both quail and chickens. These small eggs are highly nutrient rich. I would love to see the state allows both. Quail are tasty and the young roosters can be eaten and offer food for families.

Thank you for listening to my suggestions. I think the time has come to put people's lives back in their own hands. This is a wonderful way to do it!

Jessica Smith Self, registered nurse San Antonio, TX Homeowners should be allowed to keep hens in a fenced back yard with reasonable restrictions that can be dictated by the HOA, including a limit to the number of hens, whether a rooster would be allowed, a standard of cleanliness to limit smells, and distance from other residential buildings. Hens are typically quieter than other animals allowed on properties, such as dogs, and typically don't leave their immediate shelter area like other animals allowed on properties, such as cats.

There are many reputable studies that show the many benefits of allowing households to have backyard hens. For brevity I will list some of them with bullet points and provide sources at the end.

- Uneaten food in Texas makes up approximately 21% of municipal waste. It also makes up 23% of methane emissions. Allowing backyard chickens helps to curb these numbers.
- Each hen consumes approximately 82.9 pounds of household food scraps a year.
- Chickens produce approximately half of the greenhouse gases produced from the decomposition of food waste in landfills.
- Local, sustainable food source. You get healthy eggs and meat from well-cared-for chickens rather than that from the inhumane chicken industry as it is now.
- Egg-celent (sorry) fertilizer for gardens, leading to even more sustainability and food security.
- These "healthier" eggs contain twice as much Vitamin E and Omega 3 fatty acids than those produced by the chicken/egg industry.
- Chickens eat pests in the yard as well.
- Chickens can make good pets, teaching children important skills in caring for animals and being involved in the creation of their food.
- Chickens are cheep (sorry again)! After the initial cost of the coop and maybe some feed to supplement food scraps, hens more than pay for themselves. Especially with their costs in stores having tripled in the past few months.

Hens contribute so much to a household and the community in general, from being able to provide food security to households to reducing the amount of food scraps that make it to city landfills and their methane emissions. There are many HOAs that withhold the right of a homeowner to have hens in a back yard with rules that are nearly impossible to overturn. We need to have an overarching law that allows homeowners their right to food security while also allowing the HOAs to regulate it within reason to maintain their status quo.

Backyard hens don't just benefit the one, they benefit the many.

Rep. Landgraf and Members of the Agriculture and Livestock Committee, I am commenting in support of advancing HB 92 for a vote by the Texas House.
