Even more shocking is that there is now evidence that our Chairman lied and told all 7 of our Republican Women's groups and other Republican groups that we "lost" our headquarters because the rent had not been paid in over 4 months!

Our chairman didn't care about ethics or our county or the fate of the CEC. It's gotten so bad that 60 members of our CEC have spent our own money to get legal help and we filed a Writ of Mandamus at the Texas Supreme Court. This action was taken because the SREC refused to enforce their own rules to force our Chairman to follow the bylaws.

This section goes on to say, "The county chair MAY form a vacancy committee to assist in filling vacancies under this subsection". I believe this should be, at a bare minimum, a requirement to form this committee.

I further believe that all replacement precinct chairs should be vetted by that Vacancy Committee and then approved by the entire County Executive Committee.

I have been a MCRP Precinct chair for approximately 10 years and the Vacancy Chair since 2018.

Unfortunately, the amendments in HB4636 give a County Chair unbridled control and power.

Since 2018, the Vacancy Committee implemented new procedures. We actively recruit, interview, and recommend potential prospects to fill vacancies but the CEC has the power to appoint. This has resulted in outstanding, gifted precinct chairs that truly desire to serve & represent their constituents.

Why would we want to allow a county chair to have the authority to fill vacancies or appoint members to a vacancy committee that would merely follow his dictates? We have had a dictator in the past...No thank you!

The County Chair always has that ability to call meetings as it stands. Our bylaws allow a group of at least 20% of the Precinct Chairs to call a special meeting should a need arise.

I urge you as well to see the danger in amended language in Section 6. (a)(1) and 6.(e). Our party has experienced issues with bank accounts and assets not being passed to the new county chair and CEC body. A County Chair is responsible for administering the Primary Account and the Corporate account only. Never a good idea to have ALL funds in one person's hands or one person approving the contracts which should be approved by the entire CEC.

Political parties are private organizations. We have the freedom of association. Section 4. (c) has been inappropriately applied to a political party to be subject to Section 551.127 as we are not a governmental agency and not under the Government Code. HB4636 clarifies, without equivocation, that the Texas Election Code, not party rules, dictate how and if a local party officer may be removed from office. Mr. Chairman, members of the Committee, I believe that H.B. 4636 is a very BAD piece of legislation that would have very negative consequences for both party's executive committee members in several Texas counties. My name is Bob Green, and I am Chair of the Travis County Republican Party's Election Integrity Committee for Legislation. I had intended to provide this testimony in person tomorrow, but I need to be out of town.

A little history: Travis County voters once elected a conspiratorial nutcase, Robert Morrow, as our county chair. The race was at the bottom of the ballot, he was listed first and had a normal sounding name. Furthermore, in heavily Democrat counties like Travis, our county chair race does not get a lot of public attention. After the election, our precinct chairs did damage control by ensuring that party funds would NOT be handled by Mr. Morrow, and that the Executive Committee ("EC") as a whole, and NOT Mr. Morrow, would speak for our county party.

This Bill would negate essential controls on accountability, and make county parties more vulnerable to financial and other "mischief" by a power-hungry chair. Note: Precinct chairs, too, are elected officials who have to run on the same ballot as county chair candidates. Candidates have opponents, are accountable to the people who elected them and so deserve a meaningful voice in the governance of their party. However, under this Bill, even requiring audits would require the consent of the county chair; and he/she could do anything with the bank account, and the county's EC would have no say in the matter. The precinct chairs couldn't even require audits unless the county chairman consented to put it on the agenda.

What if the county chairman is stealing money? Under this bill, the county EC would be powerless to act. Also, what if the county chairman fails to perform a mandatory duty under the Election Code? For example, in counties that include more than one senate district, the precinct chairs elect the chair of the district convention. Sometimes that chair comes from a different faction of the party than the county chair...or has different views. Under this Bill, the chairman could threaten not to call the meeting unless the precinct chairs agree to elect the chair's preferred candidate. It would also prevent the removal of precinct chairs who don't attend meetings.

If H. B. 4636 should become law, it could very well cause a discrimination problem. Republican Party of Texas Rule 3 prohibits racial discrimination, but this bill would supersede that non-discrimination policy. This Bill, as law, would allow county chairs to unilaterally select people to fill chairs in vacant precincts; so if the chair decided not to appoint women, or racial minorities, the EC would be powerless to enforce our party's non-discrimination rule.

Therefore, I ask the House Elections Committee to OPPOSE passage of H. B. 4636 as written. Thank you.

HB5180 For

Relating to the disclosure of anonymous voted ballots under the public information law. HB 1356 Against

AGAINST. The measure consolidates power of precinct party chair appointments to the county party chair. No issue with Section 1 of the measure.

Regarding Section 2 of the measure. It allows the county party chair to appoint non-voting members to assist the county executive committee at the pleasure of the county party chair. This diminishes the consent of the governed by consolidating power in the county party chair. It should be amended to provide an "advise and consent" role for the executive committee membership. Propose the following change:

"SECTION 2. Section 171.022, Election Code, is amended by adding Subsection (e) to read as follows:

(e) With the advice and consent as determined by a plurality of votes of the precinct chairs of the executive committee, the county chair may appoint ex officio, nonvoting members, as necessary, to assist the county executive committee in conducting business, to serve at the pleasure of the executive committee."

Section 3 of the measure further consolidates unilateral power to the county party chair allowing the county party chair to unilaterally fill precinct vacancy. This change should be stricken and the original text remain.

Section 4 of the measure invests sole authority for setting the schedule and agenda for county executive committee meetings with the county party chair. No authority is provided to allow requests for meetings or introduction of agenda topics by executive committee membership. Recommend revising language to read:

"SECTION 4. Section 171.026, Election Code, is amended to read as follows:

Sec. 171.026. MEETINGS; PROXY NOT ALLOWED. (a) The county chair shall set the schedule for meetings and the agenda for each meeting with the advice and consent of the precinct chairs as determined by a plurality of votes.

- (b) A person may not participate in a county executive committee meeting as a proxy.
- (c) A county executive committee meeting may be in person or by videoconference, as provided by Section 551.127, Government Code."

Section 6 of the measure outlines changes to Sec. 171.028 of the Texas Election Code specific to the authority of the county party chair by adding explicit authority and administration of all county party accounts and contracts. No check and balance are associated with this "power of the purse string." There should be language adopted that provides an authorization and appropriation role for the executive committee.

Section 7 of the measure limits means of removal of a county party chair. This seem to disenfranchise the precinct chairs of the county executive committee of an oversight role in redressing county chair performance shortfalls. Like most of legislature design for roles of parties in the election process, authority is focused on consolidation at higher levels and not down to the constituency most affected by those performance shortfalls. Power needs to devolve more to citizenry and not party apparachik.

I oppose 171.022(e) because it is already addressed in most of the CEC governing Bylaws or Rules.

I oppose 171.024(c) because it violates the rights of the assembly (precinct chairs) to select its peers per Roberts Rules of Order Newly Revised. The county chair is only the presiding officer during the conduct of meetings.

I support 171.026(a).

I oppose 171.026(c) because participation is degraded by the quorum needed to establish a true membership attendance which may violate 171.026(b) PROXIES, to debate as an assembly, and to vote as an assembly. In addition, HB 4636 would give county chairs sole power to schedule CEC meetings and set meeting agendas. This violates best practices in parliamentary procedure as set forth in Robert's Rules of Order, Newly Revised. The chair currently can call meetings and propose agendas, which precinct chairs can then make motions to amend before adoption. Depending on the bylaws and rules of each CEC, some percentage of the precinct chairs may have the power to call a meeting by written request if the chair refuses, which has happened in Collin County before. This legislation would likely be interpreted to override these provisions and vest all these powers in the chair, regardless of the bylaws or rules each CEC adopts.

Please vote NO on this bill and please don't let any of the Amendments to the Election Code contained in HB 4636 pass out of committee as every one of them is created to take away all of the authority of out of the body of the County Executive Committee which is the body which is most accountable and responsible to voting public, the elected Precinct Chairs.

It is astonishing that this bill's intent is to eliminate the County Executive Committee's Bylaws which are voted on and passed by the CEC each biennium. The State Election Code should not govern how each county determines their Agenda, meeting calls, voting in person or virtual, banks accounts, contracts, chose precinct chairs to fill vacancies, or how the chairman can be removed from office.

The Republican Party of Texas is a private organization. The RULES of the RPT already set out the governing principles/rules of the Chairman and the County Executive Committee.
