I am AGAINST this bill. To allow unlicensed civilians to act as law enforcement (even having the authority to arrest people if "trained" and authorized by the governor) is inappropriate. This unit would give far right wing supporters an excuse for racially profiling minorities. Additionally, allowing a civilian without proper education and training to instigate an altercation will result in easily avoidable violence or other physical altercations. our licensed and trained law enforcement officers already struggle with handling these types of situations, why is the government entrusting the lay person? This is similar to how veterinary medicine is run in the state of Texas (and many others) - lay persons (un-licensed) are legally allowed to act (almost to a complete extent) as licensed practitioners. There may be a few "good eggs" that catch on well, but there will be far more people who don't actually know how to do the job correctly and, as in the case of veterinary medicine, deaths can and will result. Licensures and other certifications exist to allow regulation and proper training, as well as appropriate oversight and discipline of occupations. Just like licensed medical professionals train to understand the actions (and consequences) of anesthetic drugs to ensure your pet does not feel any pain during surgery and wakes up healthy afterwards, a licensed law enforcer trains to understand the law, and how to avoid the unnecessary use of deadly force in an escalated situation. Even if you do not care about the safety of those being attained, you should at least care about avoiding endangering the lives of civilians who would be put in such situations as a result of this unit. At the very least, can we at least keep law enforcement under the control of legal law enforcers??

HB20:

Sets up constitutional, independent action by Texas to take effective action by invoking Article I, Sec 3, Clause 3 reservation of self-defense power to the states when we are "in such imminent danger as will not admit of delay" or "unless actually invaded."

Creates a Border Protection Unit that will report directly report to the governor.

Authorizes the Border Protection Unit to "deter and repel persons attempting to enter the State of Texas illegally at locations outside a port of entry," to "return aliens to Mexico who have been observed actually crossing the Mexican border illegally, and were apprehended or detained in the immediate vicinity of the border," and to "use force to repel, arrest, and detain known transnational cartel operatives in the border region."

Creates beefed up border trespass offense in the Penal Code – makes it a third degree felony and subject to \$10K civil penalty each time a "person knowingly enters property of another without effective consent when knowingly entering the state of Texas from a neighboring jurisdiction."

Creates another constitutional way for Texas to act independently by invoking constitutionally clear state authority to protect health.

Creates a standing Legislative Border Safety Oversight Committee

My name is Mark Anthony Vasquez and I am a resident of the Rio Grande Valley sending testimony in opposition to HB 20. I reside in a home that is less than 6 miles from the U.S./Mexico border. I am in opposition because I am in opposition to what I see here. It is impossible to deny the absurdity. That such a bill should become law would demand that we as a people embrace a state-sponsored culture of exemption - where law enforcement in our border communities is subject to one order, while other communities fall under another.

That there are not culturally motivated factors which gave life to this motive is a very serious question which concerns us on the border. HB 20 is a dangerous border enforcement bill, designed to further criminalize and militarize border communities. This bill will only serve to embolden vigilantes, armed with a limited restraint and an equally limited experience in law enforcement to act in accordance with whatever fragile sense of place they may possess or whatever displaced racial motives may have driven them to act to begin with.

If the state of Texas is as concerned as are the residents of our border communities then we encourage our governing body to consider the root causes of the humanitarian crisis on the border. In so doing, it becomes glaringly apparent that to remedy a crisis with an over-saturation of law enforcement and militarization is an ill-conceived remedy to a symptom of a larger problem that is our broken immigration system. To invest time and effort as the state has to confront a mere symptom is futile - for the symptoms will continue to arise if one is to ignore the major ailment at hand.

Since its inception, neither the Texas Dept of Public Safety nor Gov. Abbott have provided proof that Operation Lone Star has helped the ongoing humanitarian crisis. HB 20 is just another attempt to exclude the border communities from the rule of law and indoctrinate an order of state-sponsored vigilantes to further the campaign to harass migrants and asylum seekers and to carry further the lie that such actions are necessary against our border communities.

I am in opposition to HB 20 because it is inhumane to treat entire regions of the state in such a way. We cannot as Texans allow for such bills to become law.

I am also a 22 year Army Veteran and my last assignment was an Infantry Officer in the Texas Army National Guard on the current Operation Lone Star mission.

I oppose this bill as it is currently written.

This bill continues to see Foreign Terrorist organizations (The Mexican cartels), their threat networks, and their nexus to adversarial state (China, Iran, Venezuela, etc.) and non-state (Hezbollah, MS-13, Islamic Violent Extremist Organizations, Street gangs, etc) actors as a law enforcement issue—as opposed to matters of national security.

For the bill to be truly effective, it must institutionalize what we have learned from our recent experiences countering FTOs, unconventional warfare and hybrid threats worldwide.

There are significant challenges in the ability of traditional Law Enforcement structures to synchronize objectives in a counter terrorism / Counter Hybrid threat environment. As it stands now, there is already a lack of unity of effort/command between Operation Lone Star (DPS & TMD), Operation Stone Garden entities and DHS (Customs & Border Patrol, ICE, HIS) at the Strategic, operational and tactical levels.

This suggests the need for a joint force mission command structure specifically designed to plan and execute Border Security campaigns and Counter terrorism/Hybrid threat operations on the border and throughout Texas.

The Border Protection Unit needs to consist of two Divisions, the Border division and the Interior Division. The Border Protection Unit will divide the State into 24 sectors, following the 24 regional councils of government jurisdictions.

Each sector needs to contain a Joint Operations Intelligence Center (JOIC)

The Border Security Operations Center (BSOC) in Austin serves as the central hub for information collected at the JOICs.

The Unit's Border Division primary responsibility:

a) Wide Area Security: Security across the 1,254 Texas/Mexico international border with all the coordinating lines of effort (State, County, Local) in order to protect forces, populations, infrastructure, and activities necessary to shape security environments, obtain 100 percent situational awareness and understanding of the entire border, consolidate gains, and set conditions for achieving Texas Homeland Security plans and goals.

The Unit's Interior Division primary responsibility:

a) Target (Find, Fix, Finish, Exploit, Analyze, and Disseminate – F3EAD) Investigate, disrupt, dismantle and defeat the Hybrid Threats emanating from the border (The Mexican cartels and their adversarial networks) that threaten and/or seek to exploit the laws of Texas.

The officers will need more powers and duties than State Peace Officers, otherwise the officers will not be able counter and defeat the national security threats at our border and in every region of Texas due to legal restrictions

Zaena Zamora Self McAllen, TX

I oppose HB 20 as it is both legally flawed and morally reprehensible.

The proposed Border Protection Unit is unconstitutional because the state government does not have the authority to set and enforce foreign policy, particularly when it comes to the enforcement of federal immigration law according to Article I, Section 8, Clause 18 of the Constitution.

The proposed authority of the Border Protection Unit Chief is especially concerning in that the position would have sweeping appointment, hiring, and firing authority with little oversight outside the commission mentioned later in the bill. Furthermore, giving officers the power to arrest in any Texas county raises concerns of racial profiling and over-policing and can lead to suppression of reporting of crime as community members come to fear local law enforcement as a result of over-policing and strict enforcement of immigration laws. I believe it is a violation of human dignity to allow civilians with little or no understanding of federal immigration laws and little to no training in working with asylum seekers to police Texas communities with limited oversight. Giving the Border Protection Unit the power to "within the State of Texas…arrest, detain, and deter" immigrants in "any county" of the State who are suspected of illegally entering Texas would enable extremist individuals and groups to abuse and harass anyone based on personal prejudices.

The minimum law enforcement training and licensure requirements would not be sufficient for a unit like this to be entrusted with highly sensitive work, and this bill proposes almost no qualifications and certainly less than minimum law enforcement standards. Immunity for officers against criminal and civil liability would exempt an entire class of law enforcement from any consequences and enable the members of this unit to abuse Texans. The existing border operations have violated the rights of numerous people, as reflected in numerous formal complaints and lawsuits. This immunity will mean that our civil and constitutional rights will be denied without remedy.

Finally, the construction of the border wall would be an extremely expensive project that would only waste taxpayer money that could instead be allocated to more pressing matters such as investing in community infrastructure like public schools, mental health, access to healthcare, affordable housing, etc. that would address the root causes of crime long term. Denni Arjona, Co-founder South Texans for Reproductive Justice McAllen, TX

My name is Denni Arjona, my pronouns are they/them, I am a lifelong resident of the Rio Grande Valley and I have traveled 5 hours from the border to express my opposition to HB20 today on behalf of my organization, South Texans for Reproductive Justice.

HB20 is a racist policy that robs vulnerable people of their humanity and invites further racially motivated violence to border communities. Through my work with STRJ, past experiences as a public school case manager in rural communities and as a citizen with brown skin, I can tell you that further militarization sparks fear among us.

Our communities are littered with DPS troopers, border patrol agents and surveillance technology. This constant presence near schools, neighborhoods and basically anywhere makes people afraid to leave their homes, go to work, take their children to school or even seek medical care.

HB20 also sets a dangerous precedent for abuse of power by granting immunity from civil liability to those deputized to arrest anyone they suspect of being a migrant. If the fear exists with agents of the state, I have no doubt this will skyrocket with extremists who intend to rush to police the border.

Our work with STRJ also extends beyond South Texas. In December of 2022, STRJ partnered with Solidarity Engineering, National Latina Institute for Reproductive Justice and Yellowhammer Fund to provide children's gloves, hygienic items and toys to 400 children and hand warmers to 700 people at tent encampments in Reynosa, Mexico.

It wasn't until then that I fully understood the magnitude of the humanitarian crisis our border policies have cruelly exacerbated. Though we served 700 people at Camp Rio and Camp Senda De Vida II, I went home with a heavy heart knowing families were bracing themselves for the incoming freeze at the time with no shelter at all.

I had to remind myself that there is only so much a volunteer run organization can provide, but what blew me away was the realization that it is in fact numerous small grassroots organizations and community members rising to bring clean water, medical care and basic needs, while our government continues to enact policies that couldn't be further from humane.

Camp Rio is one of the largest camps in Reynosa and it only exists because one kind man opened his property up to people who had no other place to go - families who are still vulnerable to common kidnappings and cartel violence.

You have the power to make a difference. Doubling down on policies to deny people their right to seek asylum, turn neighbors against one another and increasing trespass penalties to felony charges, is a cruel measure to take against people who are desperate to seek safety. I urge you to vote NO on HB20 and work with our communities to establish meaningful solutions. Thank you.

Kassandra Gonzalez, Ms. Texas Civil Rights Project Austin, TX

Over the last few years, I have been working at the Texas Civil Rights Project to protect the rights of asylum seekers. I have worked with countless legal service providers and humanitarian organizations that have witnessed how programs like CBP One and Operation Lone Star have harmed asylum seekers and effectively denied them their right to seek refuge. I have also conducted intakes with asylum seekers that were detained or awaiting their chance to cross from dangerous parts of Mexico. These people are vulnerable, and they are also a value add to our communities. They are mothers and fathers trying to keep their children safe—often forced to make difficult, impossible choices. Asylum seekers arrive in the U.S. to legally access our immigration system, and so, our State should aim to welcome them with dignity, not further traumatize them with border militarization and bills like HB 20.

HB 20 would create a dangerous vigilante presence in Texas for asylum seekers.

HB 20 proposes establishing a Border Protection Unit, composed of deputized vigilante forces that would endanger asylum seekers and increase the risk of violence against them. HB 20 yet again creates a task force to target asylum seekers who are, mainly, vulnerable people of color. The creation of agencies to target people of color in Texas is nothing novel.

As OLS has been implemented over the last two years, TCRP has witnessed how militia groups and citizen vigilantes have operated—intimidating unarmed asylum seekers and making immigration decisions without any training or oversight. HB 20 specifically insulates these vigilantes from any sort of civil or criminal liability, essentially giving them broad, unchecked power and free reign.

Militia groups like Patriots for America patrol with firearms and spread false narratives of how "really bad people" are coming across. In fact, the concerning collaboration of militia groups and citizen vigilantes with local sheriffs along the border led TCRP to file a complaint with the U.S. Department of Justice. One thing is clear: there is a propensity for violence and escalation when armed vigilantes, many of whom buy into anti-immigrant sentiment, are patrolling and apprehending people, sometimes unaccompanied children.

A deputized vigilante force is not who is needed for vulnerable, traumatized asylum seekers.

HB 20 codifies Title 42 and perpetuates anti-immigrant, racist sentiment.

In addition, TCRP has concerns about the harrowing impact of HB 20's codification of Title 42. Texas seeks to rely on the guise of health concerns to perpetuate anti-immigrant sentiment and the xenophobic falsehood that migrants carry disease. On the contrary, evidence suggests immigrants are not the main threat to public health or COVID-19. Rather, Americans played a dangerous role in the spread of COVID-19 across the U.S.

Zachary Shell Self (customer service worker) Austin, TX

To the Committee -

My name is Zachary Shell and I've lived in Texas my entire life. I stand in staunch opposition to HB 20, which I believe is a massive and deadly expansion of state power that would not make Texas any safer but would put immigrants and Texan border communities at risk of facing police violence and racially motivated legal and physical harm with no way to seek repercussions.

I feel the increase in penalties for trespassing and border crossing that HB 20 represents would do nothing to deter migrants from entering the border - if people are fleeing from persecution, poverty, or other threats to their lives, they will often have no choice but to risk being prosecuted for illegal entry. The harsher punishments will only serve to ensure that our prisons are more overcrowded and will greatly increase the incidence of human rights abuses relating to detainment, deportation, and use of physical force and restraint against immigrants. Any policy this sweeping and hardline is designed to harm the common people, not prevent drugs from crossing the border, I cannot support the endangerment of people's safety and their individual liberties, regardless of their citizenship status.

The border protection unit created by HB 20 is also of significant concern to me: cultivating an army to station along the border would only create more violence and unrest, and given the alarming immunity from civil or criminal liability given to border officers under this act, it is clear this act intends to stoke said unrest and at least condone, if not outright encourage, the usage of serious violence against migrants. It also opens the door for civilians and private entities to act with legal impunity as border patrol agents, which would massively increase racial discrimination in the justice system and allow hate groups to target anyone they suspected - or said they suspected - of being illegal with violence authorized by the state. My name is Sarah Cruz, and I am here on behalf of the National Network for Immigrant and Refugee Rights. Thank you to the Committee for the opportunity to provide testimony. The National Network (NNIRR) is a center for human rights education and advocacy, working to defend and expand the rights of all immigrants and refugees, regardless of status.

I am here on behalf of the Network to oppose HB 20. This bill would massively expand the border militarization and immigration enforcement complex currently carried out by both the federal and state governments, compound the injustices that Black, Brown, immigrant, and border communities have experienced historically, and are a complete disregard for the real human needs and human rights of communities across Texas.

The proposal of a new Border Protection unit would deputize regular citizens and direct law enforcement officers to participate in state immigration enforcement operations; and would disproportionately harm Black and Brown Texans who are often the target of racial bias embedded in immigration enforcement. After the launch of Operation Lone Star, DPS data from 2021 showed that "racial profiling is a significant contributor to disparities in DPS traffic stops between Latino and white drivers."

HB 20 also proposes that Unit officers would also be granted "immunity from criminal and civil liability." This raises critical concerns about oversight and accountability, and creates an environment permissible for grave human rights and civil rights violations. Let us remind you, the border is not a zone for constitutional exception. Since 2010, there have been over 265 fatal encounters between citizens and border residents with U.S. CBP agents. Similarly, since the start of OLS, vehicle pursuits involving DPS troopers carrying out its operations have been linked to 30 deaths and 71 injuries.

Moreover, these punitive measures contradict U.S. asylum law, and will undoubtedly stem the crisis of deaths and disappearances in the borderlands, which are frequently the result of hardened immigration and border policies. Official CBP data count 8618 migrant deaths through 2021. Community organizations and forensic teams estimate this number to be three times larger. How many people have to die in the borderlands for you to realize that deterrence policies are not the solution? There has to be a focus on working with the federal government to create rights-centered pathways for safe, regular, and orderly migration.

The billions of taxpayer dollars used to target, criminalize, and incarcerate our communities would be better spent to address their real needs. Human rights should not be optional or contingent upon race, class, ethnicity, or immigration status. We urge you to stop the increase of border militarization and enforcement, save lives, and use funds and the implementation of policies to empower Texas communities, not harm them.

Article I, Section 10, Clause 3 would represent a paradigm shift in our state's efforts to secure our border. The provisions outlined in statute in this bill will shift state resources from a catch-and-release posture with respect to law enforcement to actually intercepting and turning away illegal crossings as they occur. The Governor has this power right now, but this bill creates a structure and means by which these powers could be carried out.

Texas is currently under an unprecedented invasion, organized and carried out by narcoterrorist cartels, to the tune of up to 10 million people in just two years of the Biden administration, including unknown gotaways. We have no chance but to use all of the constitutional and statutory tools at our disposal to combat this.

HB 20 would facilitate a declaration of invasion and/or imminent danger under Article I, Section 10, Clause 3. Our organization suggested several changes in the language of the original draft of the bill, and the current committee substitute substantially addresses these concerns. What we have in front of us is the best option the state of Texas has to secure its border in light of the dereliction of duty of the federal government.

I ask that you please expeditiously pass HB 20 out of committee and recommend it for swift passage.

Texans deserve protection! The ongoing lack of security along our southern border represents an existential crisis for the national security, health, public safety, community well-being, and civic peace of the people of Texas. Legislation is needed to equip the governor with support to take actions necessary to defend Texas and her citizens from the ongoing threat emanating from the dereliction of federal duty.

In view of the more than 2.4 million illegal alien apprehensions in FY2022 as well as the estimated 1 million plus so-called "got aways," it is clear that states cannot rely on federal authorities to uphold existing statutory law or their respective Article IV constitutional guarantee to defend the states from invasion.

The state of Texas has no recourse but to utilize its inherent right to self-defense to secure its territorial integrity and protect its citizens from the ongoing destruction, crime, lawlessness, and chaos perpetuated by an open and unsecured border, pursuant to art. 4 sec. 7 of the Texas Constitution and art. Removal for those seen crossing illegally (outside a legal port of entry) or found in the vicinity of same is specified as a part of the "repel" authority.

3) Transparency and cost/benefit reporting requirements are strong and essential.

4) Carefully identifies those considered to be law enforcement and expected to uphold this law. Such a comprehensive listing is key to enforcement as it leaves no question as to jurisdiction.

5) Bill language related to Health and Safety in terms of disease spread is important because this establishes another constitutional way for TX to act independently; individual states have primary health and safety power under the US Constitution and judicial precedent supports this power.

6) Severability clauses repeated throughout the bill are extremely important to withstand judiciary interference. A judge will be unable to halt the entire effort due to the bill's severability provisions that keep remaining portions of the law in force should a court declare one or more of the law's provisions unconstitutional, void, or unenforceable.

7) Clearly invokes Art. 1 Sec. 10 as the US Constitution's authority for TX to declare its reservation of power to act independently to protect Texans, bypassing US v Arizona (federal preemption of immigration enforcement).

Please quickly pass CSHB 20 out of committee.

Current rates of crossing at the border do not qualify as an "invasion" and the state risks stepping out of the bounds of the U.S. Constitution with the efforts outlined in this bill. The state has an obligation to honor international treaties and agreements and is not equipped to fairly address matters of complex asylum claims without risk of discrimination and disregard of federal and international law. I am extremely concerned by the bill's provision to create a "Border Protection Unit," which could include existing law enforcement officers and "law-abiding citizens" to "arrest, detain, and deter individuals crossing the border illegally, including with the use of non-deadly force." Even more worrisome is that these individuals acting under the unit's authority would be granted immunity from criminal and civil liability for their actions.

I have been to two cities on the Texas border as part of a volunteer trip and experienced no "invasion." Instead, I found that what is really needed at the border is better collaboration between the state and NGOs/non-profit organizations trying to assist immigrants in an orderly fashion as we await Congress to take action.
