They are a Texas community. They believe in the second amendment. I'm sure many have guns or maybe left their rifle in the bed of their truck back in high school, too. But they also know that unless we do something, their reality - the reality of empty beds and empty car booster seats, lost laughter - the kind that carries pure joy - and lost hopes and dreams - this loss will be held by more families. They know, just as I do, and believe those of you at this hearing do, too, that we must start to pass and implement legislation to prevent this kind of senseless loss. HB 2744 is a start. The post said they were potentially hiding in the neighborhood, as many children ran from the school once they got out. I kept refreshing the post. I watched families and friends of the family notify the public that these children were dead - live. My heart shattered.

As more information has been released, one thing has been clear: we had uniform regulations for each of the things we KNOW to be a major threat to young people, 21 people would not have been murdered in that school.

You took cigarettes away from my class because they cause cancer. You gave us the opportunity to avoid a horrific, slow death.

Please give the next generation the opportunity to avoid death as you did mine.

I support the 2nd Amendment, but should I ever have children, I have no intention of raising them in a state that thinks my child should die to support their right to own a firearm. As a state, we have failed the families of the victims who lost their lives in the most horrific way possible. My name is Isha Archer, and I live in Houston. It is deeply unnerving to live in a large city, where large public gatherings are the norm, knowing these semiautomatic rifles are in circulation. Weapons such as these demand a higher level of responsibility on the part of the gun owner, and young adults - documented to commit murder at a higher rate than any other group - do not meet that threshold. I hear a lot of about gun rights, but what about gun responsibility?

I urge you to support HB2744. Please consider what the current law permits. What societal problem is solved by allowing young adults access to these powerful and dangerous assault weapons capable of murdering dozens of people in mere minutes or leaving victims unrecognizable and often unable to be saved? What problem has a constituent come to you with and you thought "well it's a good thing 18-20 year olds can access semiautomatic assault rifles, that's the perfect solution to that problem"? What data supports that as the best solution to anything?

I am Nikki Berry writing in support of HB 2744. I am writing for myself, but in honor of and fear for my disabled twin grand-babies. They have Type 1 Spinal Muscle Atrophy, the most severe, genetic, rare form of Muscular Dystrophy. Gray and Adelaide turned 5 in January, which in itself is a major miracle. The life expectancy for these children is less than 2 years, some very much less. Many die after birth before they ever get diagnosed.

And even though it's a fatal diagnosis, Adelaide can't get Medicaid. Her brother did after spending over 3 months in Dell ICU, almost dying multiple times. He came home with a hole in his throat and one is his gut. That's the only reason he qualified, with the same fatal diagnosis. Same parents, same jobs, same money. There will never be enough money for all these kids' nee ds.

I wish I could be there to testify with their pictures, they are so precious. That was my plan, but I'm not well enough now. Our children were luckily born after the first real treatments and gene therapy were developed, or they would be dead now in most circumstances.

In this moment, I'm thinking back over all the children and adults who've been slaughtered, in just the last month, by these rifles and other guns. I think about the profound grief of their families and circles of influence.

In this moment, I'm visualizing my grand-babies, so excited to be in kindergarten next August. Sitting in their wheelchairs in their cutest clothes, in front of the class. They are incredibly excited and very smart. Having been so sheltered their entire lives due to their conditions, and Covid. They've never even had a birthday party with other children. And NOW, they'll have friends, real friends. Socialization with their peers. They can hardly wait!

In this moment, I'm horrified at the thought. I can see the maniac blasting away into their classroom, obliterating every five or six year old there. Mine will be first. Who will protect MY kids in wheelchairs? Who will protect any disabled kids who will be sitting ducks?

In this moment, as an RN, my heart is racing, and I can not visualize the sickening carnage. All those kids who will need DNA for identification because their bodies are scattered all over the room. But my precious grand-babies, the only ones I will ever have, won't need DNA. Half of their bodies will still be strapped into those wheelchairs.
