I wish to speak in favor of a digital currency backed by gold, as a Texas option, which is separate from the Central Bank Digital Currency that is being touted by the Federal Government via EO 49067. That currency will tie people to the ESG - which Ken Paxton has already been successful in kicking Blackrock out of our state due to the ESG investments. This stands in opposition to the US Constitution, which states that we use gold and silver. I do understand that previous administrations removed us from the gold standard, and I very much support getting back to the gold standard, and getting back to State's rights having sovereignty over the federal government. The approved method of using the CBDC is to insert a chip into our hand. We will lose all anonymity if this happens. It is not only a flagrant violation of the Constitution, but a violation of our human rights. The Texas Constitution currently states: The Constitution of the Republic of Texas gave Congress the "power to coin money, regulate the value thereof and of foreign coins" and provided that "nothing but gold and silver coins shall be made a lawful tender." Congress provided that the standard value of gold and silver coins should be the same as in the United States, but no coins were ever minted by, or for, the republic. This bill, if passed, would give our state the power to coin money, using Article I, Section 10, the Supreme Court case called Briscoe versus Bank of Kentucky. The Supreme Court said it was legal for states to coin money. Also, the federal government does not have the power to take gold from a sovereign state. I ask that you keep our state sovereign, and that you pass this bill.

Article 1 Section 10 of the US Constitution says, "No State shall...make any Thing but gold and silver Coin a Tender in Payment of Debts;" Based on this Texas already has the right to create this form of Tender and should utilize this provision.

Using the existing Texas Bullion Depository, existing law, and HB 4903, Texas can make gold transactional. I am not aware of any way to own transactional gold domestically.
