The idea that cross dressing and trans people are inherently sexual and groom children is a lie created to incite hate towards people like me and my community and I'm already seeing the results of it. I'm being bullied by extremist conservatives, who often know nothing about trans people. For example, I'm a proud non-binary person. I have always felt different as a kid even though I never knew how to put the words to it. I often felt insecure presenting as a girl. I didn't fit in. I felt clumsy and uncomfortable. But while I often envied the boys, being one of them didn't seem right, either.

At the age of 22 I finally started embracing my identity as non-binary and I socially transitioned. For me, this included changing my pronouns, keeping my hair short, not wearing makeup, growing out my body hair, and dressing in whatever feels comfortable rather than trying to look at feminine and curvy as possible. I have never felt more confident in my skin! When I look in the mirror, I see me, not a picture of someone trying to be me. I also feel more comfortable in my role when interacting with people of different genders socially. I don't need to fit in with all the girls and I can act like a bro with the boys. I don't feel embarrassed anymore. I love who I am.

But being trans isn't all that I am. I love the beach! The squishy sand, the bubbles left over after the waves draw back, the wind slapping my face... that is pure happiness. I love poetry. I write to cope with difficult times but also to express my love towards my friends and crushes. And I always try to be there for my friends. I enjoy celebrating the good times with them while also helping them through hard times. Several of my trans friends have been abused or rejected by their families due to their gender identity. I do everything I can to help them get through these difficult and painful situations. And finally, I love my job. I work customer service and nothing makes me happier at work than making my customers and my coworkers smile or laugh. My job may seem unimportant to many, but I believe it still gives me a chance to make a difference in people's lives.

My existence is not a mere sexualized folly. I'm a person just like you are, and just like any other queer person. We deserve to express ourselves artistically just the same as anyone else.

My name is Quynh-Huong Nguyen, I am the Senior Communications Associate for Woori Juntos.

I am writing to express my strong opposition to SB 12 by Senator Hughes, which seeks to restrict certain sexually oriented performances on public property, on the premises of a commercial enterprise, or in the presence of a child. This bill is harmful, discriminatory, and undermines the rights and dignity of sex workers and other marginalized communities.

Firstly, this bill would disproportionately impact sex workers, who are already marginalized and vulnerable due to stigma, discrimination, and lack of legal protection. Research has shown that criminalization of sex work increases violence, exploitation, and discrimination against sex workers, particularly those who are trans, non-binary, and people of color (Plummer et al., 2018). By limiting their ability to perform and express themselves, this bill would further marginalize and stigmatize them, and could push them into unsafe working conditions, which could increase the risk of exploitation and violence.

Secondly, this bill would also harm LGBTQ+ individuals, particularly young people, who may be struggling to come to terms with their sexuality and gender identity. By limiting their access to public spaces and events where they can express themselves, this bill could exacerbate feelings of isolation and shame, and ultimately harm their mental health and wellbeing. Research has shown that LGBTQ+ youth face higher rates of mental health issues, suicide, and homelessness, due to stigma and discrimination (Marshall et al., 2011).

Thirdly, this bill reinforces the criminalization of marginalized communities, particularly communities of color, who are already disproportionately impacted by the criminal justice system. Research shows that Black, Indigenous, and people of color are more likely to be arrested, convicted, and incarcerated for sex work-related offenses, despite evidence that criminalization does not reduce harm, but rather exacerbates it (Murray et al., 2020; Brewer et al., 2018). By creating a criminal offense for certain types of sexually oriented performances, this bill could result in increased policing, surveillance, and incarceration, further entrenching the systemic racism and oppression that underpins the criminal justice system.

Finally, this bill reflects the harmful and misguided approach of the criminal justice system, which relies on punishment and control rather than healing and transformation. Research has shown that criminalization of marginalized communities, such as sex workers and LGBTQ+ individuals, is ineffective in reducing harm and instead perpetuates systemic oppression and violence (Fergusson et al., 2017). We need solutions that address the root causes of harm, such as poverty, racism, and patriarchy, rather than punish the symptoms.

Therefore, I urge you to reject SB 12 and instead support policies that respect the agency, autonomy, and diversity of all people.

Even if it violates existing law, is unconstitutional, or causes harm.

SB 12's Analysis defines the non-existent moral panic:

"A recent cultural trend has been for drag shows to be performed in venues generally accessible to the public, including children. These shows often contain sexually explicit performances and music."

The panic's justification is a lie. Drag events, like reading books to children, clearly do not contain "sexually explicit performances and music."

You know this. The lie creates disgust and fear.

A solution must be quickly enacted to 'protect the children.'

That solution is found in SB 12, with an amendment to the Penal Code: T9, C43, ScB. The amendment, Sec 43.28 (p3 L9 - P4 L16), targets all drag events where children could be present with a creative, non-vetted, definition of a "Sexually oriented performance."

(2) (a) (ii) "a male performer exhibiting as a female, or a female performer exhibiting as a male, who uses clothing, makeup, or other similar physical markers and who sings, lip syncs, dances, or otherwise performs before an audience."

There is nothing concerning anything sexual.

SB 12 contradicts/violates existing Texas law.

1) in Penal Code T9, C43, ScB: Obscenity. It contravenes the following definitions (Sec 43.21):

(a) (1) "Obscene" means material or a performance that: (A) the average person, applying contemporary community standards, would find that taken as a whole appeals to the prurient interest in sex.

(a) (3) "Performance" means a play, motion picture, dance, or other exhibition performed before an audience.

(a) (4) "Patently offensive" means so offensive on its face as to affront current community standards of decency.

2) Allows the state to dictate what the Family Code holds parents responsible for (T1, StB, C151). This places all parents in jeopardy of breaking the FC's superseding law.

The Senate public hearing for SB 12 was telling.

Support: 22 (8 from Christian faith groups, 2 Republican Party of TX, and 12 self).

Opposed: 964 (38 representing multiple organizations and 926 self).

Religious groups supporting SB 12 are far-right, working to impose their version of Christianity upon everyone, and remove any civil rights that prevent this.

Opposing SB 12 are civil rights organizations, including ACLU TX, Equality Alliance, and Human Rights Campaign.

964 opposing this bill clearly defines "current community standard of decency." Drag events are decent.

SB 12 is an attempt to impose an extreme, right-wing Christian view on all of us. This is truly obscene.

That such obscenity could be placed into the Penal Code mostly dealing with child sexual exploitation disgusts me.

Thank you for the opportunity to share our comments on SB 12. We oppose this bill and urge you to vote against its passage. The purpose of SB 12, as identified by the author, is to prevent minors from attending drag performances. While the language specific to drag performances has been removed, the original intent remains. The proposed language is overly broad in at least two sections.

First, SB 12 doesn't define 'prurient interest,' which would allow for wide latitude by individual prosecutors, leading to inconsistent enforcement. The vague language could lead many businesses, including their insurers, to err on the side of caution and greatly diminish drag performances in Texas. Second, the language specifying "public property at a time, in a place, and in a manner that could reasonably be expected to be viewed by a child" is again so broad as to have a chilling effect on public celebrations for Pride Month, including Pride parades.

Courts, including the United States Supreme Court, have repeatedly defined obscenity. Courts have consistently ruled that to be considered obscene; art must lack serious literary, artistic, political, or scientific value. SB 12 proposes to supplant the wisdom of courts with a poorly defined standard both unnecessary and potentially unenforceable. Drag performances are integral to artistic expression in the LGBTQ community and communities in general. They are expressions of joy and artistry. Drag performances belong in Texas.

Everyone has a vested interest, and indeed a duty, to protect the well-being of children. However, this bill is redundant in any protections for children and aims to solve a problem that does not exist. SB 12 implies that LGBTQ people are not safe for children, a dangerous, false, and deeply hurtful message. This legislation is unconstitutional, overly broad, and deeply harmful to a community disproportionately targeted by violent actions of people opposed to the very existence of LGBTQ people Texas.

The bill is vague. While all can debate whether the the bill is targeted enough to only prohibit performances which appeal to the prurient interest in sex, the problem is that where there are varying interpretations of that language, a mere allegation that a certain performance is prohibited can ruin someone's life. While a court may ultimately rule in the performer's favor, one cannot underestimate the costs of litigation. Unless the state is also required to pay those costs, the performer may be financially ruined. I have personal knowledge of a person accused of a crime, prosecuted with no real evidence. The prosecutor stated he had to pursue the charge "for political reasons." The defendant had to wipe out his 401(k) to defend the charge. I attended trial. When asked to put on a defense, the defense rested and presented no evidence. The court dismissed the charge for lack of evidence of a crime. Nor can one underestimate the cost to reputation and damage to employment prospects when a criminal charge is pending, and the story is disseminated on the local news.

Putting aside whether drag is a crime, one cannot debate that it is art, protected by the First Amendment. Texas taxpayers should not have to fund litigation defending a vague statute that is clearly unconstitutional. Nor should a clearly unconstitutional statute be proposed to appease certain voters or legislators. Legislators have an ethical obligation to do their sworn duty to uphold the Constitution.

Greetings, I am the Texas Director for MassResistance. I have led several investigations into drag queen entertainment for children. My conclusion from those investigations is that drag entertainment should not be marketed to children. Even if the event is "kid-friendly" the entertainers use their drag names and have sometimes provided their social media handles to children. Drag culture is full of kink, erotica, prostitution, fetishism, vulgarity and profanity. We don't market this type of content to children in any other arena and we should make no exception here. The drag entertainment industry is closely tied to the burlesque entertainment industry with entertainers performing at the same clubs and shows. We wouldn't promote burlesque to kids and similarly we should not promote drag to kids. We also do not promote adult homosexual club life to kids. Many of these performances have taken place in homosexual clubs complete with elixirs for kids. It is unacceptable to be creating a kid-friendly gay bar scene where children are accompanied by adults for the adult nightlife experience or a rainbow and glitter-filled version complete with sugar to accomplish child sexual grooming. My contention that drag queens are not role models and should not be entertainment for kids is girthed by the findings in our reports that many are prostitutes and some are even sex offenders. Background checks are routinely not done.

I've yet to hear a convincing definition of "prurient interest", and I'm concerned that if made into law, the vague language in this bill could still be used to target performers on the basis of gender expression. This bill could even be used to target cheerleaders, or anyone who experiences a wardrobe malfunction. We need to trust parents to make decisions about what performances are appropriate for their children, not give broad leeway to law enforcement to slap criminal charges on performers.

Finally, since there's no guarantee that the final version of this bill will omit language specifically targeting drag, I hope the committee will pay due attention to testimony from drag performers who want to perform their art in peace. Like any art form, some drag performances are completely appropriate for children and others aren't. Children are already barred from attending sexually explicit performances at bars, while there's nothing inherently sexual about drag queen story hour at libraries. Others have said it better, so I'll keep my comments here short.

More than anything, I want to stress that voting for this bill, even watered down as the committee sub is, could still put drag performers and trans people at risk given that this bill is so different from the version that passed through the Senate. I'm concerned that the Senate will push for the re-inclusion of explicit anti-drag language, passed the point where public comment is accepted. For this reason, I beg you to not take chances with our lives and livelihoods, and vote against this bill. If you truly agree with us that targeting drag performers specifically is unconstitutional, then the committee sub isn't good enough - we must stop this bill entirely.

My name is Tory Morris and I oppose SB 12.

I was raised how I think many conservative voters and members of this legislature would want children to be raised. We went to church every week; my parents, my sister, and I volunteered in various ministries during the first service and attended the second service as a family. Folks advocating against this bill have received death threats, and drag performers are afraid to walk alone to their cars after gigs. Groups who testify in favor of this bill claiming to advocate for family values doctor photos of drag performers to appear as if they're performing in front of lewd signs or in front of children -- these photos are often from shows I personally attended and where absolutely zero minors were present. Our opposition has to create fake evidence to advance their cause because they know they don't have a valid argument. To quote drag performer Jinx Monsoon, “Drag is an art form that was born in the LGBTQIA+ community. So if you don’t take time to get to know that community, of course aspects of drag are not going to make sense to you.

“But we don’t have to understand everything to know that it should be allowed to exist. You know, I don’t understand every cultural aspect of every culture different from my own, but nothing about me wants to tell people to stop doing it, because that’s just people living their lives and being truthful to who they are.

“Why do we think we need to govern what other people do with their lives if it has no effect on our own?”

The committee substitute introduced today, on May 10, 2023, establishes an acceptable compromise compared to the bill's original language. I am therefore neutral on CSSB 12.

Originally, I believed the intent of this bill was to have a chilling effect on drag as an art form and profession, and to further cement the association between drag performers and the false accusation that they are harming children. I also believed that the intent of this bill was to make trans people afraid of going out into public. The final section of this bill about public performances in combination with the removed section regarding men dressed as women and women dressed as men would have been weaponized against trans people going about their day-to-day lives, as there are people who believe that the very existence of a trans person appeals to the prurient interest.

I am a trans person and a performer. I was born a woman, but see myself as a man. While some would see how I dress and think it is cross-dressing, I am not performing drag. How I dress is not a performance, and, when I perform, how I dress is not the subject nor focus of my performance, because I am trans, not a drag artist. My existence is not inherently sexual. I do not dress how I do to appeal to a prurient interest. Frankly, how I dress now is far more conservative as a trans man than it ever was as a woman. I dress as I do because it is what is most comfortable for me and how I dress is the way I dress all the time. I deserve to be able to go out in public -- to be able to go to the grocery store, the bookstore, the park, the library -- without the fear of being charged for a crime based on nothing other than how I dress when my dress would be perfectly acceptable for someone male to wear in public.

Ensuring that the committee substitute is incorporated into the final bill would do a lot to allay the anxieties that queer and trans Texans have about this bill. So, if this bill is to go forward, I am hoping that this version of the bill sticks.

I support SB 12 and I thank Senator Hughes for authoring it.

I agree with how the bill analysis describes the need for this bill:

"A recent cultural trend has been for drag shows to be performed in venues generally accessible to the public, including children. These shows often contain sexually explicit performances and music.

Texas is just one of over a dozen states considering legislation to stop such performances in front of children. These states have taken different approaches to the issue. Some would include these events in the definition of a sexually oriented business. Some would define these events as one of several types of "adult cabaret performances" that appeal to the prurient interest. Others define a "drag show" specifically.

S.B. 12 integrates aspects of these different proposals. The bill amends Chapter 43 of the Penal Code to define a "sexually oriented performance" as one (1) featuring nudity; (2) or a male performer exhibiting as a female or a female performer exhibiting as a male; and (3) appealing to the prurient interest in sex. The bill goes on to address sexually oriented performances in two types of settings: (1) on public property; and (2) in commercial establishments. In both settings, the goal is to protect children from seeing these performances.

Municipalities are authorized to regulate sexually oriented performances to promote the public health, safety, or welfare of their communities. S.B. 12 says explicitly that a municipality may not authorize a sexually oriented performance on public property or in the presence of a child. The bill is not intended to stop theatrical or other similar exhibitions. Municipalities are authorized to regulate such shows as they see fit.

While drag shows have received the most media attention, S.B. 12 is not limited to this type of sexually oriented performance. Drag shows today may be replaced by other types of harmful performances in the future. S.B. 12 applies to and will protect children from sexually oriented performances in general."
