In 2020, as the world was falling apart, my husband was deployed to Afghanistan. I begin baking as a way to pass the time and to learn to decorate cookies. I begin to make cookies for friends, coworkers, family events, and then strangers begin to reach out to me. I followed all the rules to become a cottage baker, but in my full-time life I was scared to death to go to work.

My husband returned the summer of 2021, and as we transitioned into him being home we planned a vacation. The week before we were to leave, I was mandatorily floated to the Covid unit. They were rotating the responsibility to all staff from what were deemed nonessential departments. Five days later I got Covid. Two months later, I began to search for ways to get out of the medical field and then we decided to move from the city to a small town.

It's difficult to start over. To be in a place where you have no family except each other and it's an 8 hour drive to see anyone else. I went back to work as a nurse but continued baking at home as a means to cope. I really had no life outside the walls of my home, other than going to work.

So many small businesses were closed because of the pandemic and people were trying to find ways to work from home. And the businesses that were thriving couldn't get workers. In so many ways, people were still afraid. Afraid to congregate, afraid to leave their homes. Homeschooling children is on the rise.

Then in the last year, there's finally been a move to more normalcy. They stopped requiring masks in large hospitals, and in public events, and the vendor markets, fiestas, festivals, and community events begin to start up and grow in popularity.

The home-based workers, bakers, crafters, creators, home based healthcare workers, computer programmers, graphic designers, the entrepreneurs tried to start networking publicly, and grow their business from home.

Businesses that pay taxes and move on to open brick and mortar buildings. This is the American dream. Find something you love to do, perfect it, grow your following, and go public. And the cottage bakers, cookie makers, cake decorators, are trying to make a full-time small business out of a side hustle.

The rules and regulations vary from state to state. In some states you can take your baked wares to a coffeehouse, restaurant, or boutique and sell them to the owner to sell to the public. Wholesale purchasing. Some states are allowed to ship their cookies, even if they must only ship within the state.

Texas is a big state. Texas should lead the way in changing the laws. Texas should show its support to the home baker by moving into the future and not stay stuck in the past. The world is ever-changing and we should be leading the way not following. Allow this bill to pass and Texas bakers to sell wholesale. Allow the sell of pies and cheesecakes. Allow shipping. To Whom It May Concern:

My wife, Dana Bryan, and I would like to express our support for SB 829 related to cottage food production operations.

We own and operate a small farm near Seguin, TX and sell our products at the San Marcos Farmer's Market, as well as purchase some of our food there.

With recent problems highlighting the fragility of our nation's (and state's) supply chain, it is important to take steps to strengthen the system and make food more secure. Much of our current system (especially in meats) has a severe bottleneck in the processing section. For example, 80% of all the beef slaughtered in the US is done so by four firms. This puts our meat supply in serious jeopardy.

Chicken processing in Texas is worse. There are currently two USDA processing centers in Texas. One is northeast of Dallas and the other is near Hillsboro. A third center near Lexington closed last year. I have yet to find a state facility and have heard there are none. This adds greatly to our costs and makes our chicken less affordable for the consumer.

When it comes to lamb it's not much better. We have found two facilities in the San Antonio area that are state certified to process lamb for sale. One is in San Antonio and the other in Poth. We will not use the one in San Antonio because we received complaints about the meat that was processed there, so if the processing center in Poth closes or stops taking lamb, we will not be able to sell our product at the farmer's market.

We also train Active Duty Military (Skill-bridge program), military veterans, under-served, and beginning farmers and ranchers in regenerative agriculture for a program called Battleground to Breaking Ground. Since 2015 we have trained over 700 participants. We are a small farm (20 acres) running multiple revenue streams as small farms are required to do in order to survive. While we do livestock, poultry, produce, bees, and agri-tourism, we also do cottage foods. We prefer to have no waste from any of our revenue streams. Therefore, we make a lot of cottage foods such as jellies, jams, pickled products etc. The Cottage Foods provide us the ability to produce up to \$50,000.00 annually from our kitchen. \$50,000.00 is a lot of money to a military veteran or an under-served farmer trying to make ends meet with inflation increasing and supply chains continuing to fail. Cottage foods (AKA foods made in a home kitchen for sale) support local farmers who generate more revenue by supplementing fresh produce sales with prepared products that they can sell year-round at a higher profit margin. The current Cottage Food Law enabled thousands of small businesses to be launched in Texas since its inception however, some of the law's provisions still limit farmers and other entrepreneurs from building a viable business. I write to you as a concerned citizen, keenly invested in public health and safety matters, regarding the recently proposed bill that seeks to allow time and temperature-controlled foods to be sold under the cottage food exemption. While I understand the intent behind this bill to promote local and small businesses, I strongly believe that this legislation could inadvertently jeopardize the public health and safety we are all committed to protecting.

Time and temperature-controlled for safety (TCS) foods are specifically regulated due to their propensity to harbor harmful bacteria and other pathogens if not properly handled. These foods require careful temperature control and other safety measures during storage, preparation, and transport to ensure they are safe to consume.

The cottage food exemption was designed for low-risk foods, which typically do not require refrigeration and have a lower potential for causing foodborne illnesses. By extending this exemption to include TCS foods, we risk compromising the stringent safety measures currently in place.

The cost of managing foodborne disease outbreaks—both in terms of human health and economic impacts—can be significant. It is, therefore, paramount that we prioritize preventative measures, including maintaining robust food safety standards and oversight, to mitigate these risks.

I urge you to consider the potential consequences this bill could have on public health and safety. Instead, I propose that we explore other avenues to support small businesses and local producers, such as increased funding for food safety education or subsidies for necessary safety equipment, which can both encourage entrepreneurship and protect consumers.

Time/temperature controlled foods are regulated for a reason. Texas residents and Texas businesses lose significant amounts of time and money due to foodborne illnesses. Nationally, > 9 million people become ill due to foodborne illness that may lead to hospitalizations or worse (Attribution of Foodborne Illnesses, Hospitalizations, and Deaths to Food Commodities by using Outbreak Data, Emerging Infectious Diseases, Volume 19, Number 3—March 2013). Allowing the sale of cottage foods to be sold in food service establishments and retail food stores eliminates the food safety oversight that local and state public health agencies provide. Are proper food temperatures being monitored? What about proper handwashing? Many of these health and safety hazards can be minimized in commercial kitchens with adequate facilities. The previous changes the bill author made to the bill to address concerns raised by TEHA, such as removing the requirement that the address of production be included on cottage food labels absent some kind of producer database, is appreciated. We remain concerned that the bill would dramatically expand the scope of Texas cottage food laws in a way that jeopardizes public health for all Texas residents.

Other impacts may include but are not limited to: negatively impacting small business owners with razor-thin profits working in a properly outfitted commercial kitchen, foodborne illness tracking by epidemiologists, and residents that become ill and do not have adequate health insurance.

The current cottage food rules previously eliminated food handling oversight. To further reduce food safety protections is a direction that Texas should avoid.

The current DSHS Cottage Food Law explains, "A cottage food production may not sell to customers potentially hazardous foods (PHF). A PHF is a food that requires time and temperature control for safety (TCS) to limit pathogen growth or toxin production." By revising the current guidelines to meet an aspiration rather than a necessity, it creates a bigger problem and higher risk of Foodborne Illnesses throughout the State. This shouldn't be a risk that the State of Texas should want to take, for the reason that homes are not being inspected because there are no TCS foods involved, are low-risk foods, and do not require deliberate monitoring due to the minimal requirements & restrictions set forth by DSHS--that each Cottage Food operator must presently follow. By suggesting that "baked TCS" foods are introduced into cottage food operations, is simply stating or imposing a required food permit and/or inspection by the regulatory authority. At this time, most jurisdictions do not have the work force to enlist this type of additional permitting or inspection; hence one of the supporting reasons why the State cottage food law was originated; to simply act as a guide to operators, rather than to permit or inspect. To include, if we authorize cottage food operators to sell baked TCS foods to retail food establishments, this limits the traceability if they are the actual source of a foodborne illness, as again this would require a permit/inspection with the regulatory authority to execute this sort of police power. Furthermore, this bill negatively encourages cottage food operators to further expand outside of the boundaries of just "baked TCS" foods; that would indefinitely require a food permit, inspection, and additional regulations to be implemented --to reduce the spread of foodborne illnesses. The Centers for Disease Control and Prevention (CDC) suggests that the 5 major risk factors of foodborne illnesses are (1) Food from unsafe sources, (2) Poor personal hygiene and ill food workers, (3) Inadequate cooking temperatures, (4) Improper holding temperatures and cooling procedures, and (5) Cross contamination and contaminated equipment. With the potential expansion of baked TCS foods that includes retail food sales, it dramatically increases the dangers of these five risk factors. We are asking that the Cottage Food Law remain as is, unchanged due to the existing attainment of the program. It is also our hope that you will honor this request.

As a concerned citizen, I do not want food that was made in a house with broken refrigeration, sick children, and animals spreading fur and drool all over the food prep areas to be out on store shelves where I may accidentally buy it because it is next to food that was made in a clean commercial kitchen which was inspected and ran with food safety in mind. Additionally, the labeling requirements in SB 829 do not address the size or location of the warning label on homemade wholesale food items. This could lead to small font sizes being used which could cause a person to buy home-produced food by mistake. Madam Chairwoman and Members of the Committee,

As a cottage food operator, small farmer, and allergy mom, I am extremely thankful for Texas' Cottage Food laws, and would love to see them safely expanded, just as this bill proposes.

While producing and selling cottage foods provided a much-needed supplemental income for our family in the aftermath of Hurricane Harvey, and in the midst of Covid, being a small farmer and Cottage Food Operator is about more than our personal story; it's about being part of the bigger community and part of the local food security chain for our friends and neighbors. We were recently reminded of this by a friend whose cafe is near a medical community where grab-and-go foods are always in demand. During Covid, she, and others, had a hard time finding baked goods to sell. This would have been a perfect opportunity for Cottage Food bakers to step in and fill some gaps. Going forward, we now know that expanding local food options can protect our communities, ensuring we have local food sources readily available, especially during times of supply shortages.

Cottage Food Operators can also be a huge lifeline for allergy families. Families with soy, nut, gluten, dairy, and other allergies often face great challenges finding fresh breads, cookies, pastries, and so forth, especially in small towns. Being an allergy family ourselves, we are compassionate and try hard to make these orders possible for others, but the reality is that sometimes it's just too expensive for us to make only two-three of a particular product. Baking several dozen and arranging to sell the surplus to, or at, small shops would make it possible to meet client demands, even in the smaller orders, without heavily impinging on our profits.

One final comment. Farmers' Markets can be a great option for Cottage Food businesses and customers, but not every operator can leave their farm for the day, especially every week, over several months, and when sales are not guaranteed. Likewise, not all consumer schedules mesh with Farmers' Market schedules. This amendment would essentially bring Farmers' Markets into Mom and Pop shops, enhancing customer accessibility and convenience, increasing profits for both shops and operators, boosting local food security, and building the local economy. That's a home run in the Cottage Food world!

I am writing to urge you to support SB829, a bill that would make important changes to benefit Texas Home Cottage Bakers.

This comprehensive bill includes several key provisions that would promote entrepreneurship and innovation, improve food safety standards, and create new economic opportunities for Texans.

Firstly, SB829 would allow the director or officer of a nonprofit organization to produce cottage foods, eliminating previous uncertainty around whether nonprofit organizations could legally produce and sell these goods.

Fourthly, SB829 would make the home address on cottage food labels optional, replacing it with the name, city, and zip code of the producer, along with contact information for the producer. This change would protect the privacy of cottage food producers while still providing consumers with the information they need to make informed purchasing decisions.

Fifthly, the bill would explicitly prohibit local governments from requiring licenses or permits to sell cottage foods and would prohibit local officials from employing anyone who knowingly violates this provision. This change would eliminate burdensome and unnecessary regulations that can stifle small businesses.

Finally, SB829 would allow the sale of baked goods that require refrigeration, such as custard, pumpkin pie, cheesecake, and cream pies. This change would expand the variety of products that cottage food producers can offer, providing consumers with greater choice and supporting the growth of small businesses.

In conclusion, I strongly urge you to support SB829 and help Texas Home Cottage Bakers thrive. Thank you for your attention to this important matter.

They take their business elsewhere, be it a large store selling unhealthy mass-produced food items or someone who doesn't follow the rules and/or doesn't even have a food handler's registration. Every single time I've turned orders down and explained the current cottage laws, customers have remarked how ridiculous they feel the laws are because it is common sense that refrigerated items be kept refrigerated. Are there people who don't understand how food safety and refrigeration work? Absolutely. However, I refuse to believe that is the majority of the people and voters in Texas. Cottage bakers and the majority of their customers fully understand what to do.

Additionally, this bill allows us an added layer of safety so that we don't have to disclose our address on food labels. Again, cottage bakers are predominantly women. Listing our address on labels allows people to know where we live. We obviously can't screen every person who buys an item from us. They can buy the knowledge of our home address for the cost of a cookie, and we lose our safety if that falls into the wrong hands.

Again, I ask that you pass this bill. Entrust the citizens of this great state to make informed decisions on the food they choose to consume and help protect the cottage bakers by keeping their personal home addresses as they should be, which is private.

Thank you for making cottage food business possible, and for considering these amendments to the cottage food bill. This bill would open many doors for people like me, both as a cottage food operator, and as someone with celiac disease.

Coming from a small town, it is often very difficult to find allergy friendly foods, much less foods that are safe from cross contamination. Right now there is nowhere to get fresh gluten free rolls, donuts, or pastries in our area. So stopping by to get coffee and donuts with friends is not an option. For many small coffee shops, and cafes, it is simply not feasible to have a dedicated space to prepare these foods, but cottage food operators from allergy families already have kitchens that are safe. So as a consumer, it would be amazing if local businesses could carry labeled cottage food products, especially since most of our major stores have stopped offering them, and the few foods you can get are often very expensive, and not as tasty.

From a business standpoint, I have several friends who own local shops who've asked how to supply their customers with gluten free muffins, cookies, cinnamon rolls, etc. While it is not cost effective for me to set up a pop up stand to sell maybe 2-5 muffins in a day, baking in advance gives me the opportunity to deliver products to the owner who can sell them as needed. All of a sudden that becomes a valid option, benefiting the cottage food operator, the business owner, the customers, and the local economy.

Another part of the bill that would be extremely beneficial, is the ability to safely sell time and temperature controlled baked goods, Many states already have this in place, and have seen it pay off for both consumers and cottage food operators. Every year around the holidays I am asked if it is possible to buy gluten free ganache cakes, fruit filled pastries, etc. because those items are slim to none in our area. Being able to sell those items directly to consumers would significantly increase access to those sought-after allergy-free items.

Dear Chair Klick and Members of the House Committee on Public Health:

The Institute for Justice ("IJ") submits these comments in support of SB 829. IJ is a nonprofit, public interest law firm that works to protect civil liberties, including economic liberty. We have helped cottage food producers nationwide reform laws that arbitrarily limit the sale of homemade food. We support this bill because it will reduce needless regulatory barriers to buying and selling locally made food in the state.

Cottage food businesses are a way for entrepreneurs with big dreams but little capital to start small in their own homes without having to spend thousands of dollars on professional equipment and commercial kitchen space. Nearly every state across the country recognizes these businesses as job creators and revenue generators, but the state's regulatory approach is pushing this business model out of reach for many in Texas.

At IJ, we have studied the effects of cottage food businesses on local economies and communities and researched food safety. We have consulted experts, reviewed CDC data and followed up with health departments in states that have expanded their cottage food laws. Our research confirms that cottage food is inherently safe for producers and consumers and that cottage food businesses help stimulate economic growth in their communities.

SB 829 brings much needed reform for the state's cottage food producers. First, the bill raises the state's revenue cap for cottage food producers from \$50,000 to \$100,000. In recent years, many states have raised or lifted revenue caps recognizing it is counterproductive to cap people's income. Today, 31 states and the District of Columbia do not cap producers' sales. This makes sense, as revenue caps were originally intended to limit cottage food producers' volume of sales, but volume is already limited by the size of their kitchen. A low revenue cap undermines the ability of producers to grow their businesses and use their homes as a steppingstone to opening brick-and-mortar stores.

The bill also lifts other unnecessary restrictions on cottage food sales in the state. It allows producers to sell baked goods requiring refrigeration, which will expand the products producers can sell, and it expands the venues where cottage food can be sold. Seven states—California, Iowa, Montana, North Dakota, Oklahoma, Utah and Wyoming—have the broadest cottage food laws in the country. These laws give cottage food producers and consumers the freedom to buy and sell the homemade food of their choice, including perishable food. Many of these laws have been in effect for years, and to date there have been no confirmed cases of foodborne illness related to food sold under these laws. Indeed, Wyoming's law has received national recognition for safely increasing access to local food and opportunity.

Simply, SB 829 is an important way Texas can reform its cottage food law to support economic opportunity and local food.

Please do not pass SB 829. This bill undermines food safety regulations and poses serious risks to foodborne illness from cottage foods.

I worked in local public health food safety programs for 25 years. Food businesses do not intend to make their patrons sick, however foodborne illness continues to affect 1 in 6 people in the US and kills over 3000 each year!

The current cottage food laws allow for a variety of business models while maintaining appropriate safe food limits of home kitchens. My own step daughter has a cottage food business.

Increasing the cap on income for cottage food businesses will tempt businesses to exceed the capacity safe food of their home to provide large quantities of cottage food. The refrigeration units, ovens, and counters in an average home kitchen cannot safely support the increased income cap. This in turn will lead to unpermitted home additions to create space outside of the home kitchen, which is where cottage foods should be made.

I urge you to keep the restriction time/temperature control for safety as currently written in 437.001. Home kitchens are intended to support a family, not support a retail business. Home kitchens are in homes where pets, children, babies, and potentially pests are. These potential sources of contamination, along with limited space for maintaining safe food under temperature control will cause foodborne illness. Cottage foods are sold in areas where constituents are less likely or unable to seek medical care if foods have produced illness.

The limitation to keep time/temperature control for safety foods from being produced in cottage food businesses must be maintained to prevent foodborne illness. The Texas Food Establishment Rules have entire chapters dedicated to the safe handling of time/temperature control for safety foods based on science.

Lastly, the changes to Section 437.0192 must be removed from this bill. This section will further 'muddy the waters' in the regulatory web that public health must follow. This section blurs the line between a food manufacturer that is licensed by Texas DSHS and cottage food when food is changing hands and not sold directly to customers from the cottage food business that manufactures the food. Local food safety staff are already faced with hostile situations at local fairs, markets, and events when working to keep consumers safe yet this rule will add additional stress and confusion to the gray area that is cottage food business.
