Dear Senators,

Can you please consider adding a required "real time" communication tool, between the Clerk, and the Party Chairs for the purpose of Judge and Clerk allocation (HB 4030 is supportive of party chairs assigning the Judges directly to the locations but has yet to be heard), and can you please lower the population threshold from 3.5 million to 800,000.

Currently the County Chair hands over the list of Judges and Clerks to the Election Administrator or County Clerk and then the EA/Clerk actually allocates the assignments. Unfortunately in Fort Bend County the allocation has been given to a worker within the Elections office who assigns the Judge and clerk positions, without properly allocating the Judges and clerks according to the TEC code. The allocation is not Bipartisan, and also not from the approved lists provided by the Chair.

Our local GOP Elections team has battled this via email chain (so it is well documented) and in person, trying to make sure the EA office follows the law and assigns the poll locations appropriately. This battle starts over every single election, and there is no re-course for mis-allocation. In this current election for school boards, the EA has assigned 7 Republican Judges and 18 Democrat Judges during early voting. Because there is not bi-partisan representation of Judges or Clerks it gives the citizens the impression that the elections are already tainted, and it ends up disenfranchising the conservative vote.

Possible wording for Required communication with County Chairs:

(a) The County election officer/clerk shall communicate with each political party county chair or their designated election team utilizing a online, secure, restricted access communications platform to identify the assignment of all judges and clerks in real time .

(b) The online information shall include the date of the assignment, polling location name and address, contact information for the judges and clerks assigned, and any other information relevant to the timely and appropriate assignment of judges and clerks.

(c) The real time tool shall be available to the political party chairs 60 days prior to the election

Lines 15-23 on page 1 deeply disturb me.

"Sec.A31.050. ABOLISHMENT OF POSITION AND TRANSFER OF DUTIES IN CERTAIN COUNTIES. On September 1, 2023, all powers and duties of the county elections administrator of a county with a population of more than 3.5 million under this subchapter are transferred to the county tax assessor-collector and county clerk. The county tax assessor-collector shall serve as the voter registrar, and the duties and functions of the county clerk that were performed by the administrator revert to the county clerk, unless a transfer of duties and functions occurs under Section 12.031 or 31.071."

I see no non-political reason to do this. We have already litigated the invalid claims of voter fraud made by some. Our electoral system works. It does not need the changes proposed in SB 1750.

Passing SB 1750 will further undercut faith in our election system. This should be obvious to anyone who reads this bill. Targeting counties with populations greater than 3.5 million only impacts areas which have voted for primarily Democratic candidates for national, statewide, congressional and legislative positions. These areas have been called the "blue islands" in a "red ocean."

Turning county elections administrator's duties over to tax assessor-collectors and county clerks significantly interferes with our current, tested, and successful administration of elections. It does not serve the public good.

On behalf of Our Vote Texas, a 501(c)(3) nonprofit dedicated to voter education and voter rights advocacy in the state of Texas, I write to urge members of the committee to vote against SB 1750 as it is an unnecessary and unwarranted infringement on local control.

Our Vote Texas provides voter resources that give Texas voters helpful information about the basics of voting. We also advocate for reforms that improve voting and elections in terms of both access and process. One of our chief objectives is to make sure Texans understand their rights at the polls and feel confident that they can successfully and safely exercise their right to vote.

In the 2022 midterms, there were media reports of widespread outages of paper ballots at polling places all across Harris County. But as later examination of the data has shown, those early media reports were wildly overblown. Fueled by those media exaggerations, lawmakers have launched a wide ranging attack on Harris County's very ability to run its own elections.

There is simply no evidence of any malfeasance on the part of the Harris County Elections Administrator or his staff. What has been presented by proponents of this bill amounts to little more than conspiracy theories. Similar problems occurred in other counties, yet out of the 254 counties in Texas, Harris County alone faces the potential of being prohibited from selecting the method in which their elections are run.

The people of Harris County, like all other Texans, deserve to have the ability to determine whether they want a non-partisan Elections Administrator selected by their county's elected officials or a partisan County Clerk to administer their elections.

Harris County voters do not need bills like SB 1750 to improve their elections. Rather, they need a strong investment in voter education and policies that provide better access to voting and modernized voter registration. As such, we urge committee members to reject this bill and continue working to better serve all Texans. Thank you for your time and consideration.

Thank you for considering this testimony. I am a Harris County voter submitting this testimony in opposition to SB1750. Many of the election-related bills this session are aimed at Harris County because of claims made about the November 2022 election. As the Houston Chronicle discovered, many of those claims were untrue, and the Houston Chronicle's series of articles published last week debunked the assertions made by KHOU earlier this year. Elections in Harris County suffer from the same issues that would be present in any county of its size, particularly one using new voting machines and processing an extremely lengthy ballot, as was the case in November 2022. There are, of course, still problems with elections that should be addressed, but none of those, such as long lines or equipment malfunction, would be solved by abolishing the position of the Election Administrator. Harris County had long lines, insufficient supplies, equipment malfunction and a host of other election-related issues in 2018 and again in the 2020 Primary, before the Election Administrator position had been established.

The current Harris County Election Administrator is in the process of implementing a number of improvements to our election systems. He is overhauling the "judge line", which is the phone number used by election workers to reach the Election Administrator's Office, to address significant wait times. Similarly, he is implementing a program to barcode all election supplies so that the Election Administrator's office can better anticipate when to deliver supplemental supplies. By removing Administrator Tatum, these important changes will be stymied. In addition, if SB1750 were to pass, it would require Harris County to restructure elections by September 1. That timeframe is unrealistic and will lead to additional issues.

The Election Commission, not the Commissioner's Court, selects the Election Administrator. That Commission is made up of the chairs of both political parties, so that it is always bipartisan, as well as the County Clerk, Tax Assessor, and County Judge. Whether or not Harris County has an Election Administrator, and who that person is, should be considered and determined locally by our duly elected bipartisan Election Commission, not the State Legislature. SB1750 applies solely to Harris County, and we, the voters of Harris County, do not want it.

From drivethru voting to county wide voting to listening to our needs of translating voting information into Korean, we deeply appreciate what the Elections Administrators have done to make voting easier and more accessible while keeping it safe and with integrity.

SB 1750 would take all of that away and suppress the vote of many non-English speaking citizens across Texas. For our democracy, liberties, and freedoms - vote NO on SB 1750.

As a resident and tax payer of Harris County, I fully support Senator Paul Bettencourt's SB 1750, a bill that would eliminate the Elections Administrator's office in Harris County and rightfully return elections to officeholders who can be held accountable directly by voters. We the people require accountability, participation, and transparency in how our elections are run in Harris County and therefore the people require elections run by duly elected officeholders and not an unaccountable administrative office.

Quynh-Huong Nguyen Woori Juntos Houston, TX

Firstly, the bill is founded on the rumor of widespread issues with the November 2022 election, which have been debunked by a series of articles published last week by the Houston Chronicle. There is no evidence that any of the issues seen in November 2022 were intentional, and the issues that occurred have been greatly exaggerated and mischaracterized. Furthermore, logistical issues are common in every large county, regardless of whether the election is run by a County Clerk or an Election Administrator.

Secondly, elections require the undivided attention of someone solely devoted to them. The County Clerk's responsibilities range far beyond elections, so the County Clerk cannot focus exclusively on elections. It is essential to have an experienced, trained professional overseeing the election process to ensure that it runs smoothly and fairly.

Thirdly, even when elections are run by the County Clerk, the County still employs an Election Administrator who is overseen by a bipartisan commission of elected officials. However, if SB1750 passes, the EA position will be overseen entirely by one elected official (the County Clerk), making the position less accountable to voters.

Fourthly, before we had an Election Administrator, the communication between the County Clerk and Tax Assessor was inefficient, leading to delays when election workers attempted to verify voter registration. Eliminating the EA position would only lead to a return to these inefficiencies.

Fifthly, the bill would go into effect on September 1, which does not give the County enough time to make such a dramatic transition. This rushed transition could result in chaos and confusion during the upcoming elections.

Sixthly, problems with Harris County elections predate the creation of the Election Administrator position. Dissolving that position does nothing to address issues such as long lines and equipment failure.

Seventhly, the current Harris County Election Administrator is in the process of implementing important changes that should solve some of the issues we've seen in past elections. By removing the EA, these changes will be stymied, and we will not see the improvements that are necessary for free and fair elections.

Eighthly, the reason voter registration in Texas is housed with the tax assessor goes back to the shameful history of a poll tax. It is time to move past this history and more efficiently administer both elections and voter registration from the same office.

In conclusion, SB1750 is based on misinformation and would have harmful consequences for our democracy. I urge you to oppose this bill and support the people of Harris County in their efforts to maintain free and fair elections.

I support this bill. The largest county in Texas has had repeated problems with the administration of elections since the creation of the appointed position of Election Administrator by the Harris County Commissioners Court. I wish to state that since 2012 I have been an Election Judge or Alternate Judge in two different voting precincts (72 and 885) in Harris County, Texas for various primary and general elections. Procedures worked well under both elected Republican and Democratic officials, when elections were run by the County Clerk and voter registration was under the authority of the Tax Assessor-Collector. However, since the election responsibilities were turned over to an appointed official, various problems have developed. In the 2020 election, while I was the Election Judge at Atascocita Middle School (precinct 885), several voters came to me and stated that the polling place at Eagle Springs School had been shut down for a considerable period of time because the A. D. A. compliance officers forced Eagle Springs (precinct 447) to shut down because they were set up in the "wrong" room, and therefore the Eagle Springs set-up did not match the specified A. D. A. compliance measures. The A. D. A. compliance officers forced the election officials to remove their equipment to the "assigned" room and set it up again, effectively stopping voting at a "Republican" precinct for about an hour. Thus the county elections administrator effectively violated section 41.031 of the Texas Election Code through her appointed employees by restricting polling hours. When the A.D.A. compliance officers arrived at my polling place, they complained that I had not set-up the room in the way that they thought I would, but understood that they had not provided a room set-up plan and thus let the polling place remain in operation with a verbal criticism only. This unprecedented micro-managing of polling place set-ups and room locations by officials unfamiliar with previous local operations at two polling places demonstrates the poor record of the appointed elections administrator in Harris County. Further, the appointed elections administrator has failed to deliver sufficient ballots to various polling places in Harris County during the 2022 general election. Further, the appointed elections administrator has failed to submit timely reports of tally results.

SB 1750 is needed by the citizens of Harris County to restore voter confidence in the election process, and to replace the administration of registration and elections into the hands of elected officials of either party who will be more responsive to the voters. Senator Bettencourt should be commended for bringing this bill forward.

To the Honorable Members of the House Elections Committee,

I am writing to express my strong opposition to SB1750, which seeks to abolish the position of the Election Administrator in Harris County. This bill undermines the democratic principles of local control and accountability, while ignoring the essential role that dedicated Election Administrators play in ensuring the integrity and efficiency of our electoral processes.

First and foremost, it is important to note that the concerns raised about the November 2022 election have been significantly exaggerated and mischaracterized. The initial KHOU article reporting these issues has been debunked by the Houston Chronicle, which revealed that there is no evidence of intentional misconduct. As with any large county, logistical challenges may arise during an election, but these should not be used as a pretext for unwarranted legislative intervention.

Moreover, the current system is more accountable to voters than the one proposed in SB1750. Under the present arrangement, the Election Administrator is overseen by a bipartisan commission of elected officials, whereas the proposed bill would place the position under the sole purview of the County Clerk. This change would significantly reduce accountability and transparency in the electoral process.

Furthermore, the historical link between voter registration and the tax assessor in Texas is rooted in the shameful practice of poll taxes. It is high time that we move beyond this dark chapter in our history by consolidating the administration of elections and voter registration in one office, thus increasing efficiency and promoting a more inclusive democratic process.

My name is Niloufar Hafizi and I represent myself and Emgage Action, a nonprofit advocacy organization dedicated to engaging and empowering Muslim Americans. I urge you to vote "no" on SB 1750. If it were to become law, SB 1750 would make elections administration more inefficient in the only county it applies to.

I am a VDVR in Harris County, where I frequently do voter outreach. Harris is a county larger in population size than almost half of the states in the U.S.A. To have more smoothly run elections, Harris County needs a dedicated, properly funded, and adequately staffed Elections Administration Office (EAO). It does not need to have elections administration put back in the Harris County Clerk and Tax Assessor's office and run by an appointee of the County Clerk. The current system where the Commissioner's Court votes on the Elections Administrator (EA) ensures that a range of elected officials weigh in on who runs elections, and makes the EA accountable to a five-person body with representation from across Harris County.

Additionally, SB 1750 would cause logistical chaos as Houston prepares to have city elections this fall. SB 1750 as written would go into effect in September; if it were to pass, it would cause the County Clerk's office to have to reconfigure to absorb the EAO and then prepare for early voting in less than two months. Such a timeline is unrealistic, and the legislature should not compel elections administration to reorganize on such a timeline. If reconfiguration is going to happen, any major changes to elections administration should occur after 2024, a presidential election year where turnout in primaries and the general election will be higher. Voters will be adversely affected by any administrative overhaul in 2023 or 2024.

Harris County has always faced election difficulties due to the number of voters it has to serve. Harris County, unlike other counties in Texas, also serves voters in four different languages. The task of administering voter registration and elections in Harris County is an enormous and complicated task. When problems occur, the legislature's response should be to find the facts on why problems occurred and support solutions. Moreover, some of the alleged problems used to argue in favor of SB 1750 have been overblown or are erroneous, as this Houston Chronicle investigation shows: https://www.houstonchronicle.com/politics/houston/article/harris-county-ballot-paper-shortage-investigation-17849980.php

Dear Committee Members and Chair, my name is Sarah Syed, and I have served as the Presiding Judge of the Early Voting Ballot Board and Signature Verification Committee in Harris County since April 2022 after the primary. Prior to this, I served as the Alternate Judge since Fall 2020. Every election in Harris County, I along with members of our board, are paired with a member of another party to ensure fairness and integrity. I am a Harris County resident, and I oppose Senate Bill 1750 and am against it passing.

I have personally worked with two Election Administrators' (EA) and their respective office across party lines to help identify any potential problems or bottlenecks in the process and co-develop solutions to address them as it relates to processing of mail-in ballots, federal ballots, military email ballots, FPCA ballots, provisional ballots, and intentional outreach and education to voters. With the creation of an EA, it has significantly reduced wait times at polling places, ensured that all votes are counted in a timely manner in accordance with the Secretary of State, and streamlined any processes in a transparent way.

The EA is a designated office committed to uplifting and capacity building for our elections and was created out of the growing need in Harris County to ensure that the election process is free from any potential conflicts of interest or partisan bias. This is especially important because voters need to have confidence that their votes will be counted accurately, regardless of their political affiliation or views.

This bill would undermine the integrity of our electoral system by placing the responsibilities of conducting elections back onto the County Clerk and Tax Assessor-Collector's offices. More over, it is essential to expand the budget for the EA to include additional training for language access, effective ADA communication, and recruitment of translators / interpreters. All eligible voters deserve equal access to the ballot box, regardless of their language proficiency, indigenous language, or differently abled capabilities. Without proper training and resources, the County Clerk and Tax Assessor-Collector's office may struggle to provide these accommodations, ultimately resulting in a less democratic and less equitable electoral process.
