HB 267 Murr
Relating to an interim study of the appraisal of agricultural land for ad valorem tax purposes.

HB 377 Bucy
Relating to establishing a joint select committee to study the feasibility and sustainability of providing a cost-of-living adjustment applicable to certain benefits paid by the Teacher Retirement System of Texas.

HB 428 Lopez, Ray
Relating to the creation of a task force to evaluate the housing needs of senior citizens who are lesbian, gay, bisexual, transgender, queer, or questioning.

HB 771 Allen
Relating to eligibility requirements to obtain a pass for expedited access to the State Capitol.

HB 1659 Capriglione
Relating to cybersecurity training for certain public employees.

HB 2514 Guillen
Relating to interim studies on real property owned by the state.

HB 3455 Harrison
Relating to the abolition of ad valorem taxes and the creation of a joint interim committee on the abolition of those taxes.

HB 4527 Murr
Relating to an interim study of the appraisal of land used for wildlife management for ad valorem tax purposes.

HB 4574 Murr
Relating to the creation of an interim committee to study large-scale battery storage.

HB 5125 Metcalf

Relating to the organization and operation of the legislative branch of state government.

HCR 62 Hunter

Requesting that the Lieutenant Governor and the Speaker of the House of Representatives create a joint interim committee to study motorcycle operator profiling by law enforcement officers.

HCR 63 Hunter

Requesting the Lieutenant Governor and Speaker to create a joint interim committee to study suicide prevention in Texas.

HCR 64 Hunter

Requesting the Lieutenant Governor and Speaker of the House to create a joint interim committee to study human trafficking in Texas.

HCR 65 Hunter

Requesting the Lieutenant Governor and Speaker of the House to create a joint interim committee to study domestic violence in Texas.

HCR 69 Hunter

Requesting that the Lieutenant Governor and the Speaker of the House of Representatives create a joint interim committee to study the construction of a second vehicular causeway connecting Padre Island to the mainland.

SCR 22 Hall

Authorizing the creation and appointment of joint legislative study committees by the lieutenant governor and speaker of the House of Representatives.

HB 931 Dutton

Relating to a peace officer training advisory committee.
