HB 1571 Lozano | et al.  
Relating to the reimbursement under Medicaid of local educational agencies for the provision of health care services to students.

HB 1879 Darby  
Relating to the provision of counseling services by certain providers under Medicaid and reimbursement for those services.

HB 2439 Thimesch  
Relating to the individuals to whom notice and information must be provided after the Department of Family and Protective Services or another agency takes possession of a child.

HB 2473 Bucy | et al.  
Relating to improvements to the Texas Information and Referral Network.

HB 2802 Rose  
Relating to the Medicaid application form and communication with Medicaid recipients.

HB 2983 Oliverson  
Relating to a pilot project to provide medical nutrition assistance to certain Medicaid recipients in this state.

HB 3189 Garcia  
Relating to information provided to an individual identified as a potential relative or designated caregiver of a child in the conservatorship of the Department of Family and Protective Services.

HB 3584 Leo-Wilson  
Relating to certain placements for children in the conservatorship of the Department of Family and Protective Services.

HB 4065 Rose  
Relating to required reporting by the Department of Family and Protective Services regarding youth in the managing conservatorship of the department who attempt suicide.

HCR 37 Wu  
Designating May 31 as Texas Foster Youth Empowerment Day for a 10-year period ending in 2033.
