HB 181 Johnson, Jarvis | et al.
Relating to the establishment of the sickle cell disease registry.

HB 248 Murr
Relating to solicitation of patients and other prohibited marketing practices and the establishment of the task force on patient solicitation; increasing criminal penalties.

HB 299 Murr
Relating to creating a voluntary accreditation for recovery housing.

HB 362 Oliverson | et al.
Relating to the use, possession, delivery, or manufacture of testing equipment that identifies the presence of fentanyl, alpha-methylfentanyl, or any other derivative of fentanyl.

HB 861 Lozano
Relating to the processing and sale of kratom and kratom products; providing civil penalties; creating a criminal offense.

HB 1190 Klick
Relating to the prescribing and ordering of Schedule II controlled substances by certain advanced practice registered nurses and physician assistants.

HB 1488 Rose
Relating to sickle cell disease health care improvement and the sickle cell task force.

HB 1510 Clardy

Relating to the continuation and transfer of the regulation of willed body programs to the Texas Funeral Service Commission, the regulation of willed body programs, non-transplant anatomical donation organizations, and anatomical facilities, and the creation of the State Anatomical Advisory Committee; requiring registration; authorizing fees; authorizing an administrative penalty.

HB 1805 Klick

Relating to the medical use of low-THC cannabis by patients with certain medical conditions.
