Relating to access to certain investigational drugs, biological products, treatments, and devices by patients.

HB 1105 Price | et al.
Relating to the administration of a medication and the ordering and administration of an immunization or vaccination by a pharmacist.

HB 1240 Oliverson | et al.
Relating to the authority of a physician to provide and dispense and to delegate authority to provide and dispense certain drugs.

HB 1349 Sherman, Sr. | et al.
Relating to the marketing and sale of catfish and similar fish by food service establishments; providing administrative and civil penalties.

HB 1373 Dean
Relating to a pilot program for the safe disposal of controlled substance prescription drugs.

HB 1447 Cortez
Relating to food allergen awareness in food service establishments, food handler and food manager certifications, and food service training or education programs.

HB 2079 Jetton
Relating to the authority of pharmacists to order and furnish certain prescription drugs.

HB 2495 Price
Relating to the requirements to obtain or renew an athletic trainer license.

HB 2553 Stucky
Relating to the authority of a physical therapist to treat a patient without a referral.

HB 2814 Shaheen
Relating to the ownership and operation of columbariums by funeral establishment license holders.

HB 3162 Klick | et al.
Relating to advance directives and health care treatment decisions made by or on behalf of patients, including a review of those directives and decisions.

HB 3236 Herrero
Relating to the composition of the radiation advisory board.

HB 3468 Capriglione | et al.
Relating to a patient's access to health records; authorizing a civil penalty; authorizing fees.

HB 3592 Goldman
Relating to standards to qualify as a licensed specialist in school psychology.

HB 4059 King, Ken | et al.
Relating to the right to try cutting-edge treatments for patients with life-threatening or severely debilitating illnesses.

HB 4173 Klick
Relating to state overdose prevention and control efforts and the defense to prosecution for certain offenses involving possession of small amounts of controlled substances, marihuana, dangerous drugs, or abusable volatile chemicals, or possession of drug paraphernalia for defendants seeking assistance for a suspected overdose.

HB 4343 Bonnen
Relating to health benefit plan preauthorization requirements for certain health care services and the direction of utilization review by physicians.

HB 4365 Johnson, Ann
Relating to the adoption and implementation of a surgical smoke evacuation system policy at certain health care facilities.

HB 4404 Guillen | et al.
Relating to the Advanced Practice Registered Nurse Compact.

HB 4481 Smith
Relating to a directory of e-cigarettes and alternative nicotine products sold in this state, and regulation of the sale and distribution of e-cigarettes and alternative nicotine products; imposing fees; creating criminal offenses; imposing a civil penalty; imposing administrative penalties.

HB 4687 Campos
Relating to the administration of funding for the coordination of mental health, substance use, and public health care services in this state.

HB 4758 Thierry | et al.
Relating to a prohibition on certain e-cigarette containers.

HB 4759 Campos | et al.
Relating to an attack by a dangerous dog; increasing a criminal penalty.
