Relating to academic boycotts at institutions of higher education.

Relating to policy frameworks for research security established by public institutions of higher education.

SB 518 Kolkhorst
Relating to requiring the consideration of standardized test scores as a factor in nonautomatic admissions decisions at certain public institutions of higher education.

SB 969 Zaffirini
Relating to tuition and fee exemptions at public institutions of higher education for certain correctional officers and jailers.

SB 427 Kolkhorst
Relating to requiring certain institutions of higher education to enter into an agreement to offer undergraduate courses in Texas History.

SB 2059 Hinojosa
Relating to grant programs established to support nursing education and training.

SB 1442 Springer
Relating to the creation of a campus of the Texas State Technical College System.

SB 601 Birdwell
Relating to a campus of the Texas State Technical College System located in Ellis County.

SB 865 Schwertner
Relating to a campus of the Texas State Technical College System located in Williamson County.

SB 1350 LaMantia
Relating to the exemption of tuition and laboratory fees at public institutions of higher education for certain paramedics.
