Relating to prohibiting the suspension of a person's driver's license or extension of the period of a driver's license suspension for certain driving while license invalid convictions; authorizing a fee.

**HB 1263** Thompson, Senfronia | et al. SP: Miles  
Relating to the ability of a local authority to designate school crossing zones and school crosswalks at high school campuses located in certain municipalities.

**HB 1315** Herrero SP: Hinojosa  
Relating to the creation of the open burn pit registry fund and the issuance of specialty license plates to honor members of the United States armed forces exposed to open burn pits.

**SB 1542** Parker  
Relating to the designation of a portion of U.S. Highway 380 in Wise and Jack Counties as the Lost Battalion Memorial Highway.

**SB 1716** Zaffirini  
Relating to term limits for certain contracts regarding airports and associated air navigation facilities operated by or on behalf of a local government.

**SB 2179** LaMantia  
Relating to liability of professional entities performing construction monitoring and inspection services for the Texas Department of Transportation.

**SB 2200** Hancock  
Relating to public acknowledgment of donations made to the Texas Department of Transportation.

**SB 2376** Campbell  
Relating to the issuance of Support Adoption specialty license plates and to the Support Adoption account and certain voluntary contributions to that account.

**SB 2515** Bettencourt  
Relating to the restriction of the use of toll road funds for road projects.

**SB 2567** West  
Relating to the issuance of temporary tags and license plates by a motor vehicle dealer.

**SB 2601** Hinojosa  
Relating to payment of costs related to the relocation of certain utility facilities for state highway projects.
