

Fiscal Analysis

The bill would amend various Education Code provisions related to the Rural Veterinarian Incentive Program. The bill would require a participant in the program to enter into an agreement with the Higher Education Coordinating Board. The agreement includes four provisions: (1) requires the participant to practice veterinary medicine in a rural county for one calendar year for each academic year for which the participant receives financial support under the program; (2) specifies the conditions the participant must satisfy to receive financial support under the program; (3) provides that any financial support the participant receives under the program constitutes a loan until the participant satisfies the conditions of the agreement; and (4) requires the participant to sign a promissory note acknowledging the conditional nature of the financial support received under the program and promising to repay the amount of the financial support, any applicable interest, and

reasonable collection costs if the participant does not satisfy the conditions of the agreement.

Methodology

The Higher Education Coordinating Board indicates that loan forgiveness programs are administratively complex for the agency because the agency has to track and verify with different entities that the borrower continues to meet the conditions or repays the loan. For loan forgiveness programs, all the business processes and computer programming required for a new loan program must be in place to track recipients over a period of years and to collect from borrowers who do not fulfill the service obligation. The Rural Veterinarian Incentive Program also involves a proposed engagement with the 30 veterinary colleges across the country. The agency indicates that engaging with out-of-state institutions adds another layer of complexity beyond the structures that the agency has implemented for financial aid programs in the past.

The Higher Education Coordinating Board has indicated that to transition the program to their agency would require the hiring of four FTEs to develop the necessary technology and operating structure to support the program. These four FTEs include a Project Manager in fiscal year 2024 and 2025 to oversee the creation of the new application needed to process and track applicants and recipients in the program. A Program Specialist, System Analyst VI and Customer Services Representative would also be hired beginning in fiscal year 2024. Costs for salaries and benefits total \$369,340 in fiscal year 2024 and fiscal year 2024. Other costs, which include overhead costs, such as technology purchases and office equipment, total \$69,593 in fiscal year 2024 and \$58,095 in fiscal year 2025.
