A BILL TO BE ENTITLED

AN ACT

2 relating to the safety of a referee, judge, or other official at 3 certain public school extracurricular activities and prohibiting 4 certain conduct by a spectator related to those officials' safety.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 33.081, Education Code, is amended by 7 adding Subsection (f-1) and amending Subsection (g) to read as 8 follows:

9 (f-1) A spectator of a University Interscholastic League competition, including a parent or guardian of a student 10 participant, shall be prohibited from attending any future 11 12 extracurricular activity sponsored or sanctioned by the school district or the University Interscholastic League if the spectator 13 14 engages in conduct that intentionally, knowingly, or recklessly causes bodily injury to a person serving as referee, judge, or other 15 16 official of an extracurricular activity in retaliation for or as a result of the person's actions taken in performing the duties of a 17 referee, judge, or other official of the extracurricular activity. 18

(g) An appeal to the commissioner is not a contested case under Chapter 2001, Government Code, if the issues presented relate to a <u>person's</u> [student's] eligibility to participate in <u>or attend an</u> extracurricular <u>activity</u> [activities], including issues related to <u>a</u> [the] student's grades, the school district's grading policy as applied to <u>a</u> [the] student's eligibility, <u>a</u> [or the] student's

1 eligibility based on conduct described by Subsection (e-1), or a spectator's eligibility to attend an extracurricular activity 2 <u>under Subsection (f-1)</u>. The commissioner may delegate the matter 3 for decision to a person the commissioner designates. The decision 4 5 of the commissioner or the commissioner's designee in a matter governed by this subsection may not be appealed except on the 6 grounds that the decision is arbitrary or capricious. Evidence may 7 8 not be introduced on appeal other than the record of the evidence before the commissioner. 9

10 SECTION 2. Subchapter D, Chapter 33, Education Code, is 11 amended by adding Section 33.099 to read as follows:

12 Sec. 33.099. SAFETY OF OFFICIAL. A school district or open-enrollment charter school that holds an extracurricular 13 athletic activity or a University Interscholastic League athletic 14 competition on district or school property shall provide a peace 15 officer, school resource officer, administrator, or security 16 personnel to ensure the safety of a referee, judge, or other 17 official of the activity or competition until the official departs 18 19 district or school property if:

20 <u>(1) a participant or spectator of the activity or</u> 21 <u>competition engages in, attempts to engage in, or threatens violent</u> 22 <u>conduct against the official or otherwise disrupts the duties or</u> 23 <u>free movement of the official; or</u>

24 (2) the district or school reasonably suspects that an 25 incident described by Subdivision (1) may occur at the activity or 26 competition.

AN ACT

2 relating to the safety of a referee, judge, or other official at 3 certain public school extracurricular activities and competitions 4 and prohibiting certain conduct by a spectator related to those 5 officials' safety.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 33.081, Education Code, is amended by adding Subsections (f-1) and (f-2) and amending Subsection (g) to read as follows:

(f-1) A school district may prohibit a spectator of an 10 extracurricular athletic activity or competition, including a 11 parent or guardian of a student participant, from attending any 12 future extracurricular athletic activity or competition sponsored 13 or sanctioned by the school district or the University 14 Interscholastic League if the spectator engages in conduct that 15 intentionally, knowingly, or recklessly causes bodily injury to a 16 person serving as referee, judge, or other official of an 17 extracurricular athletic activity or competition in retaliation 18 for or as a result of the person's actions taken in performing the 19 duties of a referee, judge, or other official of the 20 extracurricular athletic activity or competition. 21

22 (f-2) A school district may establish an appeals process by
23 which a person may appeal to the district a prohibition imposed
24 under Subsection (f-1).

1 (g) An appeal to the commissioner is not a contested case under Chapter 2001, Government Code, if the issues presented relate 2 to a person's [student's] eligibility to participate in or attend an 3 extracurricular <u>activity</u> [activities], including issues related to 4 a [the] student's grades, the school district's grading policy as 5 6 applied to <u>a</u> [the] student's eligibility, <u>a</u> [or the] student's eligibility based on conduct described by Subsection (e-1), or a 7 spectator's eligibility to attend an extracurricular athletic 8 activity or competition under Subsection (f-1). The commissioner 9 may delegate the matter for decision to a person the commissioner 10 11 designates.
