5	SECTION 1. Section 143.004(e), Local Government Code, is
6	amended to read as follows:
7	(e) If the governing body of a municipality <u>with a</u>
8	population of less than 900,000 that has operated under this
9	chapter for at least one year receives a petition requesting an
10	election to repeal this chapter that is signed by at least 10
11	percent of the qualified voters of the municipality, the governing
12	body shall order an election submitting to the voters the question
13	on whether this chapter should be repealed. If a majority of the
14	qualified voters vote to repeal this chapter, this chapter is void
15	in that municipality.

16 SECTION 2. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2023.
