10	(1) "Coordinating board" means the Texas Higher

12	(2) "Eligible institution" means a general academic
13	teaching institution or a private or independent institution of
14	higher education, as those terms are defined by Section 61.003,
15	that operates an eligible educator preparation program.
16	(3) "Enrolled full-time" means enrolled for at least
17	12 semester credit hours or participating in a clinical teaching
18	assignment or internship that meets criteria established by State
19	Board for Educator Certification rule for initial certification as
20	a classroom teacher.
21	(4) "Scholarship program" means the Future Texas
22	Teachers Scholarship Program authorized by this subchapter.
23	Sec. 56.502. PURPOSE. The Future Texas Teachers
24	Scholarship Program is created to recruit, prepare, and retain a

- 1 talented and diverse workforce of career teachers to be leaders in
- 2 their field and to provide assistance for tuition, mandatory fees,
- 3 and other usual and customary costs of attendance at an eligible
- 4 institution as provided by Sections 56.506 and 56.507.
- 5 Sec. 56.503. ELIGIBLE EDUCATOR PREPARATION PROGRAMS. To be
- 6 eligible to participate in the scholarship program, an educator
- 7 preparation program must:
- 8 (1) be operated by an eligible institution;
- 9 (2) provide a structured system of support to assist
- 10 scholarship recipients to successfully complete the educator
- 11 preparation program;
- 12 (3) require additional hours of field-based
- 13 experience for students above the minimum hours required by State
- 14 Board for Educator Certification rule;
- 15 (4) require additional hours of clinical teaching
- 16 <u>experience for students above the minimum hours required by State</u>
- 17 Board for Educator Certification rule;
- 18 <u>(5) provide or facilitate opportunities for</u>
- 19 scholarship recipients to participate in learning opportunities
- 20 beyond the university classroom setting; and
- 21 (6) comply with other eligibility criteria
- 22 <u>established by coordinating board rule.</u>
- 23 <u>Sec. 56.504. INITIAL STUDENT ELIGIBILITY FOR SCHOLARSHIP.</u>
- 24 (a) To be eligible initially for a scholarship under the
- 25 scholarship program, a person must:
- 26 (1) be a Texas resident under Section 54.052;
- 27 (2) either:

2	institution; or
3	(B) have applied for admission to an eligible

- 5 transfer, sell, or distribute a controlled substance, as defined by
- 6 Chapter 481, Health and Safety Code, or by 21 U.S.C. Section 801 et
- 7 seq.;
- 8 <u>(4) an offense involving the illegal transfer,</u>
- 9 appropriation, or use of school district funds or other district
- 10 property; or
- 11 (5) an offense involving an attempt by fraudulent or
- 12 unauthorized means to obtain or alter a professional certificate or
- 13 license issued under Subchapter B, Chapter 21.
- 14 Sec. 56.505. CONTINUING STUDENT ELIGIBILITY AND ACADEMIC
- 15 PERFORMANCE REQUIREMENTS. (a) After initially qualifying for a
- 16 scholarship under this subchapter, a person may continue to receive
- 17 a scholarship under the scholarship program during each semester or
- 18 term in which the person is enrolled at an eligible institution only
- 19 if the person:
- 20 (1) demonstrates a continued commitment to pursuing a
- 21 <u>career as a classroom teacher:</u>
- 22 (A) in a teaching field identified by the
- 23 commissioner of education as experiencing a critical shortage of
- 24 teachers in this state; or
- 25 (B) in a public school in this state in which a
- 26 majority of students enrolled are educationally disadvantaged;
- 27 (2) remains enrolled full-time in an eligible

- 1 <u>institution;</u>
- 2 (3) remains enrolled in or is on track to be admitted
- 3 to an eligible educator preparation program, as verified by the
- 4 eligible institution in which the person is enrolled;
- 5 (4) makes satisfactory academic progress toward
- 6 completion of a baccalaureate or master's degree and approval to
- 7 take a teacher certification exam, as verified by the eligible
- 8 institution; and
- 9 (5) complies with any other academic or nonacademic
- 10 requirements adopted by the coordinating board under this
- 11 subchapter.
- 12 (b) A person is not eligible to continue to receive a
- 13 scholarship under the scholarship program if the person has been
- 14 convicted of a felony or misdemeanor offense described by Section
- 15 <u>56.504(b).</u>
- 16 (c) If a person fails to meet any of the requirements of
- 17 Subsection (a) after the completion of any semester or term, the
- 18 person may not receive a scholarship under this subchapter during
- 19 the next semester or term in which the person enrolls. A person may
- 20 become eligible to receive a scholarship under this subchapter in a
- 21 subsequent semester or term if the person:
- (1) completes a semester or term during which the
- 23 person is not eligible for a scholarship; and
- 24 (2) meets all the requirements of Subsection (a).
- 25 <u>(d) For the purpose of this section, a person makes</u>
- 26 satisfactory academic progress toward a baccalaureate or master's
- 27 degree only if:

1 (1) in the person's first academic year the person 2 meets the satisfactory academic progress requirements of the 3 eligible institution in which the person is enrolled; and 4 (2) in a subsequent academic year, the person: 5 (A) completes at least 75 percent of the semester credit hours attempted in the person's most recent academic year; 6 7 and 8 (B) has earned an overall grade point average of at least 3.0 on a four-point scale or the equivalent on coursework 9 10 previously attempted at an eligible institution. 11 (e) A person who is eligible to receive a scholarship under 12 this subchapter continues to remain eligible to receive the scholarship if the person enrolls in or transfers to an eligible 13 educator preparation program at another eligible institution. 14 15 (f) The coordinating board shall adopt rules to allow a person who is otherwise eligible to receive a scholarship under 16 17 this subchapter, in the event of a hardship or for other good cause shown, including a showing of a severe illness or other 18 19 debilitating condition that may affect the person's academic performance or that the person is responsible for the care of a 20 sick, injured, or needy person and that the person's provision of 21 22 care may affect the person's academic performance, to receive a scholarship under this subchapter: 23 24 (1) while enrolled in a number of semester credit hours that is less than the number required to be enrolled 25 26 full-time; or

(2) if the person's grade point average or completion

- 3 (g) A person's eligibility for a scholarship under this
- 4 <u>subchapter ends on the earlier of:</u>

- 8 (2) the person's completion of the baccalaureate or

- Sec. 56.506. SCHOLARSHIP AMOUNT. (a) Beginning with the
- 11 2024-2025 academic year, the amount of a scholarship under this
- 12 subchapter is equal to the amount of the scholarship for the
- 13 preceding academic year, adjusted for inflation using the college
- 14 tuition and fees index component of the consumer price index
- 15 produced by the United States Bureau of Labor Statistics.
- 16 <u>(a-1)</u> For the 2023-2024 academic year, the amount of a
- 17 scholarship under this subchapter is \$12,000. This subsection
- 18 expires September 1, 2024.
- 19 (b) The amount of a scholarship under this subchapter may
- 20 not be reduced by any other scholarship, grant, or financial aid
- 21 which the scholarship recipient receives.
- (c) Not later than January 31 of each year, the coordinating
- 23 board shall publish the amounts of each scholarship established by
- 24 the board for the academic year beginning the next fall semester.
- Sec. 56.507. SCHOLARSHIP USE. A person receiving a
- 26 scholarship under this subchapter may use the money to pay any usual
- 27 and customary cost of attendance at an eligible institution

- 1 incurred by the person. The institution may disburse all or part of
- 2 the proceeds of a scholarship under this subchapter to an eligible
- 3 person only if the tuition and required fees incurred by the person
- 4 at the institution have been paid.
- 5 Sec. 56.508. ADMINISTRATION OF PROGRAM. (a) The
- 6 coordinating board shall adopt any rules necessary to:
- 7 (1) establish eligibility criteria for educator
- 8 preparation programs in accordance with Section 56.503 and for
- 9 scholarship recipients in accordance with Sections 56.504 and
- 10 56.505;
- 11 (2) establish procedures for the application process
- 12 and for selecting scholarship recipients from among eligible
- 13 applicants; and
- 14 (3) administer the scholarship program.
- 15 (b) In establishing criteria for eligible educator
- 16 preparation programs under Section 56.503, the coordinating board
- 17 shall consult with the State Board for Educator Certification. The
- 18 coordinating board shall consider the standards used by the State

- 23 <u>(c) In establishing criteria for eligible persons under</u>
- 24 Sections 56.504 and 56.505, the coordinating board shall consult
- 25 with representatives of the educator preparation programs from
- 26 eligible institutions.
- 27 (d) In developing rules related to distributing a

- 1 scholarship, the coordinating board shall consult with financial
- 2 aid coordinators of eligible institutions.
- 3 (e) The total amount of scholarships awarded may not exceed
- 4 the amount available for the program from appropriations, gifts,
- 5 grants, or other funds.
- 6 (f) From money appropriated by the legislature for the
- 7 purposes of this subchapter, the coordinating board annually shall
- 8 determine the allocation of money available for scholarships among
- 9 eligible institutions and shall distribute the money accordingly.
- 10 (g) In determining who should receive a scholarship under
- 11 this subchapter, the coordinating board shall give priority to
- 12 awarding scholarships to:
- 13 (1) persons who demonstrate the greatest financial
- 14 need and whose expected family contribution, as determined
- 15 according to the methodology used for federal student financial
- 16 aid, does not exceed 60 percent of the average statewide amount of
- 17 <u>tuition and required fees;</u>
- 18 (2) first-generation college students, as defined by
- 19 coordinating board rule; and
- 20 (3) persons who demonstrate a commitment both to
- 21 entering a teaching field identified by the commissioner of
- 22 education as experiencing a critical shortage of teachers and to
- 23 teaching in a public school in this state in which a majority of
- 24 students enrolled are educationally disadvantaged.
- 25 SECTION 2. Section 56.308(b), Education Code, is amended to
- 26 read as follows:

- 21 SECTION 3. (a) The Texas Higher Education Coordinating
- 22 Board shall adopt rules to administer Subchapter S, Chapter 56,
