SECTION 1. Chapter 61, Education Code, is amended by adding Subchapter T-3 to read as follows: <u>SUBCHAPTER T-3. TEXAS LEADERSHIP SCHOLARS</u> <u>PROGRAM</u> <u>Sec. 61.891. DEFINITION. In this subchapter,</u>

"program" means the Texas Leadership Scholars Program established under this subchapter.

Sec. 61.892. ESTABLISHMENT; ADMINISTRATION. (a) The Texas Leadership Scholars Program is established to serve as a merit-based scholarship and leadership opportunity program for high-achieving, emerging leaders with financial need.

(b) The board shall administer the program.

(c) Using money appropriated or otherwise available for the purpose, the board shall award scholarships and provide academic achievement support and leadership development to eligible students under the program.

In this subchapter: (1) "Leadership scholarship" means a scholarship awarded to an undergraduate student under the program. (a) The Texas Leadership Scholars Program is established to serve as a merit-based scholarship and leadership opportunity program for high-achieving, emerging leaders with financial need. (b) Using money appropriated or otherwise available for the

(b) Using money appropriated or otherwise available for the purpose, the board shall award scholarships and provide academic achievement support and leadership development to eligible students under the program.

(c) The board shall administer the program. The board may contract with one or more institutions of higher education to assist in administering the program, including receiving and reviewing applications, recommending the distribution of funds to institutions of higher education, and developing criteria for the selection of students for the program.

(d) The board may establish one or more advisory committees for the purpose of recommending rules for the administration of the program.

SECTION 2. The Texas Higher Education Coordinating Board shall adopt rules to administer Subchapter T-3, Chapter 61, Education Code, as added by this Act, as soon as practicable after the effective date of this Act.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2023. donations from any public or private source for the purposes of the program.
Sec. 61.897. RULES. (a) The board, in consultation with general academic teaching institutions, shall adopt rules for the administration of the program, including rules providing for the amount and permissible uses of a scholarship awarded under the program. The rules must provide that:

the amount of a research scholarship is at least 150 percent of the amount of a leadership scholarship; and
a student may not receive a scholarship under the program for more than four years.
Notwithstanding Section 61.033, the board is not required to use negotiated rulemaking procedures under Chapter 2008, Government Code, for the adoption of rules under this subchapter.
