- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. Subchapter J, Chapter 1701, Occupations Code, is
- amended by adding Section 1701.45351 to read as follows: 6
- Sec. 1701.45351. DEPARTMENT FILE. (a) In this section, 7
- "department file" means a file maintained by a law enforcement 8
- 9 agency for each license holder employed by the agency for the
- 10 agency's use.
- 11 (b) The head of a law enforcement agency or the head's
- 12 designee shall maintain a department file on each license holder
- 13 employed by the agency.
- 14 (c) A department file must contain any letter, memorandum,
- or document relating to the license holder not included in a 15
- personnel file maintained under a policy adopted under Section 16
- 1701.4535, including any letter, memorandum, or document relating 17
- to alleged misconduct by the license holder for which the agency 18
- determines there is insufficient evidence to sustain the charge of 19
- misconduct. 20
- 21 (d) As provided by Section 1701.451, a law enforcement
- agency hiring a license holder is entitled to view the contents of 22
- 23 the license holder's department file.
- 24 (e) A law enforcement agency shall provide contents from a

- 1 license holder's department file to the commission in accordance
- 2 with:
- 3 (1) the law enforcement agency's policy adopted in
- 4 compliance with Section 1701.4522(b)(1)(D); or
- 5 (2) a request by the commission as part of an ongoing
- 6 investigation relating to the license holder.
- 7 (f) A department file maintained under this section is
- 8 subject to disclosure under Article 39.14, Code of Criminal
- 9 Procedure, or Section 511.021, Government Code. A law enforcement
- 10 agency may disclose information contained in a license holder's
- 11 department file if the disclosure is permitted under a meet and
- 12 confer agreement entered into before September 1, 2025.
- 13 (g) Except as provided by Subsections (d), (e), and (f), a
- 14 law enforcement agency may not release any information contained in
- 15 <u>a license holder's department file to any other agency or person</u>
- 16 requesting information relating to the license holder. The agency
- 17 shall refer the person or agency requesting the information to the
- 18 agency head or the head's designee. A department file maintained
- 19 under this section is confidential and not subject to disclosure
- 20 under Chapter 552, Government Code.
- 21 SECTION 2. This Act takes effect on the 91st day after the
- 22 last day of the legislative session.
