## A BILL TO BE ENTITLED 1 AN ACT 2 relating to a limit on municipal and county expenditures. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Chapter 140, Local Government Code, is amended 4 5 by adding Section 140.014 to read as follows: 6 Sec. 140.014. LIMIT ON ANNUAL EXPENDITURES. (a) In this 7 section: (1) "Board" means the Legislative Budget Board. 8 (2) "Consumer price index" means the average over a 9 calendar year of the index the board considers to most accurately 10 report changes in the purchasing power of the dollar for consumers 11 12 in this state. 13 (3) "Inflation rate" means the amount, expressed in 14 decimal form rounded to the nearest thousandth, computed by determining the percentage change in the consumer price index for 15 16 the preceding calendar year as compared to the consumer price index for the calendar year preceding that calendar year. 17 18 (4) "Population growth rate" means the rate of growth of the state's population during the preceding calendar year, 19 expressed in decimal form rounded to the nearest thousandth, 20 21 determined by the board in accordance with the most recent population estimates published by the United States Census Bureau. 22 23 (b) This section applies only to a political subdivision 24 that is a municipality or county.

No. 63 (c) Except as provided by Subsection (e), a political 1 2 subdivision's total expenditures from all available sources of 3 revenue in a fiscal year may not exceed the greater of: 4 (1) the political subdivision's total expenditures 5 from all available sources of revenue in the preceding fiscal year; 6 or 7 (2) an amount determined by multiplying: (A) the political subdivision's total 8 expenditures from all available sources of revenue in the preceding 9 10 fiscal year; and (B) the sum of one and the rate most recently 11 12 published by the board under Subsection (d). (d) Not later than January 31 of each year, the board shall 13 14 publish a rate equal to the product of the population growth rate 15 and the inflation rate. 16 (e) A political subdivision's total expenditures from all 17 available sources of local revenue in a fiscal year may exceed the amount described by Subsection (c) if: 18 19 (1) the political subdivision's voters approve the additional expenditures for that fiscal year at an election called 20 for that purpose and held on a uniform election date; or 21 22 (2) the governor declares or renews a declaration of a state of disaster under Section 418.014, Government Code, in that 23 24 fiscal year, and the governor's designation of the area threatened includes all or part of the geographic territory of the political 25 26 subdivision. 27 (f) For purposes of this section, the following are not

## 2 (1) money received from the issuance of bonds approved 3 by the voters; or 4 (2) a grant, donation, or gift.

5 SECTION 2. Section 140.014, Local Government Code, as added 6 by this Act, applies only to a fiscal year of a municipality or 7 county that begins on or after December 1, 2025.

8 SECTION 3. This Act takes effect on the 91st day after the 9 last day of the legislative session.
