## A BILL TO BE ENTITLED

| 4  | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:            |
| 5  | SECTION 1. Subchapter G, Chapter 814, Government Code, is          |
| 6  | amended by adding Section 814.605 to read as follows:              |
| 7  | Sec. 814.605. COST-OF-LIVING ADJUSTMENT: JANUARY 2026. (a)         |
| 8  | The amount of a service retirement, disability retirement, death,  |
| 9  | or other monthly benefit paid under this chapter, Chapter 820, or  |
| 10 | Chapter 804 to an annuitant based on service credited in the       |
| 11 | employee class is increased to include a cost-of-living adjustment |
| 12 | in accordance with this section.                                   |
| 13 | (b) Subject to Subsections (c) and (d), to be eligible for         |
| 14 | the adjustment, a person must be, for the month of December 2025,  |
| 15 | an annuitant eligible to receive:                                  |
| 16 | (1) a standard retirement annuity payment;                         |
| 17 | (2) an optional service retirement annuity payment as              |
| 18 | either a retiree or beneficiary under Section 814.108 or 820.0535; |
| 19 | (3) a standard or occupational disability retirement               |

| 15 | (d) If the annuitant:  |
| 16 | (1) is a retiree or beneficiary under an optional                  |
| 17 | service or disability retirement payment plan, to be eligible for  |
| 18 | the adjustment under this section:                                 |
| 19 | (A) the annuitant must be living on the effective                  |
| 20 | date of the adjustment; and  |
| 21 | (B) the effective date of the retirement of the                    |
| 22 | member of the retirement system on whose service the annuity is    |
| 23 | based must have been before September 1, 2024;                     |

| 20 | subject to the adjustment by the following percentage rate, as    |
| 21 | applicable:   |
| 22 | (1) for annuitants described by Subsection (d)(1):                |
| 23 | (A) if the effective date of retirement of the                    |

| 11 | retirement system on whose service the annuity is based was after  |
| 12 | August 31, 2014, four percent; and                                 |
| 13 | (3) for annuitants described by Subsection (d)(3):                 |
| 14 | (A) if the effective date of the annuitant's                       |
| 15 | election was on or before August 31, 2014, seven percent; and      |
| 16 | (B) if the effective date of the annuitant's                       |
| 17 | election was after August 31, 2014, four percent.                  |
| 18 | (g) The board of trustees shall recompute the amount of an         |
| 19 | annuity paid monthly under this chapter, Chapter 820, or Chapter   |
| 20 | 804, as applicable, by applying the adjustment required under      |
| 21 | Subsection (f) to the monthly amount otherwise required to be paid |
| 22 | under the applicable chapter. The adjustment under this section    |
| 23 | is in addition to the adjustment, if any, granted under Section    |

## 1 814.604 or any other law.

2 (h) The board of trustees shall determine the eligibility 3 for and the amount of any adjustment in monthly annuities in 4 accordance with this section.

5 SECTION 2. Section 814.605, Government Code, as added by this Act, applies only to a monthly benefit payment made by the 6 Employees Retirement System of Texas on or after January 1, 2026. 7 8 SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 9 10 provided by Section 39, Article III, Texas Constitution. If this 11 Act does not receive the vote necessary for immediate effect, this Act takes effect on the 91st day after the last day of the 12 13 legislative session.
