- 1 (d) A public member of the council is entitled to
- 2 reimbursement of the travel expenses incurred by the member while
- 3 conducting the business of the council, as provided by the General
- 4 Appropriations Act.
- 5 (e) Each legislative standing committee with primary
- 6 jurisdiction over environmental regulation shall provide any
- 7 needed personnel and administrative support to the council.
- 8 (f) The council shall conduct a study to:
- 9 (1) assess the current and potential effects of
- 10 climate change trends on the residents, natural resources, public
- 11 health, and economy of this state;
- 12 (2) estimate the costs to this state of adverse
- 13 effects associated with climate change;
- 14 (3) research measures for preventing or mitigating the
