A BILL TO BE ENTITLED

1	AN ACT
2	relating to state and local government disaster preparedness.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 418.054(a), Government Code, is amended
5	to read as follows:
6	(a) The division shall develop a model guide for local
7	officials regarding disaster response and recovery. The guide must
8	provide a comprehensive approach to disaster recovery by local
9	officials and include information on:
10	(1) contracting for debris removal;
11	(2) obtaining federal disaster funding;
12	(3) coordinating the availability and construction of
13	short-term and long-term housing; [and]
14	(4) obtaining assistance from local, state, and
15	federal volunteer organizations; and
16	(5) planning practices for developing and reviewing
17	local and interjurisdictional emergency management plans under
18	Section 418.106 to ensure:
19	(A) the needs of the community's vulnerable
20	populations, including persons with disabilities, persons who are
21	homeless, and low-income households, are accurately identified;
22	(B) the emergency management plans address the
23	needs identified under Paragraph (A); and
24	(C) the community resources that vulnerable

- 1 populations rely on remain available during a disaster.
- 2 SECTION 2. Section 418.106(b), Government Code, is amended
- 3 to read as follows:
- 4 (b) The plan must provide for:
- 5 (1) wage, price, and rent controls and other economic
- 6 stabilization methods in the event of a disaster; [and]
- 7 (2) curfews, blockades, and limitations on utility use
- 8 in an area affected by a disaster, rules governing entrance to and
- 9 exit from the affected area, and other security measures;
- 10 (3) integrated and inclusive operations specific to
- 11 individuals with disabilities to afford those individuals an
- 12 equitable opportunity to benefit from all disaster response and
- 13 recovery measures, programs, services, and activities;
- 14 (4) the <u>increase in the capabilities of local</u>
- 15 emergency shelters in the provision of shelter and care for
- 16 <u>individuals with disabilities during a disaster;</u>
- 17 (5) wellness checks for individuals with disabilities
- 18 in the manner provided by Subchapter I;
- 19 (6) the establishment of minimum health-related
- 20 standards for short-term and long-term shelter operations for
- 21 shelters operated with state funds or receiving state assistance;
- 22 (7) an emergency notification system that notifies
- 23 individuals with disabilities of a disaster or emergency and of any
- 24 actions the individuals should take to prepare for or respond to the
- 25 disaster or emergency;
- 26 (8) personnel surge capacity during a disaster,
- 27 including plans for providing lodging and meals for disaster relief

- 1 workers and volunteers; and
- 2 (9) horizontal integration of emergency preparedness
- 3 and response plans required for licensed facilities and providers
- 4 serving individuals with disabilities.
- 5 SECTION 3. Section 418.186(a), Government Code, is amended
- 6 to read as follows:
- 7 (a) The Department of State Health Services shall establish
- 8 a program designed to educate the citizens of this state on disaster
- 9 and emergency preparedness, response, and recovery. Before
- 10 establishing the program, the department must collaborate with
- 11 local authorities to prevent state efforts that are duplicative of
- 12 local efforts. The program must address:
- 13 (1) types of disasters or other emergencies;
- 14 (2) the appropriate response to each type of disaster
- 15 or emergency, including options for evacuation and shelter;
- 16 (3) how to prepare for each type of disaster or
- 17 emergency;
- 18 (4) the impact of each type of disaster or emergency on
- 19 citizens requiring medical assistance or other care;
- 20 (5) ways to respond in a disaster or emergency or to
- 21 assist the victims of a disaster or emergency; [and]
- 22 (6) resources and supplies for disaster or emergency
- 23 recovery; and
- 24 (7) the resources, services, and programs that are
- 25 available to address the needs of persons with disabilities during
- 26 a disaster or other emergency.
- SECTION 4. Section 418.1882, Government Code, is amended by

- 1 amending Subsection (a) and adding Subsection (a-1) to read as
- 2 follows:
- 3 (a) With the direction, oversight, and approval of the
- 4 division and the assistance of the Department of State Health
- 5 Services, health care facilities, county officials, trauma service
- 6 area regional advisory councils, and other appropriate entities,
- 7 each council of government, regional planning commission, or
- 8 similar regional planning agency created under Chapter 391, Local
- 9 Government Code, shall, as part of a crisis standards of care plan,
- 10 develop a regional plan for personnel surge capacity during
- 11 disasters, including plans for providing lodging and meals for
- 12 disaster relief workers and volunteers.
- 13 <u>(a-1)</u> The Department of State Health Services Preparedness
- 14 Coordinating Council shall create a framework and provide guidance
- 15 for the development of crisis standards of care plans. In
- 16 developing the crisis standards of care framework, the council
- 17 shall consult with the Department of State Health Services, health
- 18 care facilities, county officials, trauma service area regional
- 19 advisory councils, and each council of government, regional
- 20 planning commission, or similar regional planning agency created
- 21 under Chapter 391, Local Government Code.
- SECTION 5. Section 418.192(c), Government Code, is amended
- 23 to read as follows:
- 24 (c) The emergency notification system for which a contract
- 25 is entered into under Subsection (b) must rely on a dynamic
- 26 information database that:
- 27 (1) is capable of simultaneous transmission of

- 1 emergency messages to all recipients through at least two
- 2 industry-standard gateways to one or more telephones or electronic
- 3 devices owned by a recipient in a manner that does not negatively
- 4 impact the existing communications infrastructure;
- 5 (2) allows the public service provider to:
- 6 (A) store prewritten emergency messages in the
- 7 dynamic information database for subsequent use; [and]
- 8 (B) generate emergency messages in real time
- 9 based on provider inputs; and
- 10 (C) send emergency messages in both audio and
- 11 <u>visual formats;</u>
- 12 (3) allows a recipient to select the language in which
- 13 the recipient would prefer to receive messages;
- 14 (4) transmits the message in the recipient's language
- 15 of choice to that recipient;
- 16 (5) converts text messages to sound files and
- 17 transmits those sound files to the appropriate device;
- 18 (6) assigns recipients to priority groups for
- 19 notification:
- 20 (7) allows for the collection and verification of
- 21 responses by recipients of emergency messages; and
- 22 (8) reads or receives alerts from a commercial mobile
- 23 alert system established by the Federal Communications Commission
- 24 or complies with standards adopted for a commercial mobile alert
- 25 system established by the Federal Communications Commission.
- SECTION 6. Section 421.002(b), Government Code, is amended
- 27 to read as follows:

- 1 (b) The governor's homeland security strategy shall
- 2 coordinate homeland security activities among and between local,
- 3 state, and federal agencies and the private sector and must include
- 4 specific plans for:
- 5 (1) intelligence gathering and analysis;
- 6 (2) information sharing;
- 7 (3) reducing the state's vulnerability to homeland
- 8 security emergencies;
- 9 (4) protecting critical infrastructure;
- 10 (5) protecting the state's international border,
- 11 ports, and airports;
- 12 (6) detecting, deterring, and defending against
- 13 terrorism, including cyber-terrorism and biological, chemical, and
- 14 nuclear terrorism;
- 15 (7) positioning equipment, technology, and personnel
- 16 to improve the state's ability to respond to a homeland security
- 17 emergency;
- 18 (8) directing the Texas Fusion Center and giving the
- 19 center certain forms of authority to implement the governor's
- 20 homeland security strategy; [and]
- 21 (9) using technological resources to:
- 22 (A) facilitate the interoperability of
- 23 government technological resources, including data, networks, and
- 24 applications;
- 25 (B) coordinate the warning and alert systems of
- 26 state and local agencies;
- (C) incorporate multidisciplinary approaches to

- 1 homeland security; and
- 2 (D) improve the security of governmental and
- 3 private sector information technology and information resources;
- 4 and
- 5 (10) building community resilience and reducing
- 6 <u>long-term</u> vulnerability for persons with disabilities by
- 7 implementing inclusive disaster and emergency planning practices
- 8 at all levels of government.
- 9 SECTION 7. Section 81.0813(d), Health and Safety Code, is
- 10 amended to read as follows:
- 11 (d) A declaration or order issued under this section must
- 12 include:
- 13 (1) a description of the nature of the disaster or
- 14 emergency;
- 15 (2) a designation of the area threatened by the
- 16 disaster or emergency;
- 17 (3) a description of the condition that created the
- 18 disaster or emergency; [and]
- 19 (4) the threshold event for implementing crisis
- 20 standards of care; and
- 21 $\underline{(5)}$ if applicable:
- (A) the reason for renewing the disaster or
- 23 emergency; or
- 24 (B) the reason for terminating the disaster or
- 25 emergency.
- SECTION 8. This Act takes effect on the 91st day after the
- 27 last day of the legislative session.
