R E S O L U T I O N

1 WHEREAS, The family and friends of Kent Monroe Wattinger of  
2 Marble Falls suffered an immeasurable loss with his passing on July  
3 8, 2025, at the age of 36; and

4 WHEREAS, While their vehicle was being swept away by  
5 floodwaters in Liberty Hill, Mr. Wattinger summoned the strength  
6 and courage to push his wife, Samantha, toward the riverbank, where  
7 she was able to pull herself to safety; though he succumbed to the  
8 floodwaters, his heroic sacrifice on that fateful day will forever  
9 be remembered; and

10 WHEREAS, Born on July 25, 1988, Kent Wattinger was raised by  
11 his mother, Kimmie Lynch, and his grandparents; as a child, he  
12 cherished time spent in 4-H with his grandmother, and as a young  
13 man, he enjoyed playing in bands with his friends; and

14 WHEREAS, Mr. Wattinger and his first wife, Rebecca, became  
15 the proud parents of a daughter, Violet; after that marriage ended,  
16 he was fortunate enough to find love again with his second wife,  
17 Samantha, and he had the pleasure of seeing his treasured family  
18 grow to include two more children, Hunter and Zoey; and

19 WHEREAS, Over the course of a rewarding career in the  
20 technology industry, Mr. Wattinger rose through the ranks to become  
21 a software development engineer at Amazon Robotics; an active  
22 member of Wind Therapy Freedom Riders, he was the national safety  
23 division president and the ATX chapter president; through this  
24 organization, he and his wife attended many charity rides, benefit

1 events, and outreach efforts to support first responders, law  
2 enforcement officers, and veterans; and

3 WHEREAS, Although Kent Wattinger is deeply missed, memories  
4 of his quiet strength, his infectious humor, and his devotion to his  
5 family remain to comfort and inspire those he leaves behind; now,
