16 in 2010, Nixon Beefmasters was named the New Member of the Year by
17 Beefmaster Breeders United; and

19 Charles and Courtney, and with the passing years, he had the
20 privilege of seeing his treasured family grow to include five
21 grandchildren, Brendan, Addison, Caroline, Elizabeth, and William,
