A BILL TO BE ENTITLED

1 AN ACT
2 relating to the composition of the districts for the election of
3 members of the United States House of Representatives from the
4 State of Texas.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 ARTICLE I

7 SECTION 1. (a) The members of the United States House of
8 Representatives from the State of Texas are elected from the
9 districts described by Article II of this Act.

10 (b) One member is elected from each district established by
11 this Act.

12 ARTICLE II

13 SECTION 1. The districts for members of the United States
14 House of Representatives from the State of Texas are as described by
15 PLANC2333 on the redistricting computer system operated by the
16 Texas Legislative Council.

17 ARTICLE III

18 SECTION 1. In this Act, "tract," "block group," and "block"
19 mean the geographic areas identified by those terms on the 2020
20 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the
21 Census for the Twenty-fourth Decennial Census of the United States,
22 enumerated as of April 1, 2020.

23 SECTION 2. It is the intention of the Texas Legislature
24 that, if any county, tract, block group, block, or other geographic

1 area has erroneously been left out of this Act, a court reviewing
2 this Act should include that area in the appropriate district in
3 accordance with the intent of the legislature, using any available
4 evidence of that intent, including evidence such as that used by the
5 Supreme Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W.
6 749 (1922).

7 SECTION 3. (a) This Act supersedes all previous enactments
8 or orders adopting congressional districts for the State of Texas.
9 All previous acts of the legislature adopting congressional
10 districts for the State of Texas are repealed.

11 (b) Chapter 7 (S.B. 6), Acts of the 87th Legislature, 3rd
12 Called Session, 2021, is repealed.

13 SECTION 4. The districts described by Article II of this Act
14 apply to the election of the members of the United States House of
15 Representatives from the State of Texas beginning with the primary
16 and general elections in 2026 for members of the 120th Congress.
17 This Act does not affect the membership or congressional districts
18 of the 119th Congress.

19 SECTION 5. This Act takes effect immediately if it receives
20 a vote of two-thirds of all the members elected to each house, as
21 provided by Section 39, Article III, Texas Constitution. If this
22 Act does not receive the vote necessary for immediate effect, this
23 Act takes effect on the 91st day after the last day of the
24 legislative session.
