1 WHEREAS, A life filled with joyful times and meaningful  
2 accomplishments drew to a close with the passing of Thomas Irving  
3 Hennigan of San Antonio on August 1, 2025, at the age of 83; and

4 WHEREAS, The son of Marguerite Thomas Belisle and Ray  
5 Hennigan, Tom Hennigan was born in Alexandria, Louisiana, on  
6 August 21, 1941; his entrepreneurial spirit led him to a career in  
7 the real estate industry in partnership with his wife, Peggy  
8 Koesterman Hennigan; he opened a loan servicing company and became  
9 involved in investor education; as president of the New Orleans  
10 Real Estate Investor Group, he expanded membership from 35 to more  
11 than 800; traveling the country for seminars and conferences, he  
12 met with his counterparts and recognized the potential of a  
13 nationwide network; his organization hosted a meeting in New  
14 Orleans in 1985, and its success led the Hennigans to establish the  
15 conference that became the National Real Estate Investors  
16 Association; he served as president of the organization, which  
17 today has over 30,000 members; he also founded the San Antonio REIA;  
18 while pursuing a successful career as an investor, landlord, and  
19 rehabber, he was always happy to mentor others and share his  
20 encyclopedic knowledge of real estate; and

21 WHEREAS, Tom and Peggy Hennigan were the proud parents of a  
22 son, Stephen, and their treasured family grew to include two  
23 granddaughters, Megan and Callie; the devoted couple shared a  
24 fulfilling 46-year relationship until Mrs. Hennigan's passing in

1 2010; fortunate to find love a second time, Mr. Hennigan married  
2 the former Lucha Esquivel on February 4, 2013; among his favorite  
3 pastimes were visiting his beloved New Orleans, traveling the  
4 world, and cruising the Caribbean with his friends and the National  
5 REIA groups; outgoing and optimistic, he brightened the days of all  
6 he encountered with his warmth, kindness, and dry sense of humor;

8 WHEREAS, While his loss is difficult to bear, Tom Hennigan  
9 leaves behind numerous friends and loved ones whose lives are far  
10 richer for having known him, and he will forever hold a special  
11 place in their hearts; now, therefore, be it
