ON THIPD PEADING

- Amend S.B. No. 2217 (house committee report) as follows:
- 2 (1) On page 1, line 4, strike "31.014(a), Election Code, is
- 3 amended" and substitute "31.014, Election Code, is amended by
- 4 amending Subsection (a) and adding Subsection (a-1)".
- 5 (2) On page 2, between lines 19 and 20, insert the
- 6 following:
- 7 (a-1) Nothing in this section may be construed to prevent an
- 8 election official from redacting information included on a document
- 9 described by Subsection (a) as necessary to preserve a voter's
- 10 right to a secret ballot protected under Section 4, Article VI,
- 11 Texas Constitution.
- 12 (3) Add the following appropriately numbered SECTIONS to
- 13 the bill and renumber subsequent SECTIONS of the bill accordingly:
- 14 SECTION _____. Section 15.025, Election Code, is amended by
- 15 amending Subsection (a) and adding Subsection (e) to read as
- 16 follows:
- (a) Except as provided by Subsections (b), [and] (d), and
- 18 (e), the registration of a voter described by this subsection whose
- 19 information is changed on the registration records becomes
- 20 effective as to the change on the 30th day after:
- 21 (1) the date the voter submits to the registrar a
- 22 notice of a change in registration information under Section 15.021
- 23 or a response under Section 15.053, indicating the change; or
- 24 (2) the date the voter submits a statement of
- 25 residence to an election officer under Section 63.0011 or a
- 26 registration application or change of address to an agency employee
- 27 under Chapter 20, indicating the change.
- 28 (e) A voter's registration takes effect immediately upon
- 29 the registrar's receipt of a notice of the voter's change of address

- 1 submitted under Section 15.021, Section 63.0011, Section 15.053, or
- 2 Chapter 20 if the voter changes residence within the same county as
- 3 the voter's current registration address.
- 4 SECTION ____. Sections 63.0011(b) and (c), Election Code,
- 5 are amended to read as follows:
- 6 (b) If the voter's residence address is not current because
- 7 the voter has changed residence within the county, the voter may
- 8 vote, if otherwise eligible, in the election precinct in which the
- 9 voter resides [is registered] if the voter resides in the county in
- 10 which the voter is registered [and, if applicable:
- 11 [(1) resides in the political subdivision served by
- 12 the authority ordering the election if the political subdivision is
- 13 other than the county; or
- 14 [(2) resides in the territory covered by the election
- 15 in a less-than-countywide election ordered by the governor or a
- 16 county-authority].
- 17 (c) Before being accepted for voting, the voter must execute
- 18 and submit to an election officer a statement including:
- 19 (1) a statement that the voter satisfies the
- 20 applicable residence requirement [requirements] prescribed by
- 21 Subsection (b);
- 22 (2) all of the information that a person must include
- 23 in an application to register to vote under Section 13.002; [and]
- 24 (3) the date the statement is submitted to the
- 25 election officer; and
- 26 (4) a request to the registrar to change the voter's
- 27 registration address to the address at which the voter resides.
