- 3 SECTION 2. Section 28.025(b-22), Education Code, is
- 4 repealed.
- 5 SECTION 3. Section 28.025(b-1), Education Code, as amended
- 6 by this Act, applies only to students entering the ninth grade
- 7 during the 2026-2027 school year or a later school year. For
- 8 students entering a grade above ninth grade during the 2026-2027
- 9 school year, Section 28.025(b-1), Education Code, as that section
- 10 existed before amendment by this Act, applies, and that section is
- 11 continued in effect for that purpose.
- 12 SECTION 4. This Act applies beginning with the 2026-2027
- 13 school year.
- 14 SECTION 5. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2025.
